Congresswoman Sewell Sends Letter to House Judiciary Committee Urging an Investigation into the Impeachment of U.S. District Court Judge Mark Fuller

Washington, DC – Today, Congresswoman Terri A. Sewell (AL-07) sent a letter urging House Judiciary Committee Chairman Bob Goodlatte and Ranking Member John Conyers to commence an investigation into whether Congress should impeach U.S. District Court Judge Mark Everett Fuller. On August 9, 2014, Judge Fuller was arrested in Atlanta, Georgia on charges of misdemeanor battery, after attacking his wife in an Atlanta hotel room. On <u>September 10</u>, Congresswoman Sewell called for the resignation of Judge Fuller and on <u>September 16</u>, she released a statement expounding upon her initial call for his resignation. Congresswoman Sewell was subsequently joined by Alabama Senators Richard Shelby and Jeff Sessions and nearly all other members of the Alabama Congressional delegation in calling for Judge Fuller's resignation.

"Today, I am urging the House Judiciary Committee to commence an investigation into whether Congress should impeach Federal Judge Mark Fuller. In my opinion, Judge Fuller's recent arrest and subsequent plea to domestic violence is an indefensible violation of the public trust. The integrity of the federal court has already been severely compromised and I no longer have confidence in Judge Fuller's ability to sit in the judgment of others.

While I believe the findings and recommendations of the Judicial Council of the 11th Circuit are an important part of due process, we in Congress have our own obligations to the American people. Only Congress can remove a sitting Federal Judge. Now that Congress is back in session, I am urging the House Judiciary Committee to waste no time in conducting its own investigation into impeaching Judge Mark Fuller. This a necessary first step in beginning impeachment proceedings. During the waning days of the 113th Congress, the House Judiciary Committee can lay the groundwork for impeachment by evaluating the facts of Judge Fuller's behavior that led to his arrest for domestic violence.

We must not and cannot tolerate domestic violence in any form whether committed by an NFL player or a federal judge. No one should get a pass. If a football player can lose his job, surely a federal judge should not be allowed to keep his job. The fact that Judge Fuller has not resigned is the height of arrogance and suggests he believes his actions are above reproach. Judge Fuller is sadly mistaken because his personal conduct has already irreparably damaged his integrity and led to a loss of confidence in his ability to effectively serve as a federal judge. I will continue to call for the resignation of Judge Fuller and urge my colleagues in Congress to support impeachment if he does not resign."

Today, may we recommit ourselves to expressing the gratitude of a grateful nation.

We must also express our solemn gratitude to the troops and reservists who are currently serving in our armed forces. These brave men and women and their families remain in our thoughts and prayers as they risk their lives in the name of liberty and freedom."

THE WHITE HOUSE Office of the First Lady First Lady Michelle Obama Announces Reach Higher Commencement Challenges

Today, First Lady Michelle Obama announced two commencement challenges via video as part of her <u>Reach Higher</u> initiative. Schools choosing to participate in the challenges will create video submissions to capture their efforts to make attending and completing college a reality for all students. Finalists could have the opportunity to hear from the First Lady at their commencement ceremonies in the spring of 2015.

The Reach Higher initiative is the First Lady's effort to inspire every student in America to take charge of their future by completing their education past high school, whether at a professional training program, a community college, or a four-year college or university. In today's economy, a high school diploma just isn't enough. Students have to "reach higher," which is why the First Lady is working to rally the country around the President's "North Star" goal — that by 2020, America will once again have the highest proportion of college graduates in the world.

The FAFSA Completion Challenge

The First Lady's "FAFSA Completion Challenge" video urges high schools to increase Free Application for Federal Student Aid (FAFSA) completion rates among their seniors.

As the First Lady says in her video:

"Through FAFSA, the Department of Education provides more than \$150 billion each year in loans, grants, and work-study programs that can help you and your family pay for college. That's why I'm calling on every high school senior in America to complete their FAFSA form starting on January 1st. And I want students, teachers, school counselors, and administrators to show me how your school is taking action to get more students to fill out their forms this year. So fill out your FAFSA, make a video, and share it online."

Near-Peer Mentoring College Challenge

The First Lady's "Near-Peer Mentoring College Challenge," directed at college communities and institutes of higher education, urges them to increase and enhance near-peer mentoring and college immersion experiences on campus for high school students. Research has shown that students connecting with other students, or "near-peers," can make a significant difference in motivating them to make higher education a reality.

As the First Lady says in her video:

"Last January, I spoke with college presidents from across the country about the importance of reaching out to more of our young people, especially those from underserved communities. These students have so much potential, but they don't always get the encouragement and support they need to go to college. Today, I want to take that discussion to the next level. That's why I'm calling on people all across college communities – from student groups to admissions officers to college presidents – to take new steps to open up your campus..."

This serves as notification that the U.S. Department of Homeland Security's Federal Emergency Management Agency's Fiscal Year 2014 Assistance to Firefighters Grant Program (AFG) will open on Monday, November 3, 2014 at 8:00 am eastern time. The application period for the FY 2014 AFG program closes on Friday, December 5, 2014 at 5:00 pm eastern time.

The *Department of Homeland Security Appropriations Act, 2014* (Pub. L. 113-76) provides \$340,000,000 in AFG funding to assist fire departments and nonaffiliated ambulance and emergency medical service organizations meet their firefighting and emergency response needs. The AFG Program enables these organizations to obtain the tools and resources necessary to more effectively protect the health and safety of the public and emergency response personnel.

Promise Zone Initiative

HUD is pleased to announce the application for the second round of Promise Zone Initiative designations. The Promise Zone Initiative is part of President Obama's plan to revitalize high-poverty urban, rural and tribal communities. Promise Zones is a locally driven strategy that can create jobs, increase economic activity, expand education opportunities, reduce serious and violent crime, leverage private capital and assist local leaders in navigating federal programs and cutting through red tape.

All communities will be eligible for a Promise Zone designation. HUD will designate six urban Promise Zones and USDA will designate at least one rural and one tribal community. **Applications are due by November 21, 2014 by 5:00pm EST** with announcements expected in 2015.

HUD in close collaboration with USDA will convene three distinct webcasts for urban, rural, and tribal to discuss the second round of the Promise Zone Initiative with interested communities. Please share these webcasts with your constituents.





The online Veterans Employment Center is the single federal source for Veterans looking for new career opportunities in the private and public sectors, as well as Service Members transitioning to the civilian workforce, military and Veteran spouses and dependents looking for employment opportunities, GI Bill beneficiaries transitioning from training to the job market and employers looking to connect with high quality applicants. It is the first interagency tool that brings together public and private job opportunities with resume building and other career tools currently offered on a variety of websites together in one place.

Through the online Veterans Employment Center, Veterans, transitioning Service Members and spouses are connected to high quality career choices by matching their identified skills with available public and private job opportunities. The site is built using an open application programming interface (API) to attract private sector innovation.
