REMEMBERING NELSON MANDELA



On December 10, 2013, Congresswoman Sewell attended memorial services for former South African President Nelson Mandela in Johannesburg, South Africa. She was included in a U.S. delegation of 23 members of congress. As one of the millions throughout the world inspired by his sacrifices and achievements, Congresswoman Sewell was honored to share with South Africa and her congressional colleagues in commemorating the life and legacy of one of history's most inspirational and courageous freedom fighters. ENROLLING CONSTITUENTS IN THE HEALTHCARE EXCHANGE

On December 11th and 19th, we hosted Affordable Care Act (ACA) workshops in Selma and Grove Hill. In October and November, we hosted workshops in Birmingham, Demopolis and Montgomery. An estimated 500 constituents attended our 5 healthcare workshops. Our staff was joined by Alabama navigators and healthcare experts from Alabama Arise to assist constituents with enrollment.

PROJECT R.E.A.D.Y. WORKSHOP

On December 6th, our office hosted our 5th Project R.E.A.D.Y. workshop at Trenholm State Technical College. Attendees were offered job readiness training and assistance. This workshop was the fifth Project R.E.A.D.Y. workshop we hosted in 2013. Our other workshops were hosted at Lawson State, the University of West Alabama, Wallace State Selma, and Shelton State.

VOTING RIGHTS AMENDMENT ACT OF 2014

Earlier in January, a bi-partisan effort to create a legislative solution to reinstate the pre-clearance provision of the Voting Rights Act came to fruition with a coverage formula that does not include the State of Alabama. Federal oversight has proven to be highly effective in giving Alabama voters the security they deserve throughout every stage of the electoral process. I, therefore, cannot support this legislation in its current form. Although progress has been made, the need for federal oversight still exists in Alabama. No right is more fundamental to our democracy than the right to vote and this bill, in its current form, falls short in providing adequate protections for the people of Alabama. I look forward to working with my colleagues to strengthen the VRA Amendment Bill so that it ensures all vulnerable communities, like those in Alabama, are included under the preclearance provision. OMNIBUS FUNDING BILL

On January 15, Congress took a step in the right direction by passing the bipartisan funding bill in 2014. We were pleased with this legislation because it funds the federal government in a responsible manner and ends the drastic cuts imposed by sequestration. The legislation issues a reprieve for those facing flood insurance premium increases, addresses sexual assault in the Department of Defense, repeals last year's cuts to veteran's benefits, restores full funding for Head Start and boosts funding for Early Head Start. The omnibus agreement is a welcomed departure from the harmful sequestration cuts that have undermined our National Security, harmed American families and weakened our fragile economic recovery. 2014 FARM BILL

On January 29, Congress came to a bipartisan, bicameral agreement on a five-year farm bill after two years of negotiations to pass a farm bill that meets the needs of both our farmers and those who rely upon nutrition assistance programs. We supported the bill because, while not perfect, it does represent a compromise that broadens access to irrigation, promotes our catfish industry and strengthens rural infrastructure.
