CONGRESSWOMAN SEWELL EXPRESSES DISAPPOINTMENT IN INSENSITIVE COMMENTS MADE BY CONGRESSMAN MO BROOKS

Washington, DC – Today, Congresswoman Terri A. Sewell (AL-07) released the following statement in response to recent comments made by Congressman Mo Brooks (AL-05) accusing the Democratic Party of waging a "war on whites":

"I am incredibly disappointed in the comments made by my colleague Congressman Mo Brooks. To invoke racial motives in the debate for comprehensive immigration reform is neither productive nor warranted. His insensitive remarks are inflammatory and do not represent the views of the State of Alabama," said Rep. Sewell. "Our nation is facing a crisis. Now is the time for America to put aside partisan politics and unite on behalf of the unaccompanied minors. The time is long overdue to pass a comprehensive immigration reform bill."

Congresswoman Sewell Votes against Republican Attempt to End DACA and a Woefully Underfunded and Inadequate Bill to Address Emergency Border Crisis

Washington, DC – Tonight, Congresswoman Terri A. Sewell (AL-07) voted against H.R. 5230, the Republican Appropriations Bill to Address the Southwest Border Crisis and H.R. 5232, which eliminates the Deferred Action for Childhood Arrivals (DACA). Congresswoman Sewell released the following statement following her vote:

"Tonight, I voted against H.R. 5230 and Republican attempts to end the Deferred Action for Childhood Arrivals (DACA) program and undermine protections afforded to immigrant children fleeing persecution and violence," said Rep. Sewell. "These attempts fail to adequately address the emergency border crisis that our nation is facing and undermine protections afforded to immigrant children. Unfortunately, House Republicans have squandered this opportunity and put forth a bill that is woefully underfunded, rolls back critical protections that Congress previously extended and does not provide a real solution to fixing our broken immigration system. The humanitarian crisis at the border underscores the **urgent** need for comprehensive immigration reform."

"In lieu of compromise legislation, this bill is a piecemeal attempt that does not sensibly and adequately address this crisis. This bill ignores Congress' intent and subjects these vulnerable children to return to life threatening situations including trafficking, persecution, violence, and abuse. Further, it subjects <u>all</u> children to the dangerous and cursory screenings that currently apply only to unaccompanied children from contiguous countries and denies the fundamental right to a due process hearing. We must prioritize the protection of these children and ensure that our laws are followed by providing each child with a deportation hearing. We have a moral responsibility to protect and treat unaccompanied children with care and compassion as they await due process." Rep. Sewell concluded, "I renew my call for a comprehensive bipartisan immigration bill that adequately funds and addresses this humanitarian challenge."

Statement from Congresswoman Sewell on Conversion of Alabama Power Facility in Greene County

Washington, DC – Today, Congresswoman Terri A. Sewell (AL-07) released the following statement following an announcement by Alabama Power to convert to natural gas at its steam plant in Greene County:

"While I respect the recent business decision made by Alabama Power to convert to natural gas at its facility in Greene County, I am disappointed that such a decision will negatively impact the employment opportunities in a county that can least absorb its effect. I strongly believe in government's role in environmental policy; however I also believe that we must have a balanced approach to federal regulation such that the costs are weighed with the effects on job growth and economic impact. Although we must prepare to diversify our energy production, I am committed to supporting coal as a viable source of energy in Alabama until alternatives become more economically feasible."

The online Veterans Employment Center is the single federal source for Veterans looking for new career opportunities in the private and public sectors, as well as Service Members transitioning to the civilian workforce, military and Veteran spouses and dependents looking for employment opportunities, GI Bill beneficiaries transitioning from training to the job market and employers looking to connect with high quality applicants. It is the first interagency tool that brings together public and private job opportunities with resume building and other career tools currently offered on a variety of websites together in one place.

Through the online Veterans Employment Center, Veterans, transitioning Service Members and spouses are connected to high quality career choices by matching their identified skills with available public and private job opportunities. The site is built using an open application programming interface (API) to attract private sector innovation.

- Quick public resume posting with an instant connection to thousands of public and private employers
- Target job search based on specific, high-demand career paths
- Single search for both public and private sector positions
- Military skills translator and resume generator
