Congresswoman Terri Sewell Calls on Senate Republicans to Do Their Job and Consider the President's Supreme Court Nominee

Washington, D.C. – Today, Congresswoman Terri Sewell (D-AL-7) released the following statement to call on the Senate Republicans to follow the Constitution and give the President's Supreme Court nomination full and fair consideration:

"I urge the Senate Republicans to consider the President's nominee for the Supreme Court. The Constitution clearly states that the President has the power, by and with the advice and consent of the Senate, to nominate a successor for open seats in the Supreme Court. Justice and democracy are at stake and there is no time for this kind of partisan divisiveness. At stake is not only the Supreme Court but there are highly qualified nominees for federal, district and appellate courts that the Senate should act upon as well. On February 11, 2016, President Obama nominated Judge Abdul K. Kallon of Birmingham, AL to the U.S. Court of Appeals for the Eleventh Circuit. Judge Kallon is a highly qualified jurist whose integrity, brilliance and judicial temperament has earned him the praise and respect of his colleagues and members of the Alabama bar. The Senate should do their duty and consider all qualified nominees.

"It is a low day in a democratic society when government leaders ignore their duty and the Constitution for partisan agendas. This is not American. The President of the United States of America intends to do his job and fulfill his duty to nominate a replacement for the Supreme Court vacancy and America expects the Senate Republicans to do their job.

"If the average American worker isn't excused from doing their job just because they don't feel like it, why do Senate Republicans think they should be excused? The bottom-line is this; they are not excused. The Constitution of the United States of America can never be ignored for purposes of political preference."

Congresswoman Terri Sewell Issues Statement on the Greg Gunn Shooting in Montgomery, Alabama

Montgomery, AL – Congresswoman Terri Sewell released the following statement in response to the death of Greg Gunn, a Montgomery resident who was recently shot by a Montgomery Police Officer.

"My thoughts and prayers are with the family of Mr. Greg Gunn and those affected by this unfortunate tragedy. I have been in contact with local authorities to ensure that this case receives a thorough review and investigation."

"Now that a murder warrant has been issued in Mr. Gunn's death, and the officer has been arrested and charged, we seek to have justice be fair and swift for the family, the community and all those struggling with this tragic incident."

Congresswoman Terri Sewell Statement on Women's History Month

Washington, D.C. – Today, Congresswoman Terri Sewell released the following statement in celebration of Women's History Month:

"History his filled with stories told and untold of the dynamic impact that women have made in society. Often overlooked and underappreciated, Shirley Chisolm, the first African American woman elected to the United States Congress said it best that 'tremendous amounts of talent are lost to our society just because that talent wears a skirt.'

"Despite the many stereotypes and obstacles of the past and present, women continue to act as strong advocates for equality and justice. Women everywhere continue to break barriers, exceed expectations and defy all odds. Because of the conviction and strong determination of women, our past is inspiring, our present is enriched and our future has no limits.

"A strong chain requires strong links. When women succeed, America succeeds. Yes, it is true that women have made enormous strides in business, science, medicine, law, government, higher education and the arts. We celebrate the power and progress of women everywhere, but we can't forget about the economic hurdles women and their families presently face. We need to support the economic agenda of women and create policy that supports full and fair participation for women in the workforce. When justice and equality prevail, America prevails. Let us join in celebration of Women's History Month by calling for a successful society and equality for all."

Congresswoman Sewell Joins Colleagues to Award Congressional Gold Medal to the Foot Soldiers of the 1965 Voting Rights Marches

Washington, D.C. – Today, Congresswoman Terri Sewell (D-AL-7) released the following statement on joining her Congressional colleagues in a ceremony to bestow the Congressional Gold Medal on the Foot Soldiers whose courageous journey from Selma to Montgomery led to the passage of the landmark Voting Rights Act of 1965:

“Today, the American people, through their Congressional representatives, bestowed the Congressional Gold Medal upon the courageous Foot Soldiers who dared to march in 1965 for voting rights in Selma, Alabama. The right to vote is one of the most fundamental and sacred rights we share as Americans. Every American owes a debt of gratitude to those brave men and women who sacrificed so that all Americans could participate in our democracy. The sacrifices made by these Foot Soldiers compelled this nation to live up to its ideals of equality for all and ultimately led to the passage of the Voting Right Act of 1965. The Congressional Gold Medal ceremony should serve as a powerful reminder of the power of ordinary Americans to collectively achieve extraordinary social change.

“I am proud to have Rev. Frederick D. Reese of Selma receive this great honor on behalf of the Foot Soldiers who participated in 1965 Selma to Montgomery Marches. Rev. Reese was the leader of the Dallas County Voter League that first invited Dr. King to Selma. For over fifty years, Rev. Reese has stood as a stalwart of the voting rights movement. His acceptance of this Congressional Gold Medal is emblematic of everyone who marched, prayed and died in the pursuit of civil and voting rights in America.

“As a direct beneficiary of their sacrifices, I am honored that we finally pay tribute to these heroic men and women with the highest civilian honor Congress can bestow. It is because of the Foot Soldiers that I have the privilege of being the first black Congresswoman to represent the State of Alabama. While we can never truly repay the Foot Soldiers for the sacrifices they made, we honor their legacy by continuing the ongoing fight to preserve and protect the voting rights of all Americans.”

About the Congressional Gold Medal

Since the American Revolution, Congress has commissioned gold medals as its highest expression of national appreciation for distinguished achievements and contributions by individuals or institutions. The medal was first awarded in 1776 by the second Continental Congress to General George Washington.

About the 1965 Marches from Selma to Montgomery

Voting rights activists were brutally attacked by Alabama state troopers on the Edmund Pettus Bridge in Selma on March 7, 1965. This day, now known as Bloody Sunday, was the first of three planned, peaceful protests from Selma to Montgomery. Nearly 2,500 Foot Soldiers led by Dr. Martin Luther King attempted a second march two days later on March 9, 1965, now known as “Turnaround Tuesday.” Ultimately, an estimated 8,000 Foot Soldiers left Selma on March 21, 1965, and successfully marched to Montgomery to peacefully protest restrictive voting laws that prevented African-Americans from voting. These marches led to the passage of the Voting Rights Act of 1965 on August 6, 1965.

CONGRESSWOMAN TERRI SEWELL RECOGNIZES THE PASSING OF SUPREME COURT JUSTICE ANTONIN SCALIA

Birmingham, AL - Congresswoman Terri Sewell released the following statement regarding the passing of Supreme Court Justice Antonin Scalia:

"I join with my congressional colleagues and President Obama in expressing my condolences on the passing of Supreme Court Justice Antonin Scalia," states Congresswoman Sewell. "My thoughts and prayers are with his family and friends at this time of mourning."

"While I have not agreed with his legal philosophy and rationale in many cases, there is no denying that Justice Scalia is one of the most consequential legal scholars of our generation. He has made an indelible imprint on the legal landscape in this country and his 30 years of public service is appreciated."

"Scalia's love for the law and fundamental belief in the Constitution was well known. This is why it was so disheartening that Senate Republicans have already stated their unwillingness to carry out their Constitutional duties of vetting and confirming 'any' nominee offered by President Obama."

"Because of the total obstructionism that my Republican colleagues have instituted against President Obama since day one of his presidency, our courts across the country are suffering due to shortages in manpower, including the United States Court of the Appeals for the Eleventh Circuit. This has created case backlogs in many of the courts that has been deemed a 'judicial emergency' by the Administrative Office of the U.S. Courts."

"It is unfathomable that the highest court in the land, the U.S. Supreme Court, would be subjected to this same level of partisan, political obstructionism and denied its full complement of jurist for eleven months or longer, given the profound cases being heard before it. As such, I join others from both sides of the political divide in calling on President Obama to conduct his Constitutional duty to nominate a 'well-qualified' candidate for the Supreme Court vacancy, and for the U.S. Senate to perform its job of vetting and confirming that nominee. To suggest anything less is an affront to the American people."

Statement of Congresswoman Terri A. Sewell on the Nomination of U.S. District Judge Abdul K. Kallon to Serve on the United States Court of Appeals for the Eleventh Circuit

WASHINGTON, DC – Congresswoman Terri A. Sewell (AL-7) released the following statement today in response to the announcement by President Barack Obama that he has nominated U.S. District Judge Abdul Kallon of Alabama to fill a vacancy on the United States Court of Appeals for the Eleventh Circuit:

"I enthusiastically express my support for the nomination of Judge Abdul Kallon by President Obama for the United States Court of the Appeals for the Eleventh Circuit. Since 2009 Judge Kallon has served with distinction on the U.S. District Court for the Northern District of Alabama and his elevation to the Eleventh Circuit will continue the tradition of excellence and commitment to justice established by such distinguished Alabama jurists such as Judge Frank Johnson."

"President Obama saw in Judge Kallon the same qualities of integrity, judicial temperament, collegiality, and keen intellect that has earned him the respect and admiration of his judicial colleagues, attorneys who appeared before his court, and members of the Alabama bar. In nominating Judge Kallon for elevation to the appellate court, President Obama has selected a jurist of impeccable credentials who was rated 'well-qualified' by the American Bar Association."

"If confirmed, Judge Kallon would become the first African American jurist from Alabama to serve on the United States Court of the Appeals for the Eleventh Circuit. Equally important, the speedy confirmation of Judge Kallon will ensure that Alabama is fairly represented on the court and will fill a two-year vacancy on the Eleventh Circuit that as has created a case backlog that has been deemed a 'judicial emergency' by the Administrative Office of the U.S. Courts."

"I strongly urge Senator Shelby and Senator Sessions of Alabama to support the confirmation of Judge Kallon to the United States Court of the Appeals for the Eleventh Circuit. The selection of this nation's federal judges should not be a partisan issue, but rather we all benefit when candidates are considered based on their qualification, abilities, and character. For the same reasons they supported Judge Kallon's confirmation in 2009, the Alabama senators should once again support this highly qualified jurist whose integrity, brilliance and judicial temperament has earned him the praise and respect of his judicial colleagues and members of the Alabama bar. Without a doubt, Judge Kallon will make Alabama and this nation proud for entrusting him with this important judicial responsibility."

About Judge Kallon: Judge Kallon is a graduate of Dartmouth College and earned his J.D. from the prestigious University of Pennsylvania Law School in 1993. After law school he clerked for Judge U.W. Clemon of the U.S. District Court for the Northern District of Alabama. Prior to his ascension to the bench, Judge Kallon was a partner in the Birmingham law firm of Bradley, Arant, Boulton & Cummings where he specialized in employment and labor law.

TIGER Discretionary Grants

U.S. Transportation Secretary Anthony Foxx has announced \$500 million will be made available for transportation projects across the country under an eighth round of Transportation Investment Generating Economic Recovery (TIGER) competitive grant program.

Like the first seven rounds, FY 2016 TIGER discretionary grants will fund capital investments in surface transportation infrastructure and will be awarded on a competitive basis for projects that will have a significant impact on the nation, a metropolitan area, or a region. The 2016 TIGER grant program will focus on capital projects that generate economic development and improve access to reliable, safe and affordable transportation for communities, both urban and rural. The Consolidated Appropriations Act, 2016, does not provide dedicated funding for the planning, preparation, or design of capital projects; however, these activities may be funded as part of an overall construction project.

Since 2009, TIGER has provided nearly \$4.6 billion to 381 projects in all 50 states, the District of Columbia and Puerto Rico, including 134 projects to support rural and tribal communities. Overall, the Department has received more than 6,700 applications requesting more than \$134 billion for transportation projects across the country. The TIGER grant program supports innovative projects, including multi-modal and multi-jurisdictional projects. These federal funds leverage money from private sector partners, states, local governments, metropolitan planning organizations, ports, and transit agencies. The 2015 TIGER round alone is leveraging \$500 million in federal investment to support \$1.4 billion in overall transportation investments.

TIGER funding is provided in the Consolidated Appropriations Act, 2016, signed by President Obama on December 18, 2015. Applications are due April 29, 2016.

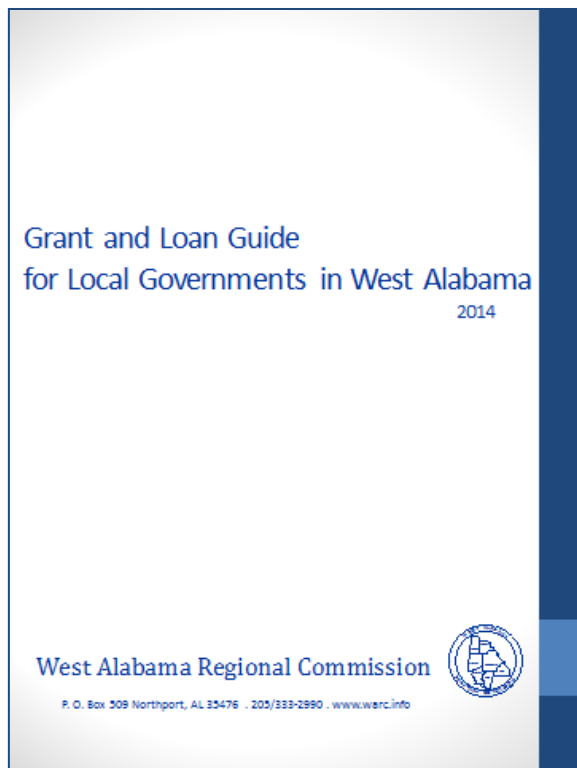

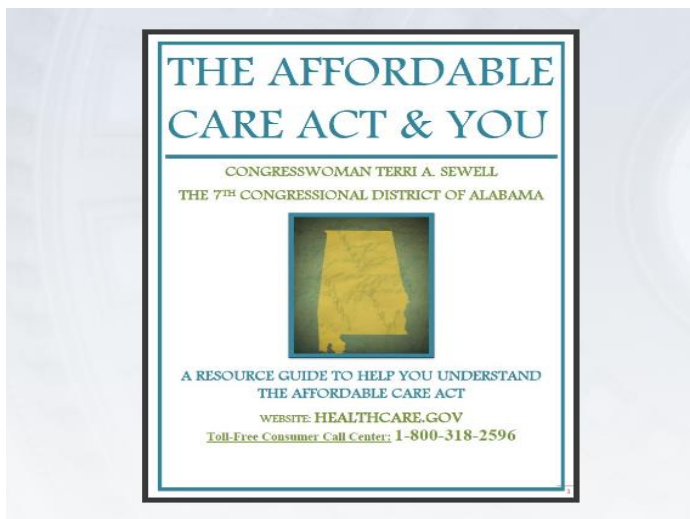

The online Veterans Employment Center is the single federal source for Veterans looking for new career opportunities in the private and public sectors, as well as Service Members transitioning to the civilian workforce, military and Veteran spouses and dependents looking for employment opportunities, GI Bill beneficiaries transitioning from training to the job market and employers looking to connect with high quality applicants. It is the first interagency tool that brings together public and private job opportunities with resume building and other career tools currently offered on a variety of websites together in one place.

Through the online Veterans Employment Center, Veterans, transitioning Service Members and spouses are connected to high quality career choices by matching their identified skills with available public and private job opportunities. The site is built using an open application programming interface (API) to attract private sector innovation.

Veteran Applicant Resources:

- Quick public resume posting with an instant connection to thousands of public and private employers

- Target job search based on specific, high-demand career paths
- Single search for both public and private sector positions
- Military skills translator and resume generator
- Social media integration with popular bookmarking sites for saving job postings

- View reverse skills translation (military to civilian skills) for applicants
- Set Veterans hiring goals and track progress
- Connect to resources designed to help recruit and retain talented, Veteran employees

In connection with the First Lady and Dr. Biden’s Joining Forces initiative, the Department of Veterans Affairs worked with the Departments of Defense, Labor, and Education, and the Office of Personnel Management to design and develop the site and incorporate features of existing online employment tools at each agency. The result is an upgrade to the existing Veterans Job Bank and an integrated solution connecting Veterans, transitioning Service Members and employers.

Employers, Veterans and transitioning Service Members deserve a single, authoritative source for connecting to each other. Now that the core tools and an integrated search function exist in one single location, each agency is engaged in minimizing duplication and redundancy of current sites and services.
