## Congressional Black Caucus Foundation (CBCF) Emerging Leaders Internship Program

### FALL INTERNSHIP PROGRAM DATES: January 9, 2017 – May 5, 2017

The semester-long Emerging Leaders Internship Program sponsored by Walmart creates a corps of trained, young leaders with the skills, outlook, and contacts necessary to generate and sustain positive change in Washington, D.C. and their local communities. Interns will receive housing, a bi-weekly stipend, and will be placed in Congressional offices, federal agencies, and non-profit organizations.. Applicants must have a minimum GPA of 2.5 on a 4.0 scale; should be at least a college sophomore at the time of application; have a permit to work in the U.S.; and have a demonstrated interest in public service, governance, and the policy-making process. Recent college graduates are eligible as long as they have not yet started post-graduate studies and have graduated no more twelve (12) months before the internship program start date.

### SPRING INTERNSHIP PROGRAM DATES: January 9, 2017 – May 5, 2017

The semester-long CBCF Communications Internship program sponsored by State Farm offers undergraduate students who are interested in working with press and media relations on Capitol Hill, in federal agencies, at private sector companies, and at non-profit organizations. Housing and a bi-weekly stipend are provided. This program is offered during the fall and spring semesters. Applicants must have a minimum GPA of 2.5 on a 4.0 scale; should be at least a college sophomore at the time of application; have a permit to work in the U.S.; and have a demonstrated interest in public service, governance, and the policy-making process. Recent graduates are eligible as long as they have not yet started post-graduate studies and have graduated no more than a year from the internship program start date.

# Reps. Sewell and McMorris Rodgers Introduce Bipartisan Cancer Care Payment Reform Legislation

# The Cancer Care Payment Reform Act enhances quality of cancer care by creating a national oncology medical home demonstration project under Medicare.

**Washington, D.C.** – Today, Congresswoman Terri A. Sewell (D-AL) joined Congresswoman Cathy McMorris Rodgers (R-WA) in introducing the bipartisan Cancer Care Payment Reform Act. The bill establishes a five-year demonstration project using the framework of the successful patient-centered Oncology Medical Home (OMH) model developed by community oncologists in recent years. Using the OMH model, physicians have partnered with insurers to pilot several successful payment programs, which have proven to provide better patient care and achieve cost savings to the health care system. The bill has also been introduced in the Senate by Senators John Cornyn (R-TX) and Tom Carper (D-DE) as S.463.

"As a representative of many rural and underserved communities with a high prevalence of poor health outcomes, I believe we should be laser-focused on ensuring all patients have access to high-quality, affordable care and treatment close to home," said Rep. Sewell. "I am proud to sponsor the bipartisan Cancer Care Payment Reform Act with Congresswoman Cathy McMorris Rodgers as a means of ensuring cancer patients have access to lifesaving cancer treatment in their community, while promoting revolutionary approaches to the delivery and payment for cancer care. Reducing financial barriers to cancer care is critical to eliminate both the human and financial costs associated with cancer for patients, loved ones, physicians, and the entire economy."

"Medical breakthroughs continue to provide hope to millions of Americans, including cancer patients, and advancements in science have made it possible for cancer patients to receive care in their community and closer to home," said Rep. McMorris Rodgers. "My legislation updates the Medicare payment process to focus on comprehensive, patient-centered care that puts quality over quantity," said McMorris Rodgers. "As we continue to search for a cure to cancer, models like this ensure that care is more results-driven and cost-effective for the patient and our nation's health care system as a whole."

The National Cancer Institute estimates that roughly 1.6 million new cases of cancer will be diagnosed in the United States this year alone and more than half a million people are expected to die from the disease. Moreover, the National Institutes of Health reports that cancer costs will reach \$158 billion nationally by 2020.

The Cancer Care Payment Reform Act relies on oncology practices to reduce overall costs to the health care system by providing higher quality care and keeping patients out of the hospital where care is most costly. Oncology centers that participate in the program would be rewarded with a portion of the savings under this legislation.

# Sewell Statement on Trump Tax Return Committee Vote

Mar 28, 2017

### Trump Tax Return Bill Receives Hearing, Vote in Ways & Means

**Washington, D.C.** – Today, the House Committee on Ways & Means held a markup on H.Res. 186, a resolution directing the Secretary of Treasury to furnish 10 years of the President's tax returns to the House of Representatives. Since the early 1970s, all presidents, Republicans and Democrats, have released their tax returns with the exception of President Gerald Ford, who released a summary of tax data. Congresswoman Terri A. Sewell voted for H.Res. 186 when the resolution failed to pass the Committee in a 24-to-16 vote.

"I voted to release Trump's tax returns because voters have the right to know when our president puts his own financial interests ahead of the public interest," said Rep. Sewell. "For more than four decades, presidents from both parties have released their tax returns because transparency is fundamental to the health of our democracy. The American people deserve the security of knowing that our president is free of any conflicts of interest."

Since the President's inauguration, ethics experts have strongly objected to Trump's lack of distance from his business investments. The President owns more than 150 businesses spread across 26 countries and has reported assets regulated by 17 different federal agencies.

# Rep. Sewell Calls for Chairman Nunes to Recuse Himself from Russia Investigation

# Chairman Nunes should recuse himself from the investigations into Russian interference and incidental intelligence collection

**Washington, D.C.** – On Monday, House Intelligence Committee Chairman Devin Nunes acknowledged that he made a secret visit to the White House to review intelligence documents which he later used to claim that the Trump Administration was the subject of improper intelligence collection. The documents that Nunes says back his claims have still not been shared with the House Intelligence Committee. Congresswoman Terri A. Sewell (D-AL) releases the following statement: "I have worked with Chairman Nunes on the Intelligence Committee for four years, so my decision on this matter was not made lightly," said Rep. Sewell. "In view of Chairman Nunes' secret meetings at the White House and his ongoing refusal to share information with his own committee, I am calling on the Chairman to recuse himself from the Intelligence Committee's Russia investigation."

"By prioritizing his political ties with the White House over his work on the Intelligence Committee, Chairman Nunes has compromised our investigation and called into question our independence. By canceling open hearings on our investigation and failing to share intelligence with Republican and Democratic members of his committee, he has kept the public in the dark. The American people deserve a fair and impartial investigation into Russia's attacks on our democracy, and for the Intelligence Committee to advance our work, I believe that Chairman Nunes' recusal will help in restoring integrity to the process."

# Rep. Sewell Statement on Failure of GOP Healthcare Repeal Bill

### Mar 27, 2017

### Republican leadership pulls legislation before House vote

**Washington, D.C.** – Today, Republican leadership pulled the GOP healthcare repeal bill off the House floor minutes before a vote was going to be held on the legislation. The decision against holding a vote followed massive public opposition to the legislation and estimates from the Congressional Budget Office (CBO) that the bill would eliminate coverage for 24 million Americans by 2026. Congresswoman Terri A. Sewell (D-AL) spoke in opposition to the bill during House debate.

"I opposed today's Republican healthcare repeal legislation because it was a bad deal for Alabama and a bad deal for working families across the country," said Rep. Sewell. "This legislation would have raised health costs, eliminated essential benefits my constituents rely on, and cut insurance for 240,000 Alabamians and another 71,000 Alabama children who depend on Medicaid. After seven years of railing against the Affordable Care Act and over sixty votes to repeal it, it is an outrage that Republicans are still not able to provide a viable alternative. Our access to care is a fundamental right, not a privilege, and I will continue to oppose any legislation that takes that right away from millions of Americans."

"I believe America's greatest resource is our people, and we cannot succeed if our people do not have the security that comes with knowing if a family member gets sick, treatment doesn't have to come at the cost of financial ruin. From the creation of Medicare, Medicaid, and Social Security, to the GI Bill, Congress has long recognized the importance of our healthcare safety-net and has worked tirelessly to protect it. This week's healthcare repeal effort was a disappointing abdication of that commitment. I hope that my Republican colleagues will come back to the table to work on crafting legislation that strengthens healthcare for all Americans."

Based on estimates released by the non-partisan CBO, over 243,000 Alabamians were expected to lose health insurance under the healthcare repeal bill by 2026. The GOP healthcare repeal also would have decreased healthcare tax credits for Alabama individuals by an average of \$7,700 and for Alabama families by an average of \$16,697.

# Rep. Sewell Statement on House Intelligence Committee Hearing

### Mar 20, 2017

### FBI Dir. Comey, NSA Dir. Rogers respond to Committee questions

**Washington, D.C.** – Today, the House Intelligence Committee held a public hearing with FBI Director James Comey and NSA Director Michael Rogers investigating Russian measures directed against the 2016 presidential election, American persons with ties to any attacks, and related national security issues. Congresswoman Terri A. Sewell (D-AL) questioned Directors Comey and Rogers on former National Security Advisor Michael Flynn's ties to Russian entities and his failure to disclose meetings with Russian officials in the lead-up to the President's inauguration.

"Russian attacks on our democratic institutions are not just a threat to the integrity of our elections, they cut to the core of our national security," said Rep. Sewell. "In order to prevent these attacks from ever happening again, we need a full, bipartisan investigation into how Russia attacked our country, who was involved, and how our government responded. In addition to shedding light on Russian influence in our democracy, today's hearing raised more questions about the nature of Russian attacks and who was involved. As a member of the House Committee on Intelligence, I am committed to getting answers and following the facts in this case wherever they may lead. When our national security is put at risk, there is no room for politics, and I am thankful for the support of members on both sides of the aisle in making today's hearings happen."

At today's hearings Director Comey confirmed that the FBI is conducting an active investigation into Russia's interference in U.S. elections and any ties to then-candidate Trump's campaign.

Rep. Sewell has cosponsored the Protecting Our Democracy Act. This legislation would create a 12member, bipartisan, independent commission empowered to interview witnesses, obtain documents, issue subpoenas, and receive public testimony to examine attempts by the Russian government and others to use electronic means to influence, interfere with, or sow distrust in the 2016 U.S. elections.

# House Passes VA Hiring Bill with Sewell Amendment

Mar 17, 2017

### Sewell amendment addresses barriers to VA workforce recruitment in rural areas

**Washington, D.C.** – Today, the House of Representatives passed H.R. 1367, a bill to improve hiring and retention practices for employees of the Department of Veterans Affairs (VA). The House voted to include an amendment offered by Congresswoman Terri A. Sewell (D-AL) encouraging the VA Secretary to select eligible employees for its Fellowship Program who represent rural areas in order to alleviate the systemic burdens of rural healthcare workforce shortages. Rep. Sewell's amendment and the underlying bill passed in bipartisan votes.

"In return for their service, our country has a sacred obligation to care for our veterans and military families," said Rep. Sewell. "Today's bipartisan support for legislation that strengthens VA hiring practices is an important step towards providing more responsive, more effective healthcare for our nation's heroes. My amendment helps to ensure that veterans who are serviced by rural VAs have access to healthcare experts with cutting edge experience in the public and private sectors. On top of long driving distances and minimal access to care, workforce shortages make it harder for our rural veterans to get the help they need, when they need it. I want to thank my colleagues on both sides of the aisle for their support, and I look forward to continuing our work to ensure that our nation keeps its promise to the men and women who serve our country."

Approximately 25 percent of our nation's veterans live in rural communities and comprise nearly 11 percent of the adult rural population. Rural veterans account for 36 percent of all VA enrollees.

Rep. Sewell's amendment passed the House of Representatives on Friday morning by voice vote. View the floor proceedings on the Sewell Amendment and Rep. Sewell's floor speech.


