# Rep. Sewell Responds to February 2nd Tornado Damage in Pickens County

Birmingham, AL- Congresswoman Terri Sewell responds to the February 2nd tornado damage in Pickens County and discusses the state's response efforts and the importance of faith-based and community volunteers. The Congresswoman released the following statement:

"Recently the National Weather Service confirmed that two tornadoes hit Pickens County on February 2nd. My heartfelt thoughts are with those Sapps residents whose homes and property were damaged by these tornadoes. Once again, the resolve and will of the people of Alabama is being challenged by a natural disaster.

"The Alabama Emergency Management Agency personnel, along with my office, are working closely with local officials to support the needs of the affected residents. My office has been on the ground since February 3rd accessing the damage with EMA officials and assisting storm survivors at the Sapps Community Center. I want to thank the Red Cross, churches and volunteers that are addressing the needs of the affected residents.

"Given that the early assessment have revealed that the damages did not meet the threshold to receive FEMA assistances, it is imperative that our state efforts address the immediate and long-term needs of this community and the affected residents. Today, Governor Bentley will tour the damages in Pickens County. It is important that all levels of government work together to address this crisis affecting the Sapps community. We will continue to monitor the damage assessment and explore all federal funding possibilities that can assist the community.

My office is committed to the recovery and rebuilding process and we will continue to assist those devastated families in any way we can. I am confident that the resilient spirit of Alabamians will see us through these difficult times and our communities will rebuild and recover stronger and better than before. We will continue to work with local, state, and federal officials to bring assistance to those affected."

# Rep. Sewell Introduces Legislation to Increase Medicare Reimbursements for Rural Hospitals

Today, Congresswoman Terri Sewell and Congresswoman Diane Black (R-TN) introduced the Fair Medicare Hospital Payments Act of 2016 (H.R. 4428), a bipartisan bill that increases Medicare reimbursements for rural hospitals in Alabama and other states with large rural populations.

"When rural hospitals struggle, entire communities suffer. In many parts Alabama's 7th Congressional District, local hospitals are the lifeblood of the community. When confronted with the unique challenges of caring for older, sicker, and low-income populations, these hospitals are struggling to keep their doors open.

"The Fair Medicare Hospital Payments Act of 2016 would ensure that these hospitals receive their fair share in Medicare reimbursement dollars. The current reimbursement system is skewed in favor of hospitals serving the healthiest and wealthiest parts of our country. Whenever I visit hospitals in the district, hospital administrators cite reimbursement disparities as one of their top concerns. H.R. 4428 would reverse this trend and increase reimbursements for hospitals in 158 Core Based Statistical Areas (CBSAs) nationwide.

"I am proud to work on this very important issue with Rep. Diane Black. The entire Congressional delegations from Alabama, Tennessee, and Arkansas have signed on to this bill and we have also received strong support from members of the Georgia, Kentucky, Texas, and Louisiana delegations. The broad, bipartisan support this bill has garnered in advance of introduction speaks to the urgency of this issue," said Rep. Sewell.

Dr. Don Williamson, President of the Alabama Hospital Association expressed the Association's support for this legislation.

"The Alabama Hospital Association would like to thank Congresswoman Sewell for introducing this bill, and we are most appreciative that every member in Alabama's House delegation has joined as cosponsors. Addressing the broken wage index system is long overdue. It is an inherently unfair system and it is unreasonable for Alabama's hospitals to be paid dramatically less for the same care as their counterparts in other states. This issue could not be more critical for the survival of the majority of Alabama's rural hospitals."

The bill also has the support of the National Rural Health Association.

"NRHA applauds the introduction of this important bill to ensure that rural providers' compensation reflects the plethora of challenges related to retention and recruitment in rural America. The Wage Index unfairly penalizes physicians that practice in underserved communities within rural America and this bill takes an important step to reduce this discrepancy."

### **Background**

The bill is strongly supported by a multitude of state hospital associations and the National Rural Health Association (NRHA). The bill's 31 original cosponsors include the entire Alabama, Tennessee, and Arkansas delegations, as well as members from Georgia, Kentucky, Texas, and Louisiana.

This legislation would establish a national minimum of 0.874 for the Medicare Area Wage Index (AWI) for hospitals. CMS bases a portion of a hospital's reimbursements for inpatient services based on the AWI, a formula designed to reflect the relative hospital wage level in the geographic area of the hospital compared to the national average. All 13 Core-Based Statistical Areas (CBSAs) in Alabama have among the lowest AWIs in the country, and would benefit significantly from this legislation. Significant distortions over the past three decades have resulted from administrative and legislative actions favoring certain regions over others. Since the formula is calculated on a budget-neutral basis, any increase from one particular state means a decrease for other states. Under the current system, 20 CBSAs in California, Massachusetts, and New York have AWIs ranging from 1.332 to 1.724, while 158 CBSAs in 25 states have AWIs between 0.685 and 0.874. The Fair Medicare Hospital Payments Act of 2016 is designed to level the playing field so hospitals in those 25 states will no longer endure inadequate reimbursements due to gains in other parts of the country.

# **Rep. Sewell Honors Black History Month**

Congresswoman Terri Sewell released the following statement in recognition of Black History Month:

"This month, we pause to remember and honor the sacrifices the Foot Soldiers of the Civil and Voting Rights movements made in order to make our nation a more equal, just, and fair society. The story of Alabama and the 7th Congressional District cannot be told without remembering those who sought to free our land from racial animosity and discrimination.

"As we pause to remember their efforts, we must also seek to preserve the historical landmarks associated with the struggle for equal rights. In keeping with the theme for the 2016 Black History Month is "Hallowed Grounds: Sites of African American Memories," my office has been working with local, state, and federal officials to discuss how to best protect and preserve the historic Civil Rights sites across Alabama's 7th Congressional District. Our district is the birthplace of the fight for equality, and we owe it to future generations to preserve this rich legacy.

"Our nation has made much progress since the passage of the landmark Civil Rights Act of 1964 and the Voting Rights Act of 1965. We owe it to ourselves, our children, and those who came before us to continue to break down any barriers that divide our society and in its place build new foundations for understanding and reconciliation. We should all commemorate this month by fulfilling the promise of our nation's democracy, and committing ourselves to uplifting our communities. By standing as one people, one nation, we can bring about change."

# Rep. Sewell Issues Statement on Fairfield Walmart Closure

Congresswoman Terri Sewell issued the following statement after speaking with Walmart executives about the pending closure of the Walmart Supercenter in Fairfield, Alabama:

"I am disappointed that Walmart has chosen to close its Supercenter in Fairfield, Alabama. That store was a vital part of Fairfield's local economy, and approximately 300 employees will lose their jobs as a result. The closure also creates a food desert in Fairfield, an underserved area where residents have few viable alternatives to purchase quality and affordable food.

"Creating jobs continues to be my top priority. The economy has turned back from the brink and is growing, but the recovery is far too modest and more needs to be done to address persistent unemployment. Closing this Walmart store will be a step in the wrong direction. Despite remarkable economic gains I believe that our work is not done. Too many working men and women continue to struggle just to provide the basic necessities for their families.

"The closing of the Walmart Supercenter in Fairfield is simply wrong for my constituents. Too many communities of color find themselves underserved and disadvantaged and closing this store will not help the situation. If we are to truly and substantively address these inequities, we must ensure that economic prosperity is a dream attainable to all who are willing to work for it. Closing this Walmart is the wrong thing to do!

"I have expressed my concerns to senior Walmart executives. My hope is that Walmart will reconsider this decision after analyzing the negative effect this would have on the Western Birmingham communities. Walmart is one of our nation's largest employers, and it is critically important that they consider the impact of their decisions on the communities they serve."

# Rep. Sewell Honors Dr. King's Legacy

Congresswoman Terri A. Sewell released the following statement in recognition of Dr. Martin Luther King, Jr., Day which our nation will observe on Monday, January 18, 2016.

"Dr. Martin Luther King, Jr., proved that the hearts of many could be changed by the voice of one. Eloquently declaring that, 'Love is the only force capable of transforming an enemy into a friend,' Dr. King laid the framework for the essential bridge toward equality. His dream of a collective nation, dedicated to peace and harmony, is the cornerstone of his teachings. We should arm ourselves with the love and compassion Dr. King carried daily.

"As a daughter of Selma, Alabama, I am proud to represent a district historically rooted in the fight for civil and voting rights. We cannot forget the many sacrifices that have been made to advance the cause of equality, and we must do our part to carry the torch that has been passed down to us. Dr. King's timeless vison should continue to guide us as we push forward. We cannot become complacent, but should remain steadfast in our push to secure fair voting rights across the nation. Organizational Assessment: Reviews all areas of operations.

Collections Stewardship Assessment: Focuses on collections policies, planning access, documentation, and collections care within the context of the museum's total operations.

Community Engagement Assessment: Assesses the museum's understanding of and relationship with its communities as well as its communities' perceptions of and experiences with the museum. Two Application Deadlines is July 1 and December 1.

Tragically, Cara passed four months after her diagnosis, yet her wish to help others through K4C lives on with the support of an ever-growing circle of family and friends.

As part of an effort to promote and support youth voluntarism, k4C started a microgrant program in fall 2014 to encourage kids 18 and under to apply for a grant of between \$250 and \$1,000 to complete service projects in their communities. Examples of fundable projects include but are not limited to turning a vacant lot into a community garden, rebuilding a school playground, and helping senior citizens get their homes ready for winter. Grants will be distributed as gift cards to home goods stores, office supply stores, grocery food chains, and toy stores. Deadline is OPEN.

- 4) Health Award: Recognizes an individual who has made a significant contribution to children in the fields of health, medicine, or the sciences. Nominees must have created, managed, or otherwise supported a sustainable program that has significantly contributed to the improved health of children; do this work over and above their normal employment or work for little or no pay; have been doing this work for a minimum of ten years; and have an existing nonprofit organization in good standing that can receive grant funds. The minimum grant award is \$50,000.
- 5) Youth Award: Recognizes youth that are making extraordinary contributions to the lives of other children. 

The online Veterans Employment Center is the single federal source for Veterans looking for new career opportunities in the private and public sectors, as well as Service Members transitioning to the civilian workforce, military and Veteran spouses and dependents looking for employment opportunities, GI Bill beneficiaries transitioning from training to the job market and employers looking to connect with high quality applicants. It is the first interagency tool that brings together public and private job opportunities with resume building and other career tools currently offered on a variety of websites together in one place.

Through the online Veterans Employment Center, Veterans, transitioning Service Members and spouses are connected to high quality career choices by matching their identified skills with available public and private job opportunities. The site is built using an open application programming interface (API) to attract private sector innovation.
