Rep. Sewell Issues Statement on Judge Fuller's Resignation

Washington, D.C. -- Congresswoman Terri Sewell issued the following statement in response to reports that Judge Mark Fuller would resign from office effective August 1st.

"News of Judge Fuller's impending resignation is a welcome outcome to a very painful breach of the public trust. His resignation will be the culmination of a drawn out process that was woefully unnecessary. The public trust was violated the moment his wife phoned the police.

"Justice was not served. We sent the wrong message to victims of domestic violence by allowing a federal judge to collect a paycheck -- without managing a caseload -- and ultimately having his record expunged.

"Fuller failed to uphold our most fundamental values. Perhaps the only consolation is that he has chosen to spare his family and our nation of the expense of a drawn out impeachment process."

Statement from Rep. Sewell in Observance of Memorial Day

Washington, D.C. – Congresswoman Terri Sewell released the following statement in honor of Memorial Day:

"This Memorial Day, our nation will join as one to remember the brave men and women who gave their lives defending our freedom. We should never take for granted the opportunities and liberties we enjoy as Americans due to their sacrifice. Our freedom was made possible by the heroism of those who served in our armed forces.

"As we honor those who lost their lives, we must also be thankful for the valor shown by those who currently serve in uniform. Supporting our veterans and their families is one of our nation's most fundamental responsibilities. Not one of our heroes should return home only to struggle to find a job or receive quality healthcare. The sacrifice these men and women have made for us requires us to do no less.

"Let us never forget the men and women who so bravely fought for our freedom. Their legacy will live on in our hearts and memories."

USDA Seeks Applications for Grants to Help Socially-Disadvantaged Producers

WASHINGTON, May 26, 2015 - Agriculture Secretary Tom Vilsack today announced that the U.S. Department of Agriculture (USDA) is now accepting applications to provide technical assistance to socially-disadvantaged groups in rural areas.

"These grants will help socially-disadvantaged business owners develop the tools and skills they need to grow their enterprises and succeed at creating jobs and expanding economic opportunities in rural areas," Vilsack said. "American agriculture is becoming increasingly diverse in many ways, with more minorities and women seeking to enter the field, as well as greater diversity in the age of farmers, the size of operations, in production methods, and in the types of crops being grown. All of these forms of diversity help strengthen U.S. agriculture for the future."

Funding will be made available through USDA's <u>Socially-Disadvantaged Groups Grant Program</u> (formerly the Small, Socially-Disadvantaged Producer Grant Program), which assists organizations that provide technical assistance to socially-disadvantaged groups in rural areas. Examples of technical assistance are conducting feasibility studies, developing business and strategic plans, and providing leadership training.

USDA plans to make up to \$3 million in grants available. The maximum award under this notice is \$175,000. More information on how to apply can be found on page 28937 of the May 20 <u>Federal Register</u>. Applications submitted by mail must be postmarked by July 20, 2015. Electronic applications must be submitted at <u>www.grants.gov</u> no later than midnight Eastern Time July 14, 2015.

Eligible applicants include groups of cooperatives, cooperative development centers and individual cooperatives that serve socially-disadvantaged groups. The cooperatives or centers can be located in any area, but the groups assisted must be located in an <u>eligible rural area</u>. Also, the majority of the governing body of the organization must be compromised of individuals who are members of socially-disadvantaged groups.

USDA Rural Development is encouraging applications for projects in census tracts with poverty rates of 20 percent or higher. All grants are awarded through a national competition.

The program is making a difference in many rural areas. For example, in 2013, the Southern California Focus on Cooperation (SCFC) received a \$200,000 Small, Socially-Disadvantaged Producer Grant to provide technical assistance to help 95 refugee immigrant and minority farmers improve their productive capacity, increase revenue, and strengthen their ability to govern and manage their cooperative businesses.

Many of the farmers benefiting from the project had little or no access to formal schooling and had been persecuted and oppressed for years in their native land. The International Rescue Committee (IRC), in concert with SCFC, developed marketing channels including various farmers markets and restaurants where the refugee farmers could sell their produce. Farmers have learned how to manage these marketing channels themselves, without assistance from IRC, and have gained new clients. They have also increased the level of cooperation among Hispanic, Korean and African farmer groups. These groups are working toward merging their efforts to form a single cooperative. The technical assistance provided by SCFC has enabled these farmers to build skills that have truly been life changing.

USDA Announces Funding Opportunity for Distance Learning and Telemedicine Projects

WASHINGTON, May 22, 2015 - Agriculture Secretary Tom Vilsack today announced that the U.S. Department of Agriculture (USDA) is accepting applications for its <u>Distance Learning and Telemedicine</u> (DLT) grant program, which provides increased access to education, training and health care resources in rural areas.

"This program provides people who live and work in rural areas with better access to a variety of educational and health care services," Vilsack said. "For example, because of the DLT program, students in rural areas can take advanced placement classes, residents can have access to specialized medical services not typically available, and many other benefits for rural communities."

USDA's Rural Utilities Service, a Rural Development agency is making \$19 million available for fiscal year 2015. The Distance Learning and Telemedicine Program finances telecommunications equipment, computer networks and advanced technologies for use by students, teachers, medical professionals and rural residents. Minimum grant amounts are \$50,000; maximum amounts are \$500,000 for fiscal year 2015.

Since 2009, USDA has provided more than \$182 million to expand access to learning at nearly 4,700 rural educational facilities and to improve delivery of medical care at more than 2,500 rural health facilities.

Details of the DLT funding are on Page 29602 of the May 22 <u>Federal Register</u>. The application deadline is July 6, 2015.

U.S. Secretary of Commerce and Aspen Institute Announce Partnership to Strengthen Workforce Development Efforts Across the Nation

U.S. Secretary of Commerce Penny Pritzker and Aspen Institute President and CEO Walter Isaacson today launched the *Communities that Work Partnership*, a brand new joint project aimed at accelerating industry-led workforce development and training efforts.

As part of the Department's "Skills for Business" initiative, the partnership will competitively select six teams around the country comprised of leaders in industry, government, education, workforce and economic development. These teams will receive technical assistance and participate in leadership development activities to strengthen regional skills development strategies that meet both businesses' and workers' needs. The results will inform and improve talent development efforts across the country. Aspen Institute Workforce Strategies Initiative (AspenWSI) will lead the initiative through a \$500,000 grant, which the Department's Economic Development Administration (EDA) has awarded for the very first time.

"The Obama Administration has taken unprecedented steps to bring together businesses, educational institutions, workforce and economic development organizations, local governments, as well as non-profits to prepare workers for in-demand jobs," said Secretary Pritzker. "As part of the Department of Commerce's 'Skills for Business' initiative, our partnership with Aspen will support worker training that meets businesses' and workers' needs and keeps America competitive."

"I'm honored that Secretary Pritzker selected the Aspen Institute to help establish the Communities that Work Partnership," said Walter Isaacson, President and CEO of the Aspen Institute. "The initiative's focus on promoting employer-led skills development is just the kind of innovative approach we need more of today to help address the inequality that has become all too pervasive in our economy."

Secretary Pritzker has made skills and workforce development a top priority for the Department of Commerce, and is working with the private sector and government leaders at all levels as part of the 'Skills for Business' initiative to prepare workers with the training needed to secure the 21st century jobs business leaders are seeking to fill.

At today's event, it was announced that AspenWSI has published a website with information about the initiative here. Their national selection committee will competitively select six teams from different regions. AspenWSI will document the strategies and lessons learned from these six original teams and provide new learning tools and case studies that can help communities and regions across the nation develop their talent pipelines to fill in-demand jobs.

AspenWSI was selected from among a dozen other applicants to partner with Commerce because of its proven track record and innovative work with workforce and leadership development.

Department of Justice's Office of Community Oriented Policing Services releases final task force report, opens 2015 grant solicitations

Grants to focus on task force objectives

WASHINGTON, DC - The Office of Community Oriented Policing Services today announced the release of the final report from the President's Task Force on 21st Century Policing. On Dec. 18, 2014, President Barack Obama signed an executive order establishing the task force and charged it with identifying best practices and recommendations on how policing practices can promote effective crime reduction while building public trust. The task force sought expertise from stakeholders and input from the public to make recommendations, which are included in the final report.

"This report includes tenable solutions for every community across this nation, whether large or small," said COPS Office Director Ronald Davis. "The remarkable 11 individuals that made up this task force were able to build consensus around some of the most challenging topics in policing."

The COPS Office today also announced five separate Fiscal Year 2015 grant funding opportunities now open to the field for submission of applications. Agencies applying for funding are strongly encouraged to incorporate the recommendations of the President's Task Force on 21st Century Policing into the community policing strategies proposed in their applications. Grants will provide a total of up to \$163 million to state, local, territory and tribal law enforcement agencies to meet a variety of resource needs, including sworn officer positions, training and technical assistance, and expansion of problem-focused task forces.

The 2015 COPS Hiring Program is a competitive grant program that funds the hiring or rehiring of law enforcement officers. CHP provides 75 percent of the approved entry-level salaries and fringe benefits of each newly hired and/or rehired full-time officer, up to \$125,000 per officer position, over the three-year (36 month) grant period.

The 2015 Community Policing Development Program advances the practice of community policing in law enforcement agencies through training and technical assistance, the development of innovative community policing strategies, applied research, guidebooks and best practices that are national in scope. The CPD solicitation is designed to address critical topics in the law enforcement field by building on the principles of community policing.

The 2015 COPS Anti-Gang Initiative funds regional, multijurisdictional anti-gang task forces comprised of federal, state and local law enforcement agencies to address gang activity, focusing on enforcement, prevention and education and intervention.

The 2015 Anti-Heroin Task Force Program assists state law enforcement agencies in states with high per capita levels of primary treatment admissions for both heroin and other opioids. AHTF funds shall be used for investigative purposes to locate or investigate illicit activities related to the distribution of heroin or unlawful distribution of prescription opioids.

The 2015 COPS Anti-Methamphetamine Program advances public safety by providing funds directly to state law enforcement agencies to investigate illicit activities related to the manufacture and distribution of methamphetamine.

Applications for all programs are due by 7:59 p.m. EDT on June 19, 2015 and are available through the COPS Office website.

USDA Seeks Applications to Expand Economic Development in Rural Communities

Washington, District of Columbia, May 15, 2015 —

Agriculture Under Secretary Lisa Mensah today announced that USDA is seeking applications for grants to support rural community economic development.

"This funding from USDA will ensure that technical and financial assistance is available for those who wish to improve the quality of life in rural communities," Mensah said. "Very often, great visions for better rural communities exist, but the next steps toward positive change are unclear. These grants will help rural communities build a path to community economic development so rural America can share in the nation's economic recovery."

Approximately \$10.4 million is being made available under the <u>Rural Community Development Initiative (RCDI) program</u>. Eligible applicants include public, private, and non-profit intermediaries, and federally recognized tribes.

RCDI grants can be used to provide training or technical assistance. Training may be focus on homeownership education, minority business entrepreneurship, strategic community planning or accessing alternative funding sources. Intermediary organizations must provide matching funds at least equal to the RCDI grant. Grants range from \$50,000 to \$250,000.

USDA has invested more than \$33 million through the RCDI program since 2009. In 2013, the Choctaw Nation of Oklahoma received a \$150,000 grant to provide home buying and home maintenance education to 50 Native American women in the community of Broken Bow.



It is the first interagency tool that brings together public and private job opportunities with resume building and other career tools currently offered on a variety of websites together in one place. Through the online Veterans Employment Center, Veterans, transitioning Service Members and spouses are connected to high quality career choices by matching their identified skills with available public and private job opportunities. The site is built using an open application programming interface (API) to attract private sector innovation.
