### Rep. Sewell Honors Dr. King's Legacy

Congresswoman Terri A. Sewell released the following statement in recognition of Dr. Martin Luther King, Jr., Day which our nation will observe on Monday, January 18, 2016.

"Dr. Martin Luther King, Jr., proved that the hearts of many could be changed by the voice of one. Eloquently declaring that, 'Love is the only force capable of transforming an enemy into a friend,' Dr. King laid the framework for the essential bridge toward equality. His dream of a collective nation, dedicated to peace and harmony, is the cornerstone of his teachings. We should arm ourselves with the love and compassion Dr. King carried daily.

"As a daughter of Selma, Alabama, I am proud to represent a district historically rooted in the fight for civil and voting rights. We cannot forget the many sacrifices that have been made to advance the cause of equality, and we must do our part to carry the torch that has been passed down to us. Dr. King's timeless vison should continue to guide us as we push forward. We cannot become complacent, but should remain steadfast in our push to secure fair voting rights across the nation. On this Martin Luther King, Jr., holiday, let us recommit ourselves to the principles of equality and justice for which Dr. King died."

### Rep. Sewell Praises Obama's Accomplishments and Final State of the Union Address

Congresswoman Terri Sewell issued the following statement after President Obama's final State of the Union address:

"President Obama's legacy will be one of a man who sought to unify a divided nation, and whose very election illustrates how far our nation has progressed since Martin Luther King, Jr., dreamed of equality.

"I was honored to share this historic moment with Sheyann Webb-Christburg whose presence should serve as a reminder that federal voting protections are as necessary today as they were in 1965 when an 8-year-old Sheyann marched from Selma to Montgomery in the name of voting equality. Sheyann's presence should also remind us that progress is elusive, and that we must not take for granted any of the rights and privileges afforded to us.

"President Obama has long warned our nation against abandoning our core values. Our collective commitment to democracy, equality, and opportunity has led us to greatness. America stands as a beacon of light around the world, lending hope to other peoples and nations across the globe. "We cannot, as President Obama wisely noted, adhere to what Lincoln called the 'dogmas of the quiet past.' President Obama has once again called on our nation to work hand in hand to create more opportunities for our families and to raise our standard of living.

"Under President Obama's leadership, American businesses have added 14.1 million jobs in 70 consecutive months. Unemployment among African-Americans has dropped to 8.3 percent from a peak of 16.8 percent in March 2010. Across Alabama, the unemployment rate has fallen to 6 percent from a recession-era peak of 11.9 percent.

"Nearly 18 million previously uninsured Americans now have health coverage thanks to the Affordable Care Act, and consumers cannot be denied health insurance due to pre-existing coverage. We still have much work to do in terms of lower health disparities between African-Americans and whites. Parts of my district are rural, and access to quality health care is a long-standing problem that I would like to see addressed.

"I am pleased too that President Obama mentioned criminal justice reform as one of his bipartisan priorities. The population in our nation's jails and prisons has reached a new high even though crime rates are falling. It's been proven that African-Americans receive harsher sentences than whites for the same crimes. Justice is color-blind, and we must do more to ensure that our laws are as well.

"Despite the gains our country has made and the vision that President Obama has outlined, Congress' blind allegiance to party politics has gotten in the way of progress. We have witnessed a backlash to many of his signature achievements – from the passage of the Affordable Care Act to re-establishing diplomatic relations with Cuba – and such resistance done nothing to advance our collective national agenda. I implore my colleagues in Congress to set aside politics, and to work with President Obama in his final year at the White House.

# Voting Rights Activist Sheyann Webb-Christburg Joins Rep. Sewell at the State of the Union

In recognition of the need to restore the full protections of the Voting Rights Act of 1965, Congresswoman Terri Sewell has invited Sheyann Webb-Christburg of Montgomery – who at 8 years old was the youngest Foot Soldier to march from Selma to Montgomery in the name of voter equality – as her special guest for President Obama's final State of the Union address.

"The State of Union falls on 'Restoration Tuesday' and I believe Sheyann Webb-Christburg is the embodiment of the struggle for voter equality in America. My hope is that her presence at the President's address will remind us of the modern day fight for ensuring that ever American citizen has access to the ballot box. The closure of DMV offices in Alabama last year proves that barriers to voting still exist and that Congress should pass the Voting Rights Advancement Act now! "At an early age, Sheyann recognized that America failed to live up to its own promise by depriving African-Americans of their right to vote. Sheyann's bravery reminded those around her that they were fighting for the next generation – her generation – as fervently as they were fighting for their own. Her courage also made it possible for me to represent our hometown of Selma in Congress. And as my childhood babysitter, I have literally grown up in her shadow. I am thankful to call Sheyann my friend, and honored to have her as my special guest for President Obama's last State of the Union. Her presence should once again serve as a reminder of the importance of the vote," said Rep. Sewell.

This will be Sheyann Webb-Christburg's first time attending the State of the Union.

"I am very grateful, honored, and blessed to be given the opportunity by Congresswoman Terri Sewell to share in such an historical moment. It is my hope that President Obama will reflect on the progress that has been made since he took office, and outline his vision for our nation," said Sheyann Webb-Christburg.

"Our nation has come a long way, but we still have a long way to go to. Federal voting protection is critical, and urgently needed. Recent experiences have shown us that disenfranchisement still poses a threat to our democracy. It saddens me to know that this is still an issue 50 years later. The struggles, blood, sweat, and tears of the 1960's were too horrific and unjust for us to take any steps backwards. We must continue to educate and fight to protect this privilege and this right," she continued.

#### **Background on Restoration Tuesday:**

On Restoration Tuesday, Members of Congress are encouraged to speak on the floor in support of restoring the landmark Voting Rights Act of 1965. RestorationTuesday is the opportunity for Members to bring attention to modern day barriers to voting and urge passage of the Voting Rights Advancement Act of 2015 (H.R. 2867) which provides a modern day formula for federal preclearance protection.

#### HUD OFFERS NEXT ROUND OF PLANNING GRANTS TO HELP TRANSFORM COMMUNITIES

Choice Neighborhoods Planning Grants to help communities revitalize distressed areas

WASHINGTON – Today, the U.S. Department of Housing and Urban Development (HUD) announced the availability of new funding to help local communities across the country to redevelop severely distressed public and HUD-assisted housing and transform surrounding neighborhoods. The funding announcement introduces an additional, innovative component to the **Choice Neighborhoods Planning Grant**, called Planning and Action Grants.

Grants of up to \$2 million will enable communities to create a locally driven plan to transform struggling neighborhoods, as well as implement early improvements, such as reclaiming vacant property and attracting new businesses. **Read HUD's funding notice.** 

"HUD's mission of expanding opportunity extends beyond a family's front door to the neighborhoods where they live," said HUD Secretary Julián Castro. "These grants will let local leaders create homegrown plans to strengthen their neighborhoods and to take those first vital steps to turn their plans into reality."

Choice Neighborhoods is HUD's signature place-based initiative in support of the President's goal to build Ladders of Opportunity to the middle class. Choice Neighborhoods is focused on three core goals:

- **Housing**: Replace distressed public and assisted housing with high-quality mixed-income housing that is well-managed and responsive to the needs of the surrounding neighborhood.
- **People**: Improve educational outcomes and intergenerational mobility for youth with services and supports delivered directly to youth and their families.
- Neighborhood: Create the conditions necessary for public and private reinvestment in
  distressed neighborhoods to offer the kinds of amenities and assets, including safety, good
  schools, and commercial activity, that are important to families' choices about their
  community.

Up to now, Choice Neighborhoods Planning Grant funds could only be used to create a neighborhood Transformation Plan. However, experience with the 63 previously awarded Choice Neighborhoods Planning Grantees has shown that tangible, early actions help sustain community energy, attract new resources, and build momentum to turn that plan into reality.

HUD's FY15/16 Choice Neighborhoods Planning Grant funds build upon these lessons by introducing Planning and Action Grants. Under these grants, communities with severely distressed public or HUD-assisted housing will continue to develop a successful neighborhood transformation plan and build the support necessary for that plan to be successfully implemented. In addition, Planning and Action Grant funds will also enable activities including:

- Reclaiming and recycling vacant property into community gardens, pocket parks, farmers markets, or land banking;
- Beautification, place making, and community arts projects;
- Homeowner and business façade improvement programs;
- Neighborhood broadband/Wi-Fi;
- Fresh food initiatives; and
- Gap financing for economic development projects.

Through the Choice Neighborhoods planning process local governments, housing authorities, residents, nonprofits, tribal authorities, private developers, school districts, police departments, and other civic organizations create a common vision and develop effective strategies to revitalize their neighborhood. The resulting Transformation Plan and locally driven Action Activities lay the foundation for revitalizing the distressed public and/or assisted housing units, transforming the surrounding neighborhood, and promoting opportunities for families.

Today, Choice Neighborhoods Planning Grantees can be found across the country in cities and towns, such as Kansas City, Missouri, Norwalk, Connecticut, and Sacramento, California. Several Planning Grantees have already launched neighborhood improvements that provided the inspiration for Planning and Action Grants. For example, in Salisbury, North Carolina, partners expanded a Mobile Fresh Farm to residents, spurring a nearby college to open a new culinary school that will provide mentoring to local students and sell surplus produce at discount prices. In Columbus, Ohio, partners created a gateway to the community by redeveloping a highway bridge and creating a mural wall with a history of the neighborhood.

Choice Neighborhoods Planning Grant funds are available for public housing authorities, local governments, nonprofit organizations, and tribal entities. Applicants must submit a completed electronic application through <a href="https://www.grants.gov">www.grants.gov</a> by February 9, 2016. <a href="https://www.grants.gov">Read HUD's funding notice</a>.

The minimum grant award is \$50,000.
- 4) Health Award: Recognizes an individual who has made a significant contribution to children in the fields of health, medicine, or the sciences. Nominees must have created, managed, or otherwise supported a sustainable program that has significantly contributed to the improved health of children; do this work over and above their normal employment or work for little or no pay; have been doing this work for a minimum of ten years; and have an existing nonprofit organization in good standing that can receive grant funds. The minimum grant award is \$50,000.
- 5) Youth Award: Recognizes youth that are making extraordinary contributions to the lives of other children. Nominees must be under the age of 21 by the nomination submission deadline; have an existing nonprofit organization in good standing that can receive grant funds; and have been doing this work for a minimum of three years by the nomination submission deadline. The minimum grant award is \$25,000.





#### **FACT SHEET: Veterans Employment Center**

The online Veterans Employment Center is the single federal source for Veterans looking for new career opportunities in the private and public sectors, as well as Service Members transitioning to the civilian

workforce, military and Veteran spouses and dependents looking for employment opportunities, GI Bill beneficiaries transitioning from training to the job market and employers looking to connect with high quality applicants. It is the first interagency tool that brings together public and private job opportunities with resume building and other career tools currently offered on a variety of websites together in one place.

Through the online Veterans Employment Center, Veterans, transitioning Service Members and spouses are connected to high quality career choices by matching their identified skills with available public and private job opportunities. The site is built using an open application programming interface (API) to attract private sector innovation.

#### **Veteran Applicant Resources:**

- Quick public resume posting with an instant connection to thousands of public and private employers
- Target job search based on specific, high-demand career paths
- Single search for both public and private sector positions
- Military skills translator and resume generator
- Social media integration with popular bookmarking sites for saving job postings

- Access targeted feed of qualified resumes from Veteran applicants
- View reverse skills translation (military to civilian skills) for applicants
- Set Veterans hiring goals and track progress
- Connect to resources designed to help recruit and retain talented, Veteran employees

In connection with the First Lady and Dr. Biden's Joining Forces initiative, the Department of Veterans Affairs worked with the Departments of Defense, Labor, and Education, and the Office of Personnel Management to design and develop the site and incorporate features of existing online employment tools at each agency. The result is an upgrade to the existing Veterans Job Bank and an integrated solution connecting Veterans, transitioning Service Members and employers.

Employers, Veterans and transitioning Service Members deserve a single, authoritative source for connecting to each other. Now that the core tools and an integrated search function exist in one single location, each agency is engaged in minimizing duplication and redundancy of current sites and services.
