Sewell votes to require background checks on sales, transfers of all firearms

WASHINGTON, D.C. – By a vote of 240-190, the U.S. House of Representatives today passed bipartisan legislation to require background checks for anyone wishing to purchase a firearm.

"Today's vote is historic – it is the first time in my eight years in Congress that the House of Representatives has taken bold action to protect our communities from gun violence. This legislation will help keep firearms away from dangerous people by ensuring that individuals already prohibited from firearm possession under federal law are not able to obtain a gun," **Rep. Terri Sewell (AL-07) said.** "Requiring universal background checks on the sale of every gun is an essential part of ensuring that guns do not fall into the wrong hands. According to one study, nearly a quarter of Americans who acquired a gun did so without a background check. Without a background check, we can't be sure if they were felons, domestic abusers or violent criminals."

"The status quo is not working, and today we proved that we will not stand by and do nothing while this type of violence rips apart our communities," **Sewell said.** "Today we demanded more than thoughts and prayers – we demanded action."

Currently, background checks are required under federal law only for sales conducted by licensed dealers. The Bipartisan Background Checks Act of 2019 would ensure already-prohibited individuals cannot buy a gun by requiring any firearm transfer between unrelated, unlicensed individuals to be conducted through a licensed dealer, who is required to perform the background check on the recipient. This provision would close the so-called "gun-show loophole" by requiring a background check for the sale or transfer of any firearm, regardless of where it is purchased.

The bill, however, provides a number of exemptions to the universal background check requirement, including gifts to family members and transfers for hunting, target shooting and self-defense.

Sewell, Leahy introduce The Voting Rights Advancement Act

WASHINGTON, D.C. – U.S. Rep. Terri Sewell (AL-07) and Sen. Patrick Leahy (D-VT) introduced legislation today to help address the most egregious forms of recent voter suppression by developing a process to determine which states and localities with a recent history of voting rights violations must pre-clear election changes with the Department of Justice.

"In my hometown of Selma and throughout Alabama's 7th Congressional District, Americans bled, marched and died for the right to vote, but the modern-day voter suppression we saw in the 2018 mid-term elections shows that old battles have become new again," **Sewell said.** "Since the Supreme Court's *Shelby vs. Holder* decision, many states have enacted more restrictive voting laws that have led us in the wrong direction. The Voting Rights Advancement Act helps protect and advance the legacy of those brave foot soldiers of the civil rights movement by restoring key provisions of the Voting Rights Act of 1965 and empowering the Justice Department to stop voter suppression tactics before they go into place."

"Nearly 54 years ago next week, on March 7, a courageous band of civil rights activists – including my friend and hero, Congressman John Lewis – began a march for the right to vote from Selma to Montgomery. They marched non-violently in the face of unspeakable violence. On that Bloody Sunday, they shed their blood for the ballot. But we gather today for much more than a vital history lesson," **Leahy said.** "We assemble today for a call to action. Voter suppression efforts are unacceptable and un-American. But because of a disastrous Supreme Court decision, they are almost impossible to stop. The Voting Right Advancement Act we are introducing today would restore and bolster the Voting Rights Act, and undo the damage done by the Shelby County decision."

"The election of 2016 was a wakeup call. Voters were threatened and given false information. Hundreds of thousands of voters were purged from the rolls all over the country. People who had voted for decades were turned away from the polls. What happened? It was the first election in over 50 years without the protection of the Voting Rights Act," **Rep. John Lewis said.** "We must repair what the Supreme Court damaged. We must pass this bill to ensure that every American has equal freedom to participate in our democracy."

"The right to vote is one of the most sacred and fundamental tenets of our democracy. Despite the progress we have made as a nation since the passage of the Voting Rights Act, there are far too many examples of those in power working to make it harder for folks to vote," **Sen. Doug Jones said.** "Efforts to restrict access to the ballot box disproportionately affect people of color, the elderly and people with disabilities. It's just plain wrong. That's why I am proud to once again join Congresswoman Sewell and our colleagues in introducing this important legislation and carrying on the legacy of all those who fought tirelessly to extend the right to vote to every American."

"Voting is the basis of our democracy, and yet a privilege still denied to many. While we've seen state leaders in places like Texas challenge voting rights and actively suppress turnout, we can and must do more to break down barriers that keep Americans, and disproportionately minority communities, from the polls," **CHC Chairman Joaquin Castro said.** "I'm proud to support H.R.4, which would restore a critical Voting Rights Act protection by requiring states with recent history of voter discrimination seek federal preclearance for election charges, and in doing so, prevent voter suppression, make elections more transparent and ensure all

Americans, regardless of their zip code or skin color, have a voice in our democracy. This is not a partisan issue. As Americans, we must ensure the integrity of the robust democracy our Founding Fathers envisioned for our nation."

The Supreme Courts' 2013 *Shelby County v. Holder* ruling struck down Section 4(b) of the Voting Rights Act of 1965, which outlined the qualifications needed to determine which states are required by the Justice Department to pre-clear elections changes in states with a history of voter discrimination.

Since the *Shelby* decision, nearly two-dozen states have implemented restrictive voter ID laws and previously-covered states have closed or consolidated polling places, shortened early voting and imposed other measures that restrict voting.

The Voting Rights Advancement Act (VRAA) seeks to restore the VRA by developing a process to determine which states must pre-clear election changes with the Department of Justice. It will also require a nationwide, practice-based pre-clearance of known discriminatory practices, including the creation of at-large districts, inadequate multilingual voting materials and cuts to polling places.

The House and Senate will also hold a series of hearings to document the public record of voter suppression and the need for federal pre-clearance enforcement.

In addition to Reps. Sewell, Lewis and Castro the bill was introduced by 207 representatives. In addition to Sens. Leahy and Jones, the bill was introduced by 46 senators.

The Voting Rights Advancement Act is endorsed by the Leadership Conference on Civil Rights; Lawyers' Committee for Civil Rights Under Law; Brennan Center for Justice; Human Rights Campaign (HRC); Asian Americans Advancing Justice (AAJC); National Association of Latino Elected Officials (NALEO) Educational Fund; Native American Rights Fund (NARF); National Education Association (NEA); Mexican American Legal Defense and Education Fund (MALDEF); NAACP Legal Defense and Educational Fund, Inc.

Sewell co-sponsors measure to revoke national emergency declaration

Resolution would nullify border edict

WASHINGTON D.C. – U.S. Reps. Terri Sewell (AL-07) and Rep. Joaquin Castro (TX-20) on Friday filed a resolution of disapproval to block President Trump's emergency declaration to build a border wall.

"The President's emergency declaration is an overreach of executive power. He himself said he did not 'need to' declare an emergency at the border," **Sewell said.** "The real national emergency is not at our southern border – it is in our rural areas where hospitals are struggling to keep their doors open; it is in Lowndes and Wilcox counties, where residents lack basic water resources; it is in communities across the country that continue to be devastated by the opioid crisis. President Trump's border wall is not a national emergency."

A vote is scheduled on the resolution – which is sponsored by more than 220 members in the House of Representatives – for Tuesday, February 26, 2019. After the measure is passed by the House, it will be sent to the Senate as a privileged resolution, meaning it must be considered on the Senate floor within 18 days of House passage.

Sewell votes to prevent another government shutdown

Bipartisan, bicameral legislation now heads to the President for his signature

WASHINGTON, D.C. – U.S. Rep. Terri Sewell (AL-07) voted today to pass a bipartisan, bicameral compromise to avert a government shutdown and to fund the government through fiscal year 2019.

"I am proud the House and Senate put partisan politics aside and came to a consensus to fund the government, invest in our priorities and keep our country safe," **Sewell said.** "Not only did Congress vote today to avert another government shutdown, we voted to increase border security funding, deliver a hard-earned pay raise for federal employees and invest in American's crumbling infrastructure."

The government funding deal includes seven appropriations bills that include provisions that invest in America's future, including:

- **Increasing border security:** providing \$1.375 billion for physical barriers with language specifying that new fencing is limited to currently deployed designs;
- **Investing in national security:** a new Coast Guard Polar Security Cutter, the first icebreaker in over 40 years and an \$884 million funding increase for the Transportation Security Administration;
- **Delivering a pay raise to federal workers:** securing a 1.9 percent pay raise for federal civilian workers that overrides the president's decision to freeze federal employee wages;
- Ensuring a fair and accurate 2020 Census: investing \$3.8 billion in the Census, an increase of \$1 billion:
- **Building safer communities:** allocating more than \$3 billion for state and local law enforcement to keep communities safe, including addressing the opioid crisis, closing sexual assault kit backlogs and hiring more police officers;
- **Rebuilding America's infrastructure**: designating \$17 billion in funding for new infrastructure investments to improve our roads, bridges, highways, railways and mass transit, including nearly \$2 billion in rural water and waste water funding; and
- **Supporting small businesses**: restoring and increasing investments in job-creating initiatives for economic and business development, including for minority and women-owned businesses.

Sewell delivers State of the District address

WASHINGTON, D.C. – U.S. Rep. Terri Sewell (AL-07) delivered her 2019 State of the District address, highlighting the work she has done to bring opportunity to Alabama's 7th District and goals for the year ahead.

"In Congress, my focus has always been on bringing better opportunities and more resources to Alabama's 7th District," **Sewell said.** "And for those opportunities to exist here in Alabama and throughout the 7th District, we need to ensure our state's engines of job growth maintain their global competitiveness and continue to create jobs. We like to say our number one focus is jobs, jobs, jobs!"

Sewell outlined the many legislative wins she helped secure on behalf of the 7th District, including the \$1.1 billion in federal grants to fund critically important projects throughout the district and a 14 percent increase in federal funding for all HBCUs – including the seven that call the 7th District home.

In the year ahead, Sewell said one of her top priorities is the passage of her Voting Rights Advancement Act, which will restore the Voting Rights Act of 1965.

"As a native of Selma and Representative for the Voting Rights and Civil Rights District of America, I believe with every fiber of my being that we have a duty to ensure that every American – regardless of race, creed or color – has the opportunity to make their vote count at the ballot box," **Sewell said**. "To be clear: voting rights are under attack. Old battles have become new again!"

To my constituents, to Alabama's state and local elected officials, and to my district's many community leaders, I am honored to come before you today to report on the state of Alabama's 7th Congressional District.

Last November 2018, Americans made their voices heard! They turned out and elected the most diverse Congress in our nation's history and Democrats took control of the House of Representatives, picking up the most seats in a generation.

The House Democratic majority has a bold agenda to increase access to affordable healthcare, strengthen wages, and repair our infrastructure.

In Congress, my focus has always been on bringing better opportunities and more resources to Alabama's 7th District. I am happy to report that our office worked to return over \$2.6 million in retroactive benefits to our constituents in 2018. Our district also received \$1.1 billion in federal grants to fund critically important projects throughout the district.

Our office motto, "Constituents First," represents our commitment to ensuring that we are always ready to assist constituents and your families throughout the year.

I know that for Alabama to succeed, everyone in our state needs better opportunities to climb the economic ladder and strengthen their competitiveness in today's job market.

And for those opportunities to exist here in Alabama and throughout the 7th District, we need to ensure our state's engines of job growth maintain their global competitiveness and continue to create jobs. We like to say our number one focus is jobs, jobs, jobs!

That means we must work hard to provide the educational tools to help open doors of opportunity for all.

Alabama's 7th District is home to the University of Alabama, UAB, outstanding community colleges and seven historically black colleges and universities that help prepare our students for success.

This year, I am proud that we helped secure a 14 percent increase in federal funding for our HBCUs and passed loan relief for HBCUs struggling with debt, like Stillman College. We must recommit ourselves to helping ensure that all of our schools of higher education are strengthened for future generations to come.

In today's economy, it's imperative that Alabama continues to develop a competitive workforce through career and technical education.

Too often, manufacturers and business owners tell me that many positions remain unfilled because they cannot find employees with the skills needed to help their businesses grow and remain competitive.

We need to work together to provide all Alabamians with the necessary skills to be competitive in a 21st Century workforce.

That is why I have been working across the aisle with my colleagues in Congress to encourage businesses to work with community colleges and universities to develop apprenticeship programs that will lead to more skilled workers and good, high paying jobs for constituents in the 7th District.

Our office has introduced the Workforce Development Tax Credit Act, a bipartisan bill that would reward companies for having training programs and hiring those workers for skilled manufacturing jobs. It would help do that by assisting companies in creating recruitment pipelines which would costly turnover and provide tax incentives for businesses to provide apprenticeship programs in manufacturing.

One of the many ways we've been working over the past eight years to help support our constituents is by helping them find good, high-paying jobs. I am a firm believer that the key to success begins with the dignity of a job.

This past year I was proud to host our 7th Annual Congressional Job fair in Montgomery. At this event on the campus of ASU, we had over 1,100 job seekers and 104 major employers in industries ranging from the automotive industry to the military to health services. In 2019, we will bring our annual job fair back to Selma to offer our constituents an opportunity to talk with some of our state's biggest employers about quality job opportunities in the Black Belt.

This year we also continued our career readiness workshops through Project R.E.A.D.Y., a workforce development initiative that offers training by career professionals in partnership with educational institutions throughout the district.

I know that creating opportunity means standing up for policies that strengthen Alabama's economy. As the only representative from Alabama on the House Ways and Means Committee, I have and will continue to stand up for free and fair-trade policies that expand markets for our farmers and manufacturers.

And as always, I'm working across the aisle to make health care more affordable. Last year, we were successful in thwarting Republican attempts to repeal the Affordable Care Act. But that's not enough -- rising health costs

still squeeze paychecks and millions still lack coverage, especially in states like Alabama that didn't expand Medicaid.

So, I am working closely with my colleagues in Congress to stabilize and strengthen the ACA, expand coverage, simplify the health insurance process and reduce costs.

And the facts are clear: premiums and health care costs are higher in states that have not expanded Medicaid.

Over 90% of rural hospital closures have been in states that did not expand Medicaid before the closure.

In Alabama, approximately 314,000 more people would be covered under Medicaid expansion.

Not doing so is a poor decision; and while I can't force Alabama's governor to expand Medicaid, I can continue to promote legislation that provides more incentives for her to do so.

So, one of the first bills I introduced this Congress would extend the federal match to allow states that expand Medicaid in the future to still receive a 100 percent federal match for the first three years. The legislation will help cover the cost of expanding Medicaid to thousands of low-income families and non-elderly adults without children, giving them access to affordable health insurance.

Last year, I also made it a top priority to help improve health services in rural areas of our district.

I am proud to have worked with my colleagues across the aisle to secure funding for struggling, rural hospitals. To improve health services in rural communities, we introduced the Rural Emergency Medical Center Act and fought for funding for community health centers that provide necessary primary care services.

We also hosted a Health Fair in Lowndes County with Senator Doug Jones to encourage residents to get screened for health conditions resulting from exposure to raw sewage and promote our legislation to provide grants for low income residents to install septic tanks.

Sen. Jones and I were successful in getting the Rural Septic Tank Access Act included in the Farm Bill.

Since I came to Congress in 2011, I have worked to bring resources and solutions to the families living in Alabama's Black Belt with inadequate wastewater and sewer systems. I am proud to report that this past year we were able to also secure an additional \$1.8 billion in funding for water and wastewater infrastructure.

I have toured homes with no wastewater systems at all, and communities that rely on unsafe spray fields for their wastewater treatment. I have met with families in rural Alabama who struggle with the health and economic challenges created by failing wastewater systems. Every day, their stories inspire my fight in Congress for stronger investments in our wastewater infrastructure.

The funding we secured will help give our rural communities access to resources to bring their wastewater infrastructure into the 21st century.

I am excited to report that this investment is already at work in the City of Uniontown. In November 2018, the U.S. Department of Agriculture announced \$23.4 million in funding to repair the community's existing wastewater treatment plant and install new infrastructure.

USDA's assistance in Uniontown is an important step forward, but the wastewater crisis facing Alabama's rural Black Belt is not over. I will continue fighting for Uniontown, Lowndes County, and all of our state's residents who have to live with inadequate basic infrastructure.

While I am happy to report many successes over the past year, there is always more work left to be done to improve the lives and opportunities for those living in Alabama's 7th District.

One of my top priorities this year is the passage of the Voting Rights Advancement Act, which will restore the Voting Rights Act of 1965. As a native of Selma and Representative for the Voting Rights and Civil Rights District of America, I believe with every fiber of my being that we have a duty to ensure that every American – regardless of race, creed or color – has the opportunity to make their vote count at the ballot box.

To be clear: voting rights are under attack. Old battles have become new again!

We saw evidence of that in the 2018 midterm elections in November when, in Georgia, the Republican candidate for governor put 53,000 voter registrations on hold, nearly 70 percent of which were for black voters.

We saw it in North Dakota, where Republicans established a new requirement that voters show ID with a residential street address. That state law was a barrier to voting for thousands of Native Americans who live on reservations and use PO boxes, rather than residential street addresses.

We saw it in North Carolina, where state legislators closed 20 percent of early voting locations, making it harder to vote.

And we saw it in New Hampshire, Florida, Texas, and Wisconsin, where students faced higher hurdles to casting their ballots.

The foot soldiers of the Civil Rights Movement shed blood, marched and died for the right to vote in Selma and throughout the 7th District. I firmly believe that we must not only protect that legacy, but we should advance it.

So, I'm leading the charge to help rectify the ongoing injustices that many voters, especially minority voters, face when they go to the ballot box.

We plan to participate in field hearings around the country to prove that voter suppression is still alive and well.

We must create a steady drum beat to restore the Voting Rights Act because voting rights has become a partisan issue. So, while the VRAA will pass the House of Representatives since Democrats will support it, we must convince Republicans in the Senate to join us in order for our bill to become law. We all have a role to pay in raising public awareness about the need to restore the Voting Rights Act.

Indeed, we have a lot of work to do this year in Congress.

We must work to create jobs and raise wages in communities that have been left behind for far too long. We must ensure that all Alabamians, from families in Birmingham to those in our rural Black Belt, have adequate access to health care. We will fight to make sure that every Alabamian has the tools they need to thrive in today's economy. And we will work to make sure every American who casts a ballot has their vote counted.

Thank you for the opportunity to serve you in Congress.

Sewell Statement on Commerce Autos Report

This report was delegitimized from the start when President Trump called for a 25% tariff on autos before the investigation even began. The 24,000 auto workers in Alabama know that U.S. auto jobs do not threaten America – they strengthen it. I urge the President to consider the people of Alabama, and the damage auto tariffs would have on our state."

Sewell statement on possibility of President Trump declaring a national emergency

WASHINGTON, D.C – U.S. Rep. Terri Sewell (AL-07) released the following statement on the possibility of President Trump declaring a national emergency:

"The President is pounding his fists after failing to secure billions of dollars for a wasteful, ineffective brick-and-mortar wall that the vast majority of Americans do not support. His actions are a clear abuse of power and set a dangerous precedent. Instead, the President should be focused on addressing some of the real emergencies facing our country – gun violence, the opioid crisis, crumbling infrastructure and poverty."

Sewell statement on U.S. Steel jobs announcement

WASHINGTON, D.C. – U.S. Rep. Terri Sewell (AL-07) released the following statement in response to U.S. Steel's announcement that it will restart construction of an electric arc furnace steelmaking plant at its Fairfield Works facility in Jefferson County:

"My top priority in Congress has always been to promote good, high-paying jobs to Alabama's 7th District. Since U.S. Steel's Fairfield plant downsized in 2015, I have worked closely with U.S. Steel and the Fairfield community to get our steelworkers back to work. As a strong supporter of American-made steel, I am thrilled that U.S. Steel will add 150 full-time jobs at Fairfield Works.

"Manufacturing facilities like Fairfield Works are economic pillars in our community. While this expansion is a move in the right direction, Congress must do more to create jobs and strengthen manufacturing in states like Alabama. I look forward to continue working with steelworkers and U.S. Steel to promote growth and economic opportunity in Alabama's 7th District and across our state."

<u>National Robotics Initiative 2.0: Ubiquitous Collaborative Robots – (CFDA 10.310, 12.800, 43.001, 47.041, 47.070, 47.075, 47.076, 81.049, 81.104)</u>

The NRI-2.0 program builds upon the original National Robotics Initiative (NRI) program to support fundamental research in the United States that will accelerate the development and use of collaborative robots (co-robots) that work beside or cooperatively with people. The focus of the NRI-2.0 program is on ubiquity, which in this context means seamless integration of co-robots to assist humans in every aspect of life. The program supports four main research thrusts that are envisioned to advance the goal of ubiquitous co-robots: scalability, customizability, lowering barriers to entry, and societal impact. Topics addressing scalability include how robots can collaborate effectively with multiple humans or other robots; how robots can perceive, plan, act, and learn in uncertain, real-world environments, especially in a distributed fashion; and how to facilitate large-scale, safe, robust and reliable operation of robots in complex environments. Customizability includes how to enable co-robots to adapt to

specific tasks, environments, or people, with minimal modification to hardware and software; how robots can personalize their interactions with people; and how robots can communicate naturally with humans, both verbally and non-verbally. Topics in lowering barriers to entry should focus on lowering the barriers for conducting fundamental robotics research and research on integrated robotics application. This may include development of open-source co-robot hardware and software, as well as widely-accessible testbeds. Outreach or using robots in educational programs do not, by themselves, lower the barriers to entry for robotics research. Topics in societal impact include fundamental research to establish and infuse robotics into educational curricula, advance the robotics workforce through education pathways, and explore the social, economic, ethical, and legal implications of our future with ubiquitous collaborative robots. Collaboration between academic, industry, non-profit, and other organizations is encouraged to establish better linkages between fundamental science and engineering and technology development, deployment, and use. Such a collaborative approach is critical to informing and guiding the development of requirements towards the eventual development and deployment of user-centric innovative CI that fosters new pathways to discovery. Proposals pursuant to CESER should clearly identify and describe the science and engineering goals and rationale, and explain and support the potential for transformative impacts on science/engineering research and broader impacts. Proposals for technical efforts that are not well-tied to identified science and engineering researchchallenges as well as utilization scenarios are unlikely to be supported. Exploratory and pilot activities. CESER supports early-stage exploratory efforts that may comprise analysis, community planning, and pilot-level activities that are preparatory or informative for eventual future development and deployment of science/engineering-driven CI. Proposals for full-scale technical efforts leading to development/deployment should be directed to other appropriate NSF programs. Integrative and accelerative approaches. Proposals are particularly welcomed that address identified common needs across multiple research disciplines; leverage and accelerate the impact of existing CI investments in resources and services in one or more application domains; aim to reduce barriers to broader adoption of CI-enabled science/engineering approaches; and integrate different aspects and elements of CI to achieve holistic solutions with transformative science/engineering impact. Requirement to contact NSF Cognizant Program Officers. CESER is an inherently collaborative science/engineering-CI program. Successful CESER projects typically involve co-funding from the relevant disciplinary research programs within NSF. Consequently, before submitting a proposal to CESER, proposers must first (1) discuss their ideas with a cognizant CESER Program Officer to ensure that CESER is the appropriate venue for the proposal and (2) discuss their ideas with the relevant NSF disciplinary science and engineering research program(s) to ensure there is adequate disciplinary interest in the proposed effort. Proposals that have been declined by CESER or any other NSF program may not be resubmitted to CESER without substantial revision. Proposals violating this restriction may be returned without review

National Sea Grant American Lobster Research Program – (CFDA 11.417)

The American lobster (Homarus americanus) is one of the most iconic modern American fisheries and total U.S. landings of lobster have steadily increased over the past 35 years. Today, the ex-vessel value of the American lobster fishery is estimated at roughly \$666.7 million and represents one of the largest and most valuable fisheries along the Atlantic coast. In 2015, the American lobster fishery represented the highest landed value in the nation. Rising ocean temperatures have caused global fish population distribution shifts, and studies suggest warming temperatures may also directly impact the migration, growth, maturity, and natural mortality of American lobster. Of equal concern are potential impacts to lobster larval mortality due to ecosystem and food web changes. Lobster habitat is also changing, although the degree to which is unknown. These changes present threats to the American lobster fishery in the Gulf of Maine and Georges Bank, where the majority of American Lobster is harvested. Although lobster populations and landings in the Gulf of Maine and Georges Bank have been increasing since the late 1990s, young-of-year surveys began showing declines in 2012. The state of Maine, where more than eighty percent of lobsters harvested in the US were landed in 2016, reported an eighteen percent drop in catch volume in 2017. The recruitment failure experienced in southern New England and its subsequent impacts on the lobster fishery have raised concerns that a similar failure could occur in the Gulf of Maine and Georges Banks after years of record harvests. Understanding the factors leading to recruitment failures and the socioeconomic implications are critical to preserving the American lobster fishery. Both researchers and industry are already observing changes in maturation and growth in the Gulf of Maine lobster population. The 2015 stock assessment found that while the Gulf of Maine and Georges Bank stock was at record high abundance, there has been a decline in settlement in recent years - a potential sign of poor future recruitment. Changes in the spatial distribution of the stock such as increased migration between inshore and offshore habitat are also not well-understood. While traditionally much of the lobster fishery has been located in nearshore areas, there is also a need to better understand the growing offshore fishery. As the fishery adapts to the effects of environmental change, there are clear socioeconomic impacts to the communities involved. Critical research is needed now to answer some of the most important questions regarding the lobster stock and its fishery. This program will support research to address critical gaps in knowledge about how the American Lobster and its fishery is being impacted by environmental change. It is informed by listening sessions with regional fishing industry stakeholders, state and federal fisheries managers, and university, state and federal fisheries researchers. Research topics suitable for study on American lobster under this FFO should have a geographic focus of the Gulf of Maine and/or Georges Bank and address one or more of the following: (1) Increased understanding of life history parameters, including but not limited to, migration, growth, and maturity; (2) Larval studies and early biology; (3) Spatial distribution; and (4) Socioeconomic lessons learned from Southern New England as they pertain to Georges Bank and the Gulf of Maine. For each research topic above, special emphasis may be placed on the impact of warming temperatures. Pending appropriation of funds, Sea Grant anticipates awarding between 5-10 research projects totaling between \$1 million and \$2 million in FY2019. Projects must have a maximum duration of two years. The National Sea Grant College

Precision Measurement Grant Program (PMGP) – (CFDA 11.609)

The PMGP was started in 1970 to support research in the field of fundamental measurement or the determination of fundamental constants, enabling the faculties at universities and colleges and laboratory researchers to conduct significant research in this area. By funding the research projects of eligible applicants through this program, NIST supports advances in fundamental measurement, the determination of fundamental constants, and fosters extramural collaboration with NIST scientists. The PMGP also is intended to make it possible for researchers to pursue new ideas for which other sources of support may be difficult to find. There is some latitude in research topics that will be considered under the PMGP.

Wounded Warrior Service Dog Program (WWSDP) FY2019 – (CFDA 12.750)

Beginning in FY2015, Congress appropriated \$1,000,000 for the WWSDP to fund a competitive grants program. This program continues in FY2019 under the authority of the Defense Health Program, Operations & Maintenance, therapeutic service dog training program. The Uniformed Services University of the Health Sciences (USU) is authorized by 10 U.S.C. 2113(g)(1)(A) to make grants to any nonprofit entity. Historically, USU has solicited grant applications from nonprofit institutions committed to connecting service dogs with service members and veterans. USU obligated \$1,000,000 in FY2015, \$5,000,000 in FY2016, and FY2017 and \$10,000,000 in FY2018 to carry out this program. USU intends to award multiple, 12-month grants (subject to availability of funding) to eligible nonprofit organizations to continue this program in FY2019. All applications shall be submitted as outlined in this FOA. The Program Announcement (PA) number for this FOA is VP-19-001. All applications must be submitted electronically through the NIH ASSIST portal. Information on applying through ASSIST is outlined in the FOA. USU plans to obligate approximately \$10,000,000 in grants to successful applicants for the WWSDP in FY2019. The number of grants to be awarded and the amount of funding per grant is to be determined based upon the quality of the applications. On average, since the Program's inception, USU awarded grants to 21 Recipients with an average funding amount of approximately \$251,500 per award with awards ranging from \$45,000 to \$586,800. Funding provided through this program is not intended to finance new programs or initiatives, but to support the operations of existing programs. The planned period of performance for the FY2019 WWSDP is June 2019 through June 2020. Past Recipients of WWSDP grants are eligible to apply and compete for FY2019 WWSDP grants; however, applications for renewal or supplementation of existing awards will not be considered. The WWSDP is limited to nonprofit organizations subject to 26 U.S.C. 501(c)(3) of the tax code. Applicants must be nonprofit organizations who have been established for the purpose of training and providing service dogs. Pass-through entities will not be considered. Organizations should be able to tailor a comprehensive plan to establish and operate a program to provide assistance dogs to Service Members and/or Veterans with disabilities. An applicant's failure to meet eligibility criteria by the application deadline will preclude USU from making an award to the applicant.

FY2019 Office of Naval Research Historically Black Colleges and Universities/Minority Institutions (HBCU/MI) Program – (CFDA 12.300)

The Department of Navy (DoN) Historically Black Colleges and Universities/Minority Institutions (HBCU/MI) Program aims to increase the quantity and quality of minority professionals in science, technology, engineering, and mathematics (STEM) in the defense community. Research conducted at Minority-Serving Institutions (MSIs) for the DoN HBCU/MI Program: • Enhances the research and educational capabilities of HBCU/MIs in scientific and engineering disciplines critical to the defense mission of the DoN, • Encourages cross-institutional, collaborative participation of HBCU/MIs in naval-relevant research, development, testing, and evaluation (RDT&E), and • Increases the engagement of students, including underrepresented minorities, in STEM fields important to the defense mission. This FOA is executed under policy and guidance of the DoN HBCU/MI Program and is administered by the Office of Naval Research (ONR). This FOA seeks to support research efforts that will contribute to the science and technology (S&T) mission and vision of the U.S. Navy and the U.S. Marine Corps while simultaneously expanding the research capacity of participant institutions and engaging students in STEM. In that regard, this FOA is intended for white papers and invited proposals from HBCU/MIs exploring basic, naval-relevant research. The technical content of any idea must align with the following research areas of interest as outlined by the Naval Research Development Framework. Information, Cyber, and Spectrum Superiority An increasingly interconnected force with more rapid and effective decision-making is enabled by persistent sensing, advanced data analytics, digital integration, and assured spectrum access. In that regard, this research area spans three strategic areas: • Assured Command and Control (C2) • Electromagnetic Maneuver Warfare (EMW) • Full Spectrum Cyber technologies Assured Command and Control (C2): Assured C2 is enabled by persistent sensing, timely intelligence, and decision support tools that will accelerate "data to decisions" timelines. Leveraging machine reasoning and data analytics, an end-to-end approach achieves protected data transport, resilient networking, and assured apps and services that result in trusted information and actions. The need for increased spectral efficiency and diversity, coupled with the information domain, is critical to our naval freedom of maneuver on a global scale. Electromagnetic Maneuver Warfare (EMW): EMW efforts include electromagnetic spectrum management technologies and techniques that fluidly combine communications, surveillance electronic warfare (EW), and electronics to understand and shape the battlespace. Ultra-wide bank systems, which continuously monitor the spectrum, are needed to facilitate optimized use. Intrinsically secure and resilient computing systems with robust computational and communications architectures will provide the capability to manipulate and interpret rapidly growing amounts of data support of C2, Combat Systems (CS), and Intelligence Surveillance, and Reconnaissance (ISR) effects. Assuring secure access to the full spectrum is essential to operate at will or deny adversary access in more complex and dynamic future EMW environments. Full Spectrum Cyber technologies: Full-spectrum Cyber approaches must be developed to protect our networks, data, information systems, and real-time control systems. Total platform cyber protection is becoming an essential element of Information Warfare. Cyber technologies provide the ability to assess and counter potential threats. Future information systems must provide agile capabilities for achieving and maintaining communications and data integrity in rapidly evolving, dispersed, and disadvantaged environments. Computational architectures need more resilient information infrastructure through assured system design, automated defensive tools for advanced

persistent threats, hardening of the hosts, and data assurance. Applicable Research Interests: • Advanced RF electronics and materials • Communications and networking • Computational methods for decision making • Data science and analytics • Electronic warfare • Sensors and sensor processing • Machine learning, reasoning, and intelligence • Resource optimization • Precision navigation and timekeeping Mission Capable, Persistent, and Survivable Sea Platforms Concepts, systems, and component technologies that improve the performance and survivability of naval ships/submarines in an increasingly distributed yet interconnected force are critical. New platforms will need to deliver advanced weapons, as well as increased mobility and survivability. Power and energy for surface ships is a key, enduring investment for the efficiency of legacy platforms, while enabling the power requirements of future electric weapons. High-power electric weapons and sensors have advanced significantly, creating technical requirements for dramatic increases in energy management and pulsed power. Computational tools that model the platform's interaction with the anticipated operational environment are essential to the development of integrated designs and protections such as stealth, counter-directed energy weapons, tactical decision aids, electronic warfare, and hard-kill systems. Undersea dominance remains a priority as the Navy designs and builds the next generation of strategic and tactical submarines. Resurgence by peer adversaries in ultra-quiet submarine technology is closing the gap in undersea warfare. Platform mobility and survivability is critical to successful operational strategies calling for more distributed forces. Advancements in materials, acoustics, and intelligent control are required in addition to hydro-, electro-, and computational mechanics. Advancements in countermeasures for ships and submarines are also critical. Platforms will become more self-sustaining to extend endurance and forward presence while reducing the logistics tail for fuel. Future platforms must have reduced sustainment requirements and be easier to maintain. Efforts are focused on platform interfaces as well as platform efficiency to reduce sustainment needs. Enhanced interface standards and modularity provide flexibility, ease of maintenance, and upgrades. Finally, affordability permeates all modernization concepts. The development of validated design tools capable of rapidly and accurately analyzing and evaluating novel platforms with advanced system performance characteristics is a high priority. Applicable Research Interests: • Naval engineering • Advanced naval power systems • Advanced survivable sea platforms • Unmanned sea platforms, autonomy, and power • Advanced naval materials • Undersea weapons, counterweapons, and energetics • Sea platform environmental quality • Corrosion control Aviation, Force Projection, and Integrated Defense Sea-based aviation, including platform and weapons research, is focused on new or enhanced capabilities to defined against, and/or deter, disable, damage, defeat, or destroy adversaries at extended ranges and speeds. Offsetting technologies must continue to provide naval forces with an edge in any future battle. In the future battlespace, electric weapons with deep magazines and low cost-per-kill will be required to engage large numbers of threats simultaneously. Directed-energy systems will be used in layered defense to counter ISR capabilities, defeat or destroy threats, both before and during combat. Networked weapons will improve the probability to kill and reduce the need for multiple weapons targeting the same platform. Advanced warhead materials will decrease the size of rounds. Electromagnetic realigns will allow more, smaller, and longer-range rounds. Future naval fires efforts include targeting, decision support and precision strike by air, surface, undersea, and expeditionary forces. Improved aerodynamic control will allow unprecedented maneuverability for unconventional aircraft designs. Advanced aircraft power and propulsion technologies, such as variable-cycle advanced technology, will provide more efficient operation over a wider range of flight conditions. They will also enable technologies for providing the power and thermal management of electric weapons for next-generation aircraft. Advances in structures and materials will allow for reduced life-cycle costs as well as stronger and lighter airframes. Autonomous systems will reduce operational risk and improve mission performance. For today's missions, autonomy can improve manning effectiveness and provide options for mission tasks. For future missions, autonomy can provide new persistent, pervasive, and rapid response capabilities to do tasks that would be unaffordable or impractical today.

The intent of the PRMRP Discovery Award is to support innovative, non-incremental, high-risk/potentially high-reward research that will provide new insights, paradigms, technologies, or applications. The proposed research project should include a well-formulated, testable hypothesis based on a sound scientific rationale and study design. ONR, on behalf of the Office of the Secretary of Defense, for the Manufacturing Engineering Education Program – (CFDA 12.300)

The National Defense Authorization Act (NDAA) for Fiscal Year 2017 established the "Manufacturing Engineering Education Program," (MEEP) (Section 2196, Title 10, United States Code10 U.S.C. § 2196), which authorizes the Department of Defense (DoD) to support industry-relevant, manufacturing-focused, engineering training at United States institutions including education, industry, nonprofit, and consortia of such institutions or industry. The purpose of this program is to establish new or to enhance existing programs (or collections of programs) to better position the current and next-generation manufacturing workforce to produce military systems and components that assure technological superiority for the DoD. Interested parties should focus programs on manufacturing education to support one or more distinct manufacturing technologies of DoD interest, for example: manufacturing of lightweight structures, systems and materials; robotics for manufacturing; manufacturing to exploit nanotechnology; manufacturing of components and systems for power generation, storage, or distribution; or manufacturing of multi-functional electronics and/or optical devices. Proposed efforts should develop and enhance curricula and programs to effectively develop skills sets needed for students to operate in multidisciplinary design and manufacturing environments, including those for which manufacturing schema are informed by computational tools for modeling and simulation. Students also should be prepared to work effectively in environments where multiple engineering disciplines are engaged during design, development and manufacturing, and where the roles of manufacturers and suppliers in businesses of various sizes, from startups to major systems integrators, are optimized. Curricula and programs that develop shop-floor capabilities are also sought and may include welding; manufacturing-related programming (Computer Numerical Control (CNC), Computer Aided Design (CAD), Programmable Logic Controllers (PLC), logic, robotic control, etc.); operation and maintenance of state-of-the-art manufacturing equipment/tooling; process monitoring and optimization, and in-line quality assurance; and manufacturing, supply chain, and distribution management. The DoD, through the Office of Naval Research (ONR), seeks a broad range of consolidated and integrated multidisciplinary programs of education that encompasses the total manufacturing engineering enterprise with an emphasis on: a. Developing targeted instruction and/or curricula that covers desired manufacturing technologies and skills. b. Identifying specific opportunities for faculty and student engagement with industry, including opportunities for students to obtain relevant work experience in manufacturing through such activities as internships, summer job placements, or cooperative work-study programs. Identifying specific industrial partnership(s) and providing details of the collaboration is a critical element for any proposed program. c. Geographical diversity. Instruction that

encompasses the total manufacturing engineering enterprise may include but is not limited to the following: a. Manufacturing engineering education and training through classroom activities, laboratory activities, thesis projects, individual or team projects, internships, cooperative work-study programs, and interactions with industrial facilities, consortia, or other such activities and organizations in the United States and appropriate foreign countries; b. Faculty and teacher development programs; c. Recruitment of educators highly qualified in manufacturing engineering to teach or develop manufacturing engineering courses; d. Presentation of seminars, workshops, and training for the development of specific manufacturing engineering skills; e. Activities involving interaction between students and industry, including programs for visiting scholars or industry executives, or other personnel exchanges; f. Development of new, or updating and modification of existing, manufacturing curriculum, course offerings, and education programs; g. Establishment of programs in manufacturing workforce training; h. Establishment of joint manufacturing engineering programs with defense laboratories and depots; i. Expansion of manufacturing training and education programs and outreach for members of the armed forces, dependents and children of such members, veterans, and employees of the Department of Defense. Any proposed program or collection of programs should include quantitative assessment plans to demonstrate the increased understanding of manufacturing engineering challenges and potential solutions, and the enhanced quality and effectiveness of the instruction that result from that increased understanding.

Help America Vote Act (HAVA) Training and Technical Assistance – (CFDA 94.006)

The Administration on Intellectual and Developmental Disabilities (AIDD) in the Administration for Community Living (ACL), the U.S. Department of Health and Human Services (HHS), announces the availability of Fiscal Year (FY) 2019 funds authorized under the Help America Vote Act (HAVA) of 2002, Pub. Law 107-252, Title II, Subtitle D, Part 5, section 291 (42 United States Code (U.S.C.) 15461). Provisions under this section provide for the award of grants for Training and Technical Assistance (T/TA) to assist Protection and Advocacy Systems (P & As) in promoting full participation in the electoral process for individuals with disabilities, including registering to vote, casting a vote, and accessing polling places; developing proficiency in the use of voting systems and technologies as they affect individuals with disabilities; demonstrating and evaluating the use of such systems and technologies by individuals with disabilities (including blindness) in order to assess the availability and use of such systems and technologies for such individuals; and providing T/TA for non-visual access. (At least one recipient must provide T/TA assistance in this area.) Help America Vote Act (HAVA) programs are designed to establish and improve participation in the election process for individuals with a full range of disabilities. In each eligible state and territory, seven percent of HAVA funds are set aside for Protection and Advocacy Systems (P&As) to ensure that individuals with disabilities have the opportunity to participate in every step of the voting process. After receiving technical assistance, P&As may inform others on the availability of accessible voting equipment and its use. The funds should be used to provide Training and Technical Assistance to the P&As in their promotion of full participation in the electoral process for individuals with disabilities, including registering to vote, casting a vote, and accessing polling places.

Suicide Prevention Lifeline Crisis Center Follow-Up Expansion Grant Program – (CFDA 93.243)

The purpose of this program is to provide an integrated hub that: (1) ensures systematic follow-up of suicidal persons who contact a NSPL Crisis Center; (2) provides enhanced coordination of crisis stabilization, crisis respite, and hospital emergency department services; and (3) enhances coordination with mobile on-site crisis response. Pediatric Mental Health Care Access Program – CFDA 93.110

This notice solicits applications for the Pediatric Mental Health Care Access Program. The purpose of the Pediatric Mental Health Care Access Program is to promote behavioral health integration into pediatric primary care by supporting pediatric mental health care telehealth access programs. State or regional networks of pediatric mental health care teams will provide tele-consultation, training, technical assistance, and care coordination for pediatric primary care providers to diagnose, treat and refer children with behavioral health conditions. For purposes of this funding opportunity, telehealth is defined as the use of electronic information and telecommunication technologies to support and promote long-distance clinical consultation, patient and professional health-related education, public health and health administration. Permitted telehealth modalities between providers include (but are not limited to): real-time video, telephonic communications, store and forward of images and mobile health (mHealth) applications. For purposes of this funding opportunity, a pediatric mental health care telehealth access program for which funding may be used, shall— A. be a statewide or regional network of pediatric mental health care teams that provide support to pediatric primary care sites as an integrated team; B. support and further develop organized state or regional networks of pediatric mental health care teams to provide consultative support to pediatric primary care sites; C. conduct an assessment of critical behavioral consultation needs among pediatric providers and such providers' preferred mechanisms for receiving consultation, training, and technical assistance; D. develop an online database and communication mechanism, including telehealth, to facilitate consultation support to pediatric primary care practices; E. provide rapid statewide or regional clinical telephone or telehealth consultations when requested between the pediatric mental health care teams and pediatric primary care providers; F. conduct training and provide technical assistance to pediatric primary care providers to support the early identification, diagnosis, treatment, and referral of children with behavioral health conditions; G. provide information to pediatric providers and assist pediatric providers in accessing, pediatric mental health care providers, including child and adolescent psychiatrists, and licensed mental health professionals, such as psychologists, social workers, or mental health counselors and in scheduling and conducting technical assistance; H. assist with referrals to specialty care and community or behavioral health resources; and I. establish mechanisms for measuring and monitoring increased access to pediatric mental health care services by pediatric primary care providers and expanded capacity of pediatric primary care providers to identify, treat, and refer children with mental health problems. You must describe how your project will support the development of new or the improvement of existing statewide or regional pediatric mental health care telehealth access programs, thereby facilitating access to and availability of telehealth (including by telephone) psychiatric consultation and care coordination to pediatricians and other pediatric primary care providers. You must also describe how your project will provide training and education on the use of evidence-based, culturally and linguistically appropriate telehealth protocols to support the treatment of children and adolescents with behavioral disorders. The program will support telehealth consultation with a pediatric behavioral clinician on the team and referral to a local pediatric behavioral clinician, to the extent possible. This program will serve as a resource for pediatric primary care providers serving children and adolescents, including, but not limited to, pediatricians, family physicians, nurse practitioners, physician assistants, and care coordinators.

National Harm Reduction Technical Assistance and Syringe Services Program (SSP) Monitoring and Evaluation Funding Opportunity – (CFDA 93.488)

This three-year program will strengthen the capacity and improve the performance of harm reduction programs throughout the United States; and implement a monitoring and evaluation of syringe services programs. Grants to Support New Investigators in Addressing Cross-Cutting Violence Prevention and Opioid Overdose Prevention – (CFDA 93.136)

The National Center for Injury and Prevention Control (NCIPC) intends to provide support and 75% "protected time" for an intensive, supervised (mentored) career development experience to develop new researchers in the fields of opioid overdose prevention and cross-cutting violence prevention. The intent is to provide resources to young investigators so they can grow their skills by developing and conducting research efforts needed to address NCIPC Research Priorities (https://www.cdc.gov/injury/researchpriorities/index.html), with the potential to investigate new and emerging public health issues. Investigators focused on opioid overdose prevention must propose a research project to investigate risk factors for and strategies to prevent opioid overdose. Investigators identified in the **NCIPC** address of the research gaps Research (https://www.cdc.gov/injury/researchpriorities/index.html). Beyond the areas explicitly stated in the Research Priorities, research questions of interest to NCIPC include: How can PDMP, coroner, medical examiner, and law enforcement data be used to identify risk and protective factors for opioid overdose? What are the patterns of couse of prescription opioids and heroin, injection of opioids, and overdose? What strategies are most effective at improving use of prescription drug monitoring programs? What levers can be used to support providers and health systems in improving prescribing, pain management, and overdose response, while minimizing unintended consequences? How can public health systems be improved to support linkage to care for opioid use disorder and overdose? What public health approaches can be infused into public safety efforts and law enforcement response to improve health outcomes? How can individuals be empowered to make safer choices about opioid use? It is expected that the research could be directly translated to inform strategies being implemented by state and local health departments in addressing the opioid overdose epidemic. Investigators focused on cross-cutting violence prevention must assess multiple forms of violence impacting children or youth (i.e., child abuse and neglect, youth violence, teen dating violence and self-directed violence). Exposure to violence and other adverse childhood experiences can negatively affect health and development across the lifespan. CDC's Preventing Multiple Forms of Violence: A Strategic Vision for Connecting the Dots emphasizes the strategic importance of prevention strategies that address multiple forms of violence (https://www.cdc.gov/violenceprevention/pdf/strategic_vision.pdf). Investigators focused on preventing multiple forms of violence impacting children or youth must address at least one of the cross-cutting violence prevention identified **NCIPC** Research research gaps the **Priorities** (https://www.cdc.gov/injury/researchpriorities/index.html) in the context of children or youth. These gaps include the need to: identify modifiable factors that buffer against adversity and aggressive behavior in childhood to reduce multiple forms of violence and enhance positive health outcomes; evaluate the effectiveness and economic efficiency of policies or community-level change strategies designed to enhance the economic and social environment to reduce multiple forms of violence impacting children and youth; evaluate the effectiveness and economic efficiency of early education and support for young children and their families to prevent multiple forms of violence; evaluate the effectiveness and economic efficiency of programs, policies, and practices to enhance young people's skills and relationships that reduce their involvement in multiple forms of violence; and evaluate the effectiveness of dissemination and implementation strategies for child/youth violence prevention and assess factors that accelerate adoption of evidence-based strategies.

NIDILRR plans to make one field-initiated DRRP award in the health and function domain. NIDILRR's field-initiated DRRP award in the health and function domain may be a research project or a development project, depending on the ranking of applications provided by the peer review panel.

FY 2019 Linking Actions for Unmet Needs in Children's Health Grant Program – (CFDA 93.243)

The Substance Abuse and Mental Health Services Administration (SAMHSA), Center for Mental Health Services (CMHS), is accepting applications for fiscal year (FY) 2019 Linking Actions for Unmet Needs in Children's Health Grant Program (Short Title: Project LAUNCH). The purpose of this program is to promote the wellness of young children, from birth to 8 years of age, by addressing the social, emotional, cognitive, physical and behavioral aspects of their development. It is expected that this program will provide local communities or tribes the opportunity to disseminate effective and innovative early childhood mental health practices and services, ultimately leading to better outcomes for young children and their families. The overall goal of Project LAUNCH is to foster the healthy development and wellness of all young children (birth through age 8), preparing them to thrive in school and beyond. Project LAUNCH grants are designed to build the capacities of adult caregivers of young children to promote healthy social and emotional development; to prevent mental, emotional and behavioral disorders; and to identify and address behavioral concerns before they develop into serious emotional disturbances (SED).

Minority Aids Initiative: Substance Use Disorder Treatment for Racial/Ethnic Minority Populations at High Risk for HIV/AIDS – (CFDA 93.243)

The Substance Abuse and Mental Health Services Administration (SAMHSA), Center for Substance Abuse Treatment (CSAT), is accepting applications for fiscal year (FY) 2019 Minority AIDS Initiative - Substance Use Disorder Treatment for Racial/Ethnic Minority Populations at High-Risk for HIV/AIDS (Short Title: MAI – High Risk Populations) grants. The purpose of this program is to increase engagement in care for racial and ethnic minority individuals with substance use disorders (SUD) and/or co-occurring substance use and mental disorders (COD) who are at risk for HIV or are HIV positive that receive HIV services/treatment. According to the Centers for Disease Control and Prevention (CDC), in 2017, gay and bisexual men accounted for 66 percent of all HIV diagnoses in the United States. In the same year, individuals who were HIV infected through heterosexual sex made up 24 percent of all HIV diagnoses. The data also notes that in FY 2017 African Americans were most affected by HIV and accounted for 43 percent of all new HIV diagnoses while Hispanic/Latinos were also strongly affected and accounted for 26 percent of all new HIV diagnoses. There are also variations by age as young people aged 13 to 24 are especially affected by HIV. In 2017, young people accounted for 21 percent of all new HIV diagnoses. All young people are not equally at risk, however. Young gay and bisexual men accounted for 83 percent of all new HIV diagnoses in people aged 13 to 24 in 2017 (includes young gay and bisexual men who inject drugs), and young African American gay and bisexual men are even more impacted. MAI - High Risk Populations grants are authorized under Section 509 of the Public Health Service Act, as amended. The program aligns with SAMHSA's Strategic Plan Priority #3 "Advancing Prevention, Treatment, and Recovery Support Services for Substance Use."

<u>Implementing Evidence-Based Health Promotion Programs for Children with Attention-</u> <u>Deficit/Hyperactivity Disorder (ADHD) or Tourette Syndrome (TS) – (CFDA 93.073)</u>

The purpose of Implementing Evidence-Based Health Promotion Programs for Children with Attention-Deficit/Hyperactivity Disorder (ADHD) or Tourette Syndrome (TS) is to improve the health of people with ADHD or TS by developing and providing health communication and education resources to professionals and the public based on best evidence. Program strategies include 1) Providing Information, Consultation and Referral Services, 2) Developing and Disseminating Health Communication Programs and Materials, and 3) Developing and Delivering Health Education Programs. This award builds upon and expands previous efforts by incorporating current evidence on health communication and health education strategies, and on ADHD or TS to provide information, education, and consultation about assessment, diagnosis, treatment, health and well-being for children with ADHD or TS. The intended long-term outcomes are to promote optimal health and well-being of children with ADHD or TS by increasing awareness of available support services and evidence-based treatments for ADHD or TS among healthcare and educational professionals, and the public; knowledge about ADHD or TS among individuals who receive information or educational materials; knowledge about ADHD or TS among individuals who attend education programs; and intent to adopt health behaviors, evidence-based treatment, or educational strategies among individuals who attend education programs and individuals who receive educational materials.

Networks for Oral Health Integration within the Maternal and Child Health Safety Net – (CFDA 93.110)

This notice announces the opportunity to apply for funding under the Networks for Oral Health Integration within the Maternal and Child Health (MCH) Safety Net Program (referred to here as the NOHI Program). The purpose of this program is to improve access to and delivery of comprehensive, quality oral health care[1] for children, 0-17 years of age, by testing and establishing models of care utilizing three collective strategies: (1) enhanced integration of oral health care within MCH safety net services (Section IV, Table 1); (2) increased knowledge and skills among health care providers (including dental, non-dental clinical, and non-dental support service providers) for delivering optimal dental services; and (3) increased knowledge and awareness of preventive oral health practices among parents/caregivers to increase adoption of these behaviors including use of needed dental services. Achieving the program purpose requires testing and validating replicable models of care to integrate oral health into MCH safety net services. The MCH safety net services are comprised of providers, payment programs (e.g., Medicaid and the State Children's Health Insurance Program) and facilities that provide clinical, nonclinical and support services. A "model of care" [2] broadly defines the delivery of health services, outlining best care practices and services for a person, population group, or patient cohort as they progress through the stages of a condition, injury, or event. It aims to ensure people get the right care, at the right time, by the right team, and in the right place. The NOHI Program will provide funding to three distinct Networks that will each develop, implement, and evaluate a model of care that enables the integration of optimal oral health services within one of the MCH safety net settings specified in Table 1 (Section IV). Oral health integration in a clinical MCH safety net setting should include each of the following components: anticipatory guidance[3], oral health education to children and their families, oral health risk assessment of children or adolescents[4],[5], structured referrals for appropriate oral health services, tracking of referrals to determine receipt of needed oral health services, provision of preventive oral health services [6] by dental or non-dental personnel, and referrals for restorative dental services, if needed.

<u>Development, Implementation, and Management of a Funding System to support the Grade "A" Milk Safety Program and National Shellfish Sanitation Program (U18) – (CFDA 93.103)</u>

The objective of this FOA is the development, implementation, and management of a funding system in which State, Tribal, and Territorial Grade "A" Milk Safety and National Shellfish Sanitation regulatory programs can apply and be subawarded funds to support technical training and equipment purchases, and to improve the implementation of the Grade "A" Milk Safety Program and the National Shellfish Sanitation Program (NSSP). Funds may be awarded to up to two non-profit association/organization(s), upon which they will subsequently administer and subaward funds to State, Tribal, and Territorial regulatory agencies for facilitating improvements to and advancing the Grade "A" Milk Safety Program and the National Shellfish Sanitation Program.

Overdose Data to Action – (CFDA 93.136)

The complex and changing nature of the opioid overdose epidemic highlights the need for an interdisciplinary, comprehensive, and cohesive public health approach. States, territories, and local partners need access to complete and timely data on prescribing, and on nonfatal and fatal drug overdoses to understand the scope, direction, and contours of the epidemic. They also need the tools and resources to then use data to inform and target their prevention and response efforts. This NOFO integrates work funded through three previous CDC funding opportunities: Prescription Drug Overdose Prevention for States (CDC-RFA-CE15-1501), Data Driven Prevention Initiative (CDC-RFA-CE16-1606) and Enhanced State Surveillance of Opioid-Involved Morbidity and Mortality (CDC-RFA-CE16-1608). This three-year funding opportunity will continue work focused on: increasing comprehensiveness and timeliness of surveillance data; building state and local capacity for public health programs determined to be promising based on research evidence; making Prescription Drug Monitoring Programs (PDMPs) easier to use and access; and working with health systems, insurers, and communities to improve opioid prescribing. It adds new work focused on linkages to care and other areas of innovation supported by evidence-based practice.

Maternal Opioid Misuse (MOM) Model – (CFDA 93.687)

The Acting Secretary of the Department of Health and Human Services declared on October 26, 2017 that the opioid crisis is a nationwide public health emergency. Opioid misuse has devastating consequences for individuals, families, caregivers, states, and communities. The impact of this crisis is significant for CMS beneficiaries, who have higher rates of opioid overdose deaths and opioid misuse-related healthcare utilization relative to the privately insured. Pregnant and postpartum Medicaid beneficiaries and their infants are at particular and growing risk of harm. Substance use is now a leading cause of maternal mortality; Medicaid is the primary payer for more than 75% of maternal hospital stays related to substance use disorders; and Medicaid pays for 80% of the \$1.5 billion annual cost of caring for infants exposed in utero to substances such as opioids.

Women's HIV Epidemiology Cohort Studies (R01 Clinical Trial Not Allowed) – (CFDA 93.121)

NICHD plans to establish new epidemiology cohort(s) of least 2000 participants to stimulate research on a wide range of HIV research hypotheses pertinent to reproductive age women. The purpose of this Funding Opportunity

Announcement (FOA) is to support new and innovative epidemiology research in reproductive age women living with HIV.

Integrated Care for Kids (InCK) – (CFDA 93.378)

The Integrated Care for Kids (InCK) Model provides funding opportunities to states and local organizations to test whether payment supporting integrated service delivery across behavioral health, physical health, and other child services reduces Medicaid and Children's Health Insurance Program (CHIP) expenditures and improves the quality of care for covered children. The InCK Model will assist states and local communities in addressing priority health concerns for children, such as behavioral health challenges, including opioid and other substance use, and the effects of opioid use on families. CMS will support Awardees in developing state-specific pediatric alternative payment models (APMs) that incorporate provider accountability and focus on meaningful improvements in care quality and health outcomes. Successful Awardees will use model funding to support infrastructure investments and activities necessary to support model planning and operations including (but not limited to): state and local investments in information technology, strategic planning and analysis for model design, model operations and staffing, and federal evaluation activities.

Occupational Safety and Health Training Project Grants (T03) – (CFDA 93.262)

Research and Evaluation on Violence Against Women: Sexual Violence, Intimate Partner Violence, Stalking, and Teen Dating Violence, FY 2019 – (CFDA 16.560)

The goals of National Institute of Justice's (NIJ) Violence Against Women (VAW) program of research are to improve knowledge and understanding of intimate partner and dating violence, stalking, and sexual violence through science to best prevent and respond to these crimes. This call for proposals is tied to Department of Justice priorities related to reducing violent crime, responding to victimization, protecting police officers, and enhancing investigations and prosecution. Pre-session work involves participants completing several online instruments and reading assignments. This program is grounded in the evidence based Leadership Challenge Model© developed by James Kouzes and Barry Posner and addresses five leadership practices: (1) challenging the process, (2) inspiring a shared vision, (3) enabling others to act, (4) modeling the way, and (5) encouraging the heart. An on-line 360-degree feedback instrument assesses the participant's behavior against these five leadership practices. Other instruments, such as the Myers-Briggs Type Indicator®, DiSC Productive ConflictTM and others assess psychological type, use of power and influencing strategies, and team strategies used by course participants. Participants will prepare a dynamic leadership development plan, participate in individual developmental coaching, and during intercession periods between phases undertake action-based learning projects focused on the relevant issues in their agencies with the intention of applying skills and strategies learned in the program to build organizational capacity and manage organizational change between sessions one and two. The blended CLD series simultaneously engages all levels of agency leadership through internal action-based learning strategies at the individual, team and agency levels.

<u>Management Development for the Future (MDF) Series - Facilitation, Coaching and Training with Two</u> Agencies – (CFDA 16.601)

MDF is NIC's Management Development for the Future series, a dynamic, agency exclusive, individual and organizational development experience, which primarily targets the middle management tier of a correctional

organization. It simultaneously engages all levels of agency leadership through internal action-based learning strategies at the individual, team and agency levels. T his agency exclusive leadership development series is conducted over 12–18 months and is provided to participants within selected partner agencies. The learning strategies used in this "blended" individual and organizational development series may include, dependent upon specific partner agency need, three 24-hour (3 on-site day) classroom sessions spread out over the series, independent e-learning courses, online instructor-led sessions, online 360-degree feedback leadership assessments, reading, individual developmental coaching sessions, and the development of personal leadership development plans. Participants will prepare a dynamic leadership plan and undertake action-based learning projects focused on the relevant issues in their agencies with the intention of applying skills and strategies learned in the program to build organizational capacity and manage organizational change.

Research and Evaluation on the Administration of Justice, FY 2019 – (CFDA 16.560)

A homeless veteran is a veteran, as defined in 38 U.S.C. 101(2), who is "homeless" as that term is defined at 42 U.S.C. 11302(a)-(b), as amended by the Homeless Emergency Assistance and Rapid Transition to Housing Act of 2009 (Public Law 111-22). Stand Down grant funds must be used to enhance employment and training opportunities or to promote the self-sufficiency of homeless veterans through paid work. Veterans experiencing homelessness do not always have access to basic hygiene supplies necessary to maintain their health and appearance. Lack of shelter limits their ability to prepare for and present themselves at job interviews or be contacted for follow-up. Basic services such as showers, haircuts, attention to health concerns, and other collaborative services provided at SD events can give participants a greater sense of self and an opportunity to improve their chances of securing and maintaining employment Each year, VETS sets funds aside from the Homeless Veterans' Reintegration Program (HVRP) budget activity to award SD grants. Stand Down funding is a non-competitive grant awarded on a first-come, first-served basis until available annual funding is exhausted. VETS will continue to accept applications and process when additional funds become available. The maximum amount that can be awarded, per applicant for a geographic area, in a fiscal year (October 1 – September 30) is \$7,000 for a one-day event and \$10,000 for a multi-day event. - Be a tax-exempt, nonprofit public charity classified under Section 501(c)(3) of the U.S. Internal Revenue Code OR a registered charity in Canada with a Canada Revenue Agency Number, or registered as a provincial nonprofit society OR a public education institution or government entity qualified under Section 170(c)(1) of the U.S. Internal Revenue Code or qualified as a Canadian municipality.

Wells Fargo Corporate Giving Programs

Wells Fargo supports nonprofit organizations that work on a community level in the areas of human services, arts and culture, community development, civic responsibility, education, environmental consciousness, and volunteerism.

Deadline: Applications accepted on an ongoing basis.

Good Sports Accepting Applications for Sports Equipment Grant

Good Sports helps lay the foundation for healthy, active lifestyles by providing athletic equipment, footwear, and apparel to disadvantaged young people nationwide. By working closely with teams, coaches, and community leaders across the United States, the organization is able to focus on the respective needs of each individual program and help offset the main factors causing the greatest challenges.

Good Sports is accepting applications from organizations and schools for equipment, apparel, and footwear for a wide range of sports. Organizations that are approved will have access to equipment, apparel, and footwear inventory for a two-year period. During that time, organizations can make up to six separate donation requests — as long as need is well documented, donations will be granted. There is no need to resubmit a full application again during the two-year period.

To be eligible, applicants must directly serve youth between the ages of 3 and 18; serve youth in an economically disadvantaged area; be located in North America (the U.S. and Canada); and operate an organized sport, recreational activity, or fitness program that offers consistent and structured opportunity for play to large groups of children. Schools must apply as a whole; applications for individual programs within a school will not be considered. Donation requests for short-term events such as sports camps and tournaments or to individual athletes will not be considered.

While the equipment, apparel, and footwear received through the program are free, recipients are expected to pay shipping and handling costs, which amount to roughly 10 percent of the donation value, with a maximum fee of \$1,500.

Deadline: Applications are reviewed on a rolling basis. It is recommended, however, that organizations apply at least eight weeks prior to the start of their particular season or program to ensure the desired equipment can be accessed and shipped on time.

Karma for Cara Foundation Invites Applications for Youth Microgrants

The Karma for Cara Foundation is a nonprofit founded by 21-year-old Cara Becker and her family while she was undergoing treatment for leukemia at the Johns Hopkins Kimmel Cancer Center. Cara and her two brothers began volunteering at a young age as part of their family's commitment to community service. She and her family saw a tremendous need to help support other patients and their families who were also challenged by cancer. Tragically, Cara passed four months after her diagnosis, yet her wish to help others through K4C lives on with the support of an ever-growing circle of family and friends.

As part of an effort to promote and support youth voluntarism, k4C started a microgrant program in fall 2014 to encourage kids 18 and under to apply for a grant of between \$250 and \$1,000 to complete service projects in their communities. Examples of fundable projects include but are not limited to turning a vacant lot into a community garden, rebuilding a school playground, and helping senior citizens get their homes ready for winter. Grants will be distributed as gift cards to home goods stores, office supply stores, grocery food chains, and toy stores.

VFW Accepting Applications From Veterans for Emergency Financial Assistance

Veterans of Foreign Wars is accepting applications from active and discharged military service members who have been deployed in the last six years and have run into unexpected financial difficulties as a result of deployment or other military-related activity. Since the program's inception, Unmet Needs has distributed more than \$5 million in assistance to qualified military families, with nearly half of those funds going directly toward basic housing needs.

The hardship must be the result of deployment, a military pay issue, or military-related illness or injury. It cannot be due to civil legal or domestic issues, misconduct, or any issues that are a result of spousal separation or divorce, financial mismanagement, or bankruptcy.

Start a Snowball Invites Applications for Youth Philanthropy Projects

Start a Snowball, Inc. encourages kids of all ages to engage in philanthropic and community service activities. The organization believes that even one child with the right intentions and support can start a project that seems small in the beginning and eventually grows ("snowballs") into something that inspires and benefits an entire community.

In order to help kids kick off their philanthropy efforts, Start a Snowball awards \$100 in seed funding for projects taken on by individuals or organizations.

To be eligible, projects must be led by youth between the ages of 5 and 18 and have the intention of doing good.

Start a Snowball does not give directly to collection funds. The organization also does not provide support for fundraisers for sports teams, unless they serve an underserved or disadvantaged group, or support projects that are discriminatory or political in nature.

Deadline: Rolling

Craft Emergency Relief Fund Accepting Applications From Craftspeople in Need

The Craft Emergency Relief Fund is a national nonprofit organization that awards small grants and loans to professional craftspeople experiencing career-threatening illness, accident, fire, theft, or natural disaster.

Financial assistance ranges from \$500 to \$8,000. Other services include referrals to craft suppliers who have agreed to offer discounts on materials and equipment to craftspeople eligible for CERF funds and booth fee waivers from specific craft show producers.

CERF loan recipients are expected to repay the loan in full within five years, enabling CERF to have funds readily available for future craftspeople in need.

Applicants must be a professional artist working in a craft discipline (e.g., a potter, metalsmith, glass artist, woodworker, fiber artist, or furniture maker) who has had a recent career-threatening emergency and a legal resident of the U.S.

Pollock-Krasner Foundation Accepting Applications From Artists With Financial Need

The mission of the Pollock-Krasner Foundation is to aid those individuals who have worked as artists over a significant period of time. The foundation's dual criteria for grants are recognizable artistic merit and financial need, whether professional, personal, or both.

Grants are intended for a one-year period of time, with the size of the grant to be determined by the artist's individual circumstances and professional exhibition history. Artists applying for a grant must be actively exhibiting their current work in a professional artistic venue such as a gallery or museum space.

The foundation does not accept applications from commercial artists, video artists, performance artists, filmmakers, crafts-makers, computer artists, or any artist whose work primarily falls into these categories.

Pollination Project Invites Applications From Social Entrepreneurs for Seed Grants

The Pollination Project is accepting applications from social entrepreneurs looking to make their communities and world a better place. Seed grants of up to \$1,000 will be awarded to projects in the early stages of development, including those that promote compassion toward all life (people, planet, animals), environmental sustainability, justice in all its forms, community health and wellness, and social change-oriented arts and culture. Only applications for seed funding, as opposed to ongoing operational or program costs of a nonprofit organization, will be accepted. To be eligible, applicants must be a passionate, committed individual with a social change vision that fits within one or more of the categories above. Established nonprofit organizations with paid staff will not be considered.

Hope for The Warriors Accepting Applications for Critical Care Support for Wounded Veterans

Hope For The Warriors believes those touched by military service can succeed at home by restoring their sense of self, family, and hope. Nationally, the organization provides service members, veterans, and military families with comprehensive support programs focused on transition, health and wellness, peer engagement, and community resources.

Originally designed to meet short-term needs in the days following an injury, the Hope for The Warriors' Critical Care Coordination program has expanded to assist post-9/11 combat-wounded veterans and their families as they navigate through long-term recovery.

Program case coordinators work daily with post-9/11 combat-wounded service members and veterans, their families, and families of the fallen to meet immediate financial needs related to daily living including utilities, groceries, rent, mortgage, and rental deposits. The program provides casework assistance and resource referrals that will help clients immediately and in the future. Payment is always made to a third party.

To be eligible, applicants must be seeking support for needs that are a direct result of a service member's post-9/11 combat-related injury.

Singing for Change Accepting LOIs for Projects to Address Social and Environmental Problems

Created by Jimmy Buffett in 1995, Singing for Change initially was funded with contributions from the singer's summer concert tour. Since then, SFC has offered competitive grants to progressive nonprofit organizations working to address the root causes of social or environmental problems.

Priority will be given to organizations that keep their overhead low, include community members in planning, and collaborate with other groups to find innovative ways of solving common problems. SFC aims to advance the common good by empowering people to thrive and strengthen and sustain vibrant, diverse communities.

Grants will range in size from \$1,000 to \$10,000. Grants are made only to nonprofit organizations with tax-exempt status under section 501(c)(3) of the Internal Revenue Code, or to organizations that have a sponsoring agency with exempt status.

Deadline: Ongoing

A Little Hope Announces Youth Bereavement Support Services Grants

A Little HOPE supports organizations that provide bereavement support services and grief counseling to children and teens who have experienced the death of a parent, sibling, or loved one.

To be considered, applicants must e-mail (no telephone calls) the name of their program, website address, names of the executive director and program director, and the location of the program. No other information is needed or will be processed. Strong preference will be given to applicants who demonstrate a commitment to the use of community trained volunteers. Grant award amounts are based on the scope and budget of the project.

Captain Planet Foundation Offers Grants for Hands-On Environmental Education Activities

The mission of the Captain Planet Foundation is to promote and support high-quality educational programs that help children and youth understand and appreciate our world through hands-on learning experiences aimed at improving the environment in their schools and communities.

Grants are intended to serve as a means of bringing environment-based education to schools and inspiring youth and communities to participate in community service through environmental stewardship activities. The

foundation will fund unique and innovative projects that do not precisely match the grant guidelines but otherwise promote the foundation's mission to advance hands-on environmental activities.

Deadline: January 31 (typically for fall and winter projects), September 30 (typically for spring and summer projects)

Chambers of Commerce Invited to Start Young Entrepreneur Academies

The Young Entrepreneurs Academy today serves thousands of students across America. In 2011, the United States Chamber of Commerce Foundation became a national sponsor and partner of the academy to help celebrate the spirit of enterprise among today's youth and the future leaders of tomorrow.

To that end, YEA, in partnership with Sam's Club and the U.S. Chamber of Commerce Foundation, is accepting applications from chambers of commerce across the country to start Young Entrepreneurs academies of their own. The thirty-week program teaches students in grades 6-12 how to generate business ideas, conduct market research, write business plans, pitch to a panel of investors, and launch their own companies. In 2015, Sam's Club will award startup funds of up to \$2,500 each to thirty chambers of commerce across the country.

Cornell Douglas Foundation Grant

One-year grants of up to \$20,000 will be awarded to nonprofit grassroots community-organizing groups in the United States working to further social and environmental justice and support sustainable and just-food systems. Grants can be used to support both program and operational costs.

KaBOOM!, a program that provides eligible communities with most of the funds, tools, and resources they need to build a custom-made playground in one day.



Alabama Additional Funding Sources

Community Foundations in Alabama

There are 13 community foundations in Alabama, covering 78 percent of the counties in the state and holding assets that total more than \$190 million.

Daniel Foundation

The Daniel Foundation offers grants in four program areas: Civic and Community Improvement, Education, Health, and Arts and Culture. Applications are limited to 501 (c)(3) organization that are located in Alabama.

Alabama Power Foundation

The Alabama Power Foundation allocates funding in four categories: Improving Education, Strengthening Communities, Promoting Arts and Culture, and Restoring and Enhancing the Environment.

Alabama Humanities Foundation

The AHF awards grants solely to support public humanities projects. Active public participation, involvement of humanities scholars, and strong humanities content are the three essential components of AHF-funded projects.

Gwyn Turner Endowed Fund

The fund is administered by the National Trust for Historic Preservation, in partnership with Alabama Trust for Historic Preservation. Nonprofits and governmental agencies can obtain funding for preservation planning, heritage education, workshops, conferences and special interventions. Grants range from \$1,000 to \$5,000 and require a 1:1 cash match.

Sybil H. Smith Trust

Alabama State Council on the Arts

Grants awarded to nonprofit organizations and local governments in the following categories: Presenting Grants, Project Assistance, Operating Support, Technical Assistance, Collaborative Ventures, and Program Development.

Historic Chattahoochee Commission

The Historic Chattahoochee Commission (HCC) promotes tourism and historic preservation in the Chattahoochee Trace, an 18-county region in Alabama and Georgia. The HCC supports preservation through two grant programs: Seed Grant and the Threatened Landmarks Program.

The online Veterans Employment Center is the single federal source for Veterans looking for new career opportunities in the private and public sectors, as well as Service Members transitioning to the civilian workforce, military and Veteran spouses and dependents looking for employment opportunities, GI Bill beneficiaries transitioning from training to the job market and employers looking to connect with high quality applicants. It is the first interagency tool that brings together public and private job opportunities with resume building and other career tools currently offered on a variety of websites together in one place.

Through the online Veterans Employment Center, Veterans, transitioning Service Members and spouses are connected to high quality career choices by matching their identified skills with available public and private job opportunities. The site is built using an open application programming interface (API) to attract private sector innovation.

In connection with the First Lady and Dr. Biden's Joining Forces initiative, the Department of Veterans Affairs worked with the Departments of Defense, Labor, and Education, and the Office of Personnel Management to design and develop the site and incorporate features of existing online employment tools at each agency. The result is an upgrade to the existing Veterans Job Bank and an integrated solution connecting Veterans, transitioning Service Members and employers.

Employers, Veterans and transitioning Service Members deserve a single, authoritative source for connecting to each other. Now that the core tools and an integrated search function exist in one single location, each agency is engaged in minimizing duplication and redundancy of current sites and services.
