# Rep. Sewell Commends Alabama NeighborWorks Grant Recipients

May 17, 2017

#### CSP of West Alabama and NHS of Birmingham receive over \$250,000 in grants

**Washington, D.C.** – On Tuesday, May 16, 2017, NeighborWorks America, a congressionally chartered nonprofit committed to expanding affordable housing and community development, announced new grant awards to the Community Service Programs (CSP) of West Alabama, Inc. and Neighborhood Housing Services (NHS) of Birmingham, Inc. NeighborWorks awarded CSP a grant of \$170,500 and NHS a grant of \$111,500. Congresswoman Terri A. Sewell (D-AL) releases the following statement commending the two organizations:

"Home ownership is a point of pride, security, and stability for individuals and their families. It is a key component to achieving the American dream," said Rep. Sewell. "The grants announced this week by NeighborWorks America are going to two local organizations that have helped to provide people in our communities with access to decent, safe and affordable housing for decades. For families struggling to make ends meet, their support is indispensable. NeighborWorks' investment in Alabama is going to give families in my district a shot at building a life they otherwise would not have access to."

In fiscal year 2016, NeighborWorks America leveraged \$91 dollars of other investments for every \$1 of appropriated grants provided to the organization – resulting in a direct investment of \$7.1 billion in communities across the country. That year, the NeighborWorks network assisted over 360,000 families and helped to create 21,000 new homeowners.

## Representative Sewell is Vice Chair of Commission on Protecting American Democracy from the Trump Administration

May 25, 2017

DNC launches group in response to Presidential Advisory Commission on Election Integrity

**Washington, D.C.** – Today, the Democratic National Committee (DNC) announced the launch of the Commission on Protecting American Democracy from the Trump Administration. The group will investigate voter suppression, the "voter fraud" myth, and strategies for modernizing the voting process to provide more Americans better access to the polls. The new Commission comes in response to the Trump Administration's Presidential Advisory Commission on Election Integrity.

"When it comes to protecting voting rights for all Americans, we cannot trust the Trump Administration to get the facts right," said Rep. Sewell. "Time after time, President Trump has chosen to recite baseless 'voter fraud' claims rather than taking on real issues like voter suppression. Our Commission will document and report on today's wave of voter suppression tactics and provide recommendations for strengthening access to the polls for all Americans. One person, one vote is a fundamental principle of our democracy, and I am proud to be part of a Commission that seeks to protect and advance voting rights."

The Commission will work to discredit the Presidential Advisory Commission on Voter Fraud by debunking the myth of widespread voter fraud in America and demonstrating the difficulty of voting in areas affected by voter suppression. The Commission will also highlight and promote best practices for making voting easier and dismantling obstacles to casting a ballot.

Jason Kander, President of Let America Vote and former Missouri Secretary of State, will chair the Commission with Congresswoman Terri Sewell (D-AL) serving as Vice-Chair. Members of Congress and state and local elected officials also join the Commission to offer diverse experience in legislating to protect voting rights and administering fair and accessible elections.

# Sewell Statement on FBI Director Comey's Dismissal

May 9, 2017

#### Trump fires FBI Director amidst active investigation into Russia ties

**Washington, D.C.** – Today, FBI Director James Comey was fired by President Donald Trump, whose campaign associates were under investigation by the FBI for their ties to Russian officials. Congresswoman Terri A. Sewell (D-AL), who sits on the House Permanent Select Committee on Intelligence releases the following statement:

"For any American concerned about the integrity of our democracy, President Trump's decision to fire the man leading an investigation into his campaign's ties to Russia should set off an alarm," said Rep. Sewell. "Our national security is at stake, and President Trump has disempowered the central investigative body leading an inquiry into the matter. In order to get to the bottom of Russia's attack on our election, we must appoint an independent prosecutor who can restore faith in this investigation. No amount of interference from the White House can put this issue to rest for the American people, only a thorough, independent investigation can do that."

### **Sewell Statement on "Voter Fraud" Commission**

May 11, 2017

Under the guise of a fake problem, new commission lays the foundation for voter suppression

**Washington, D.C.** – Today, President Trump signed an executive order creating a commission to examine cases of voter fraud in American elections. Despite an <u>absence of any evidence</u> demonstrating widespread voter fraud in American elections, President Trump has <u>falsely and repeatedly</u> claimed that millions of ineligible voters cast ballots in the 2016 presidential election. Congresswoman Terri A. Sewell (D-AL) releases the following statement:

"Donald Trump has done more to undermine the legitimacy of our democracy than any president in recent history," said Rep. Sewell. "Today's executive order uses a fake issue to cast doubt on the integrity of our elections all while laying the foundation for laws that disenfranchise our nation's minority voters. If President Trump is truly interested in strengthening the security of our democracy, his first priority should be to ensure that our elections are protected from Russian interference. That is an issue founded on real evidence confirmed by 17 of our nation's intelligence agencies. If this President wants to protect that sanctity of our vote, he should support an investigation into voter suppression tactics and work with Congress to restore the Voting Rights Act (VRA). But instead, President Trump has chosen to funnel our taxpayer dollars into a sham commission that confirms his worst biases."

On March 8, 2017, Reps. Elijah Cummings, Terri Sewell, Derek Kilmer, and 51 other House Democrats sent <u>a letter</u> to Vice President Mike Pence urging the Administration to investigate voter suppression as part of any investigation into voting irregularities in the 2016 elections.

Rep. Sewell has repeatedly urged the Administration to <u>stop offering false information</u> on voter fraud and to refocus its efforts <u>on preventing voter suppression</u>. Millions of eligible voters, including an estimated <u>250,000 Alabamians</u>, do not have the required identification to vote in elections where strict ID laws are present.

# Rep. Sewell Statement on DOJ Special Counsel Appointment

May 17, 2017

#### DOJ appoints special counsel to lead investigation of Russian election interference

**Washington, D.C.** – On Tuesday, the Department of Justice (DOJ) announced the appointment of Robert Mueller as special counsel to investigate Russian interference in the 2016 election and possible ties between Russian officials and U.S. persons. Congresswoman Terri A. Sewell releases the following statement:

"The appointment of a special counsel to lead an investigation is an important step forward. Robert Meuller is a respected legal mind who knows our intelligence community and has earned the trust of lawmakers from both parties. I hope that his leadership will help restore the public's confidence that Russia's attack on our elections will be investigated thoroughly and independently."

"The appointment of Robert Mueller as special counsel in no way eliminates the need for a thorough investigation by the House Intelligence Committee. As a Member of that Committee, I will continue my work to get to the bottom of Russia's attack by following the facts wherever they lead. I believe that the House Intelligence Committee will also have a role in ensuring that the new special counsel receives whatever resources he needs to conduct a full investigation."

### Rep. Sewell Statement on Trump Budget

May 23, 2017

#### Budget slashes funding for safety net, healthcare, education, agriculture

**Washington, D.C.** – Today, the President released a 2018 budget proposal with massive cuts to social safety-net programs, science, agricultural, and other institutions vital to Alabama communities. Congresswoman Terri A. Sewell (D-AL) releases the following statement:

"President Trump's budget takes aim at working families, rural Americans, the disabled, underserved communities, and those who struggle to make their voices heard in our democracy," said Rep. Sewell. "Leaving those Americans behind is not only a failure in compassion, it is utterly short-sighted when it comes to growing our economy and making America competitive. In areas like healthcare, education, agriculture, and research, Trump's budget will have devastating consequences for Alabama. What makes our country great is our willingness to extend a hand up to those who need it most, and that's a value which Trump's budget cuts."

Over the next decade, President Trump's budget would slash more than \$1.4 trillion from Medicaid, a health program covering nearly 70 million Americans. The budget also cuts \$192 billion from nutritional assistance, and \$72 billion from disability benefits, and would eliminate loan programs which subsidize college education for low-income families. Trump's proposal would cut funding for the National Institutes of Health (NIH) by more than \$5 billion. Federally subsidized crop insurance would face a 36 percent cut, and President Trump's budget proposes elimination of USDA's rural economic development program and defunds the Delta Regional Authority and the Appalachian Regional Commission.

### Rep. Sewell on Testimony of Former CIA Director Brennan

May 23, 2017

#### House Intelligence Committee holds open hearing with Brennan

**Washington, D.C.** – Today, the House Intelligence Committee held a public hearing featuring former CIA Director Brennan as part of the Committee's Russia investigation. Congresswoman Terri A. Sewell (D-AL) is a member of the House Intelligence Committee and questioned Brennan on Russia's disinformation campaign and the work of Russian officials to undermine American democratic institutions.

"In today's hearing, former CIA Director Brennan was unequivocal in his statement that members of the Trump campaign had contact with Russian officials who undermined our elections and that this issue deserves a full investigation," said Rep. Sewell. "As a Member of the House Intelligence Committee, I am committed to following the facts and getting to the truth. When we lose sight of the truth and the evidence provided by our intelligence community, our democracy and our national security are put at risk."

## On Foster Youth Shadow Day, Rep. Sewell Hosts Birmingham Youth

May 24, 2017

Shadow day connects youth from foster system with Members of Congress

Washington, D.C. – On Wednesday, Congresswoman Terri Sewell (D-AL) participated in Foster Youth Shadow Day, hosting Khadejah Moore from Birmingham. The Congressional Foster Youth Shadow Program gives young people who have interacted with the foster care system the chance to follow a Member of Congress for the day, learning about representative government while sharing their understanding and experiences from foster care with Members.

"This Foster Care Month, I am recognizing the more than 400,000 children in our foster care system as well as the families, caregivers, and community organizations who work so hard to provide them with loving, stable homes," said Rep. Sewell. "Here



in Congress, we must continue our work to strengthen the foster care system to ensure that it provides safety, permanency, and wellbeing for children in need. The young people visiting the Capitol this Wednesday were able to share an important perspective on how we can work to build a better foster care system that supports one of our nation's most vulnerable groups."

Khadejah Moore is from Birmingham, Alabama. She lived for five years in the foster care system. Through the help of her foster family, Khadejah was able to graduate high school in the top ten percent of her class with an advanced diploma. In May of 2017, Khadejah graduated cum laude from Alabama State University, an HBCU in Montgomery, Alabama.

Rep. Sewell is a member of the bipartisan Congressional Caucus on Foster Youth, which brings Members of Congress together to discuss the challenges facing foster youth and develop bipartisan policy initiatives. In 2016, Rep. Sewell hosted a child welfare listening tour in order to learn about issues facing foster youth in Alabama, including the impact of substance abuse on foster youth families, the court system, and how preventive services can help keep families together.

Rep. Sewell is also a cosponsor of the Family First Prevention Services Act (H.R. 258), a bill to strengthen families by providing evidence-based prevention services to reduce unnecessary foster care placements.

### Rep. Sewell on CBO Score: Trumpcare Will Cost Lives

May 24, 2017

#### New CBO score shows Trumpcare eliminates coverage for 23 million Americans

**Washington, D.C.** – Today, the Congressional Budget Office (CBO) released a report showing that the healthcare repeal bill which passed the House this May would eliminate healthcare coverage for 23 million Americans. For sick patients in states which waive essential health requirements, CBO predicts that healthcare coverage could become unaffordable and likely unattainable. Congresswoman Terri A. Sewell (D-AL) releases the following statement:

"Today's new score from the CBO confirms that Trumpcare still contains the same terrible policies that have mobilized Americans nationwide against the GOP healthcare repeal bill," said Rep. Sewell. "This bill remains a bad deal for Alabamians – eliminating coverage for 23 million Americans, cutting Medicaid by \$834 billion and penalizing older Americans and those with pre-existing conditions. That is a lose-lose proposition for the American people."

"Make no mistake, a bill that kicks 23 million people off of insurance will cost lives. Our access to affordable care is a fundamental right, not a privilege, and I will continue to oppose any legislation that takes that right away from millions of Americans."

### Statement from Rep. Sewell in Observance of Memorial Day

May 30, 2017

**Birmingham**, AL – As America prepares on Memorial Day to pay tribute to the brave men and woman who laid down their lives in defense of this country, Rep. Terri A. Sewell (D-AL) releases the following statement recognizing their sacrifices:

"On this Memorial Day, we once again recognize and pay tribute to the incredible dedication and bravery of men and women who chose to defend our country, and in doing so, gave their lives in order to uphold the freedoms we all enjoy. We as Americans owe our continued liberty and independence to these men and women who made the ultimate sacrifice on the battlefield. As festivities commence this Memorial Day, it is important that we remember how extraordinary our Armed Forces are in maintaining our great democracy.

"Let us also never forget the families that mourn the loss of loved ones and those who have returned home yet face ongoing challenges. #### **National Endowment for the Arts**

These grants support projects that include: opportunities for artists to create, refine, perform, and exhibit their work; the presentation of artistic works of all cultures and periods; opportunities for arts organizations and artists to expand and diversify their audiences; innovative uses of new models or technology to create work or engage audiences; the preservation of significant works of art and cultural traditions; innovative creative placemaking that contributes to community livability; opportunities for individuals to experience and participate in a wide range of art forms and activities; opportunities to enhance the effectiveness of arts organizations and artists; development, production and national distribution of innovative media projects about the arts and of media projects that can be considered art; standards-based arts education activities for K-12 students and lifelong learning in the arts for individuals of all ages. #### **National Endowment for the Humanities**

<u>Humanities Initiatives at Historically Black Colleges and Universities, Tribal</u> Colleges and Universities, and Hispanic Serving Institutions – *(CFDA 45.162)* 

NEH Humanities Initiatives at Historically Black Colleges and Universities, Hispanic-Serving Institutions, and Tribal Colleges and Universities are intended to strengthen the teaching and study of the humanities, in subjects such as history, philosophy, literature, religion, and the interpretation of the arts. These grants may be used to enhance existing humanities programs, resources, or courses, or to develop new ones. Applicants are encouraged to draw on the knowledge of outside scholars who would contribute expertise and fresh insights to the project. Each project must be organized around a core topic or set of themes.

#### **Humanities Collections and Reference Resources – (CFDA 45.149)**

The Humanities Collections and Reference Resources (HCRR) program supports projects that provide an essential underpinning for scholarship, education, and public programming in the humanities. Thousands of libraries, archives, museums, and historical organizations across the country maintain important collections of books and manuscripts, photographs, sound recordings and moving images, archaeological and ethnographic artifacts, art and material culture, and digital objects. Funding from this program strengthens efforts to extend the life of such materials and make their intellectual content widely accessible, often through the use of digital technology. Awards are also made to create various reference resources that facilitate use of cultural materials,

from works that provide basic information quickly to tools that synthesize and codify knowledge of a subject for in-depth investigation.

HCRR offers two kinds of awards: 1) for implementation and 2) for planning, assessment, and pilot efforts (*HCRR Foundations* grants).

#### **National Science Foundation**

#### Towards a Leadership-Class Computing Facility – Phase 1 – (CFDA 47.070)

NSF invites proposals for the acquisition and deployment of a High Performance Computing (HPC) system, called the Phase 1 system, with the option of a possible future upgrade to a leadership-class computing facility. The Phase 1 system will serve two important and complementary purposes:

- It will serve as a robust, well-balanced, and forward-looking computational asset for a broad range of research topics for which advances in fundamental understanding require the most extreme computational and data analysis capabilities; and
- It will serve as an evaluation platform for testing and demonstrating the feasibility of an upgrade to a leadership-class facility five years following deployment

A competitive proposal in response to this solicitation will have the following five characteristics:

- A detailed acquisition plan for deploying a reliable and well-balanced HPC system with at least two- to
  three-fold time-to-solution performance improvement over the current state of the art, the University of
  Illinois at Urbana-Champaign's (UIUC) <u>Blue Waters</u> system, for a broad range of existing and emerging
  computational and data intensive applications;
- A thorough operations plan for the Phase 1 system to ensure that it will serve as an effective computational tool for the broad scientific and engineering community, and for the Nation at large;
- A detailed three- to five-year project plan for scientific and technical evaluation of the Phase 1 system that will lead to an upgrade design of a leadership-class system, called the Phase 2 system, as well as the physical facility that will host it: the Phase 2 system is expected to have a ten-fold or more time-to-solution performance improvement over the Phase 1 system;
- Clear and compelling science and engineering use cases, as well as detailed strategic project goals for a leadership-class computing facility; and
- A persuasive articulation of educational and industry outreach, and the achievement of other broader societal impact goals, in the long-term strategic plan for the leadership-class computing facility.

Note that the award of a Phase 1 system does not imply any commitment beyond support for beginning the initial planning process for a leadership-class computing facility. The facility planning process may be terminated at any time if satisfactory progress is not demonstrated through annual reviews.

#### **Cybermanufacturing Systems**

There is an opportunity for researchers to pursue research and educational efforts to accelerate the creation of an interoperating, cross-process manufacturing service layer that enables the rapid, bottom-up transformation of access to manufacturing services. Such a service layer can allow creative entrepreneurs and companies to both furnish and access manufacturing apps that span the full spectrum from ideation to physical realization, giving rise to an era of cybermanufacturing. The cybermanufacturing service layer differs from existing Internet services in that it needs an architecture that can incrementally incorporate and organize the rich and deep semantic elements of manufacturing knowledge, requiring an almost unlimited capacity to expand the range and depth of content contributed in the form of partitioned, but interoperating, manufacturing applications.

Deadline: OPEN.

#### Historically Black Colleges and Universities - Undergraduate Program

To meet the nation's accelerating demands for STEM talent, more rapid gains in achievement and successful degree completion in STEM for underrepresented minority populations are needed. The Historically Black Colleges and Universities Undergraduate Program (HBCU-UP) is committed to enhancing the quality of undergraduate STEM education and research at HBCUs as a means to broaden participation in the nation's STEM workforce. To this end, HBCU-UP provides awards to develop, implement, and study evidence-based innovative models and approaches for improving the preparation and success of HBCU undergraduate students so that they may pursue STEM graduate programs and/or careers.

#### **U.S. Small Business Administration**

#### 7(j) Technical Assistance – (CFDA 59.007)

The purpose of the program is to provide Business Development Assistance for Small Disadvantaged Businesses. SBA performs this mission by entering into grants, cooperative agreements and contracts with qualified service providers who have the capability to provide business development assistance to eligible businesses and individuals under Sections 7(i), 7(j) and 8(a) of the Small Business Act. #### U.S. Department of Agriculture

#### Mobile Technology for CN Innovation Laboratory – (CFDA 10.538)

This is an announcement is subject to the availability of funds for one new cooperative agreement for FY 2017-2020 with a public or private Academic or Research Institution. The USDA anticipates awarding up to \$1.5 million in grant funding to support the creation of a Mobile Technology for Child Nutrition Research

Innovation Laboratory. This "lab" will support the development, testing and implementation of innovative mobile technology-based solutions to improve services, effectiveness, participation, and customer satisfaction in the Child Nutrition (CN) programs through subgrants. Subgrantees may include partnerships between State and local programs, researchers, and small businesses that are well-positioned to develop and test the effectiveness of novel mobile applications for consideration and eventual use by FNS and State agencies. FNS has a particular interest in mobile technology solutions that integrate behavioral economic approaches in their design. Mobile applications developed under this grant should support the activities of those who administer Child Nutrition programs and/or improve service delivery for program participants.

#### <u>Rural Microentrepreneur Assistance Program – (CFDA 10.870)</u>

Provide rural microentrepreneurs with the skills necessary to establish new rural microenterprises and to provide continuing technical and financial assistance related to the successful operation of rural microenterprises. (1) Make direct loans to Microenterprise Development Organizations (MDO), which may be a non-profit entity, Indian Tribe or public institution of higher education for the purpose of capitalizing microloan revolving funds to provide fixed interest rate business loans of the lesser of \$50,000 or 20 percent of the amount loaned to an MDO for startup and growing rural microenterprises. The maximum loan amount an MDO may borrower under this program will not exceed \$500,000. (2) Make grants to MDOs to support rural microenterprise development. These grants are known as operational enhancement activities or services grants. These grants will be used to seek training and other enhancement services to strengthen their own organizations. These grants will not exceed 10 percent of available funding, whichever is less in any given year. (3) Any MDO that receives a loan under this program is eligible for a grant to assist microentrepreneurs who have received or are seeking a microloan from an MDO. These grants are known as technical assistance (TA) grants and may be used by an MDO to provide marketing, management, and other technical assistance to microentrepreneurs. TA grants will provide assistance specifically tailored to the needs of one or more microentrepreneurs.

#### <u>Rural Economic Development Loans and Grants – (CFDA 10.854)</u>

To promote rural economic development and job creation projects, including funding for project feasibility studies, start-up costs, incubator projects, and other reasonable expenses for the purpose of fostering rural development.

**Applicant Eligibility:** Electric and telephone utilities that have current loans with the Rural Utilities Service (RUS), Rural Telephone Bank loans, or guarantees outstanding and are not delinquent on any Federal debt or in bankruptcy proceedings.

Beneficiary Eligibility: Rural/General Public.

**Deadlines:** Contact the headquarters or regional office, as appropriate, for application deadlines.

#### Rural Business Opportunity Grants – (CFDA 10.773)

To promote sustainable economic development in rural communities with exceptional needs. Grant funds may be used to assist in the economic development of rural areas by providing technical assistance, training, and planning for business and economic development.

**Applicant Eligibility:** Grants may be made to public bodies, nonprofit corporations, Federally-Recognized Native American Tribes, and cooperatives with members that are primarily rural residents and that conduct activities for the mutual benefit of the members.

**Beneficiary Eligibility:** Rural communities and businesses in rural areas.

**Deadlines:** Contact the headquarters or regional office, as appropriate, for application deadlines.

#### Rural Cooperative Development Grants - (CFDA 10.771)

To improve the economic condition of rural areas by assisting individuals and businesses in the startup, expansion or operational improvement of rural cooperatives and other mutually-owned businesses through Cooperative Development Centers.

Funds must be used to provide technical assistance to individuals and businesses in rural areas for the purpose of cooperative development. Funds must be used for cooperative development, although limited use of funds for assistance to other business types may be allowed at the Agency's discretion. All available funds are discretionary funds and must be awarded through a national competition.

**Deadlines:** Contact the headquarters or regional office, as appropriate, for application deadlines.

#### Rural Housing Preservation Grant - (CFDA 10.433)

To assist very low- and low-income rural residents individual homeowners, rental property owners (single/multi-unit) or by providing the consumer cooperative housing projects (co-ops) the necessary assistance to repair or rehabilitate their dwellings. These objectives will be accomplished through the establishment of repair/rehabilitation, projects run by eligible applicants. This program is intended to make use of and leverage any other available housing programs which provide resources to very low and low-income rural residents to bring their dwellings up to development standards.

**Deadlines:** Contact the headquarters or regional office, as appropriate, for application deadlines.

#### Rural Rental Housing - (CFDA 10.415)

Loans can be used to construct, or to purchase and substantially rehabilitate rental or cooperative housing or to develop manufactured housing projects. Housing as a general rule will consist of multi-units with two or more family units and any appropriately related facilities. Funds may also be used to provide approved recreational and service facilities appropriate for use in connection with the housing and to buy and improve the land on which the buildings are to be located. Loans may not be made for nursing, special care, or institutional-type homes. Grants are in the form of rental assistance for some units within the underwritten property. The term for

an initial Section 515 loan is 30 years with a 50-year amortization period. However, the term for subsequent loans and loans for special types of properties, such as manufactured housing, may be made for a shorter term based on the project's expected useful life. Each loan is made at a note rate established by the Agency as prescribed in RD Instruction 440.1. Borrowers approved for initial and/or subsequent loans receive interest credit, which reduces the effective interest rate for the Agency's financing, thereby lowering the property's rents. In return for this below-market rate financing, the borrower agrees to lease the project's rental units to incomeligible households at rents approved by the Agency. Borrowers operate on a nonprofit or limited-profit basis.

#### Rural Community Development Initiative - (CFDA 10.446)

To develop the capacity and ability of private, nonprofit community-based housing and community development organizations, and low income rural communities to improve housing, community facilities, community and economic development projects in rural areas.

**Deadlines:** Contact the headquarters or regional office, as appropriate, for application deadlines.

# Agriculture and Food Research Initiative – Food Safety Challenge Area – (CFDA 10.310)

The Agriculture and Food Research Initiative (AFRI) is a competitive grant program that provides funding for fundamental and applied research, education, and extension projects in food and agricultural sciences. Within AFRI, the long-term goal of the Food Safety Challenge Area is to support the development and deployment of science based knowledge to improve the safety and nutritional quality of food without sacrificing flavor, acceptability, and affordability. #### Socially-Disadvantaged Groups Grant – (CFDA 10.871)

To provide technical assistance to socially-disadvantaged groups through cooperatives and Cooperative Development Centers. Ultimate beneficiaries must be in rural areas. All available funds are discretionary funds and must be awarded through a national competition.

Applicant Eligibility: Eligible applicants are cooperatives, groups of cooperatives, and cooperative development centers that serve socially-disadvantaged groups and whose governing board is comprised of a majority of individuals who are members of a socially-disadvantaged group. Applicants are not eligible if they have been debarred or suspended or otherwise excluded from participation in Federal assistance programs under Executive Order 12549, "Debarment and Suspension." Applicants are not eligible if they have an outstanding judgement obtained by the U.S. in a Federal Court (other than U.S. Tax Court), are delinquent on the payment of Federal income taxes, or are delinquent on a Federal debt. Any corporation that has been convicted of a felony criminal violation under any Federal law within the past 24 months or that has any unpaid Federal tax liability that has been assessed, for which all judicial and administrative remedies have been exhausted or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability, is not eligible for funding. (3/1/17)

**Beneficiary Eligibility:** Ultimate beneficiaries must be located in rural areas, as defined by 7 U.S.C. 1991(a).

**Deadline:** Contact the headquarters or regional office, as appropriate, for application deadlines.

#### Appropriate Technology Transfer for Rural Areas - (CFA 10.782)

Provide diverse technical information and educational resources about sustainable agriculture to farmers, information providers, agriculture-related businesses, and community food organizations across the U.S.

Funds must be used to provide information about sustainable agriculture. Information may be provided through publications or direct technical assistance. All available funds are discretionary funds.

**Applicant Eligibility:** Applicants are not eligible if they have been debarred or suspended or otherwise excluded from participation in Federal assistance programs under Executive Order 12549, "Debarment and Suspension." Applicants are not eligible if they have an outstanding judgement obtained by the U.S. in a Federal Court (other than U.S. Tax Court), are delinquent on the payment of Federal income taxes, or are delinquent on a Federal debt. Any corporation that has been convicted of a felony criminal violation under any Federal law within the past 24 months or that has any unpaid Federal tax liability that has been assessed, for which all judicial and administrative remedies have been exhausted or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability, is not eligible for funding.

#### Very Low-Income Housing Repair Loans and Grants - (CFA 10.417)

Loan funds may be used to make general repairs and improvements to properties or to remove health and safety hazards. Grant funds may be used only to pay for the costs for repairs and improvements that will remove identified health and safety hazards or to repair or remodel dwellings to make them accessible for household members with disabilities. Loans and grants are typically used for repair or replacement of heating, plumbing or electrical services, roof or basic structure as well as water and waste disposal systems, and weatherization.

**Applicant Eligibility:** Applicants must own and occupy a home in a rural area; and be a citizen of the United States or reside in the United States after having been legally admitted for permanent residence or on indefinite parole. Loan recipients must have sufficient income to repay the loan. Grant recipients must be 62 years of age or older and be unable to repay a loan for that part of the assistance received as a grant. Applicant's income may not exceed the very low-income limit set forth in RD Instructions.

# Women & Minorities in Science, Technology, Engineering, & Math Fields - (CFA 10.318)

The Women and Minorities (WAMS) in Science, Technology, Engineering and Mathematics (STEM) Fields program was authorized to increase participation by women and underrepresented minorities from rural areas in the fields of science, technology, engineering and mathematics, with priority given to eligible institutions that carry out continuing programs funded by the Secretary.

The goal of the WAMS program is to develop and implement robust partnerships to increase the representation, participation, and entrepreneurism of women in STEM careers, thereby contributing to national economic prosperity.

The purpose of the grant program is to support projects that: Provide STEM knowledge, skills and competency to Women and Minorities from Rural Areas with successful placement (a) in the workforce in STEM fields, or (b) as innovators and entrepreneurs adding value to the STEM fields in areas that have relevancy to the USDA Secretary's priorities.

**Applicant Eligibility:** State agricultural experiment stations; colleges and universities; university research foundations; other research institutions and organizations; Federal agencies; national laboratories; private organizations or corporations; individuals; or any group consisting of 2 or more of these entities.

**Deadline:** Not Applicable. (1/17/17)

#### Household Water Well System Grant Program - (CFA 10.862)

To make grants to private, nonprofit organizations to finance the construction, refurbishing and servicing of individually-owned household water well systems in rural areas for individuals with low or moderate income.

Grant funds will be used to establish and maintain a revolving loan fund to provide loans to eligible individuals to construct, refurbish, and service individually-owned household water well systems. Eligible individuals must

own or will own the household water well systems. Funds may be used to pay administrative expenses associated with providing the loans. Grant funds may not be used to pay (1) administrative expenses exceeding 10 percent of the loans made during the calendar year; (2) administrative expenses incurred before the Rural Utilities Service executes a grant agreement; (3) delinquent debt owed to the Federal Government.

**Applicant Eligibility**: An applicant must be a private organization, organized as a non-profit corporation. The applicant must have the legal capacity and authority to perform the obligations of the grant. The applicant must have sufficient expertise and experience in lending activities and promoting the safe and productive use of individually-owned household water well systems and ground water.

**Beneficiary Eligibility:** An individual in a household in which the combined income of all household members (for the most recent 12 months) does not exceed 100 percent of the median non-metropolitan household income for the State or territory in which the individual resides.

**Deadline:** Contact the headquarters or regional office, as appropriate, for application deadlines. (3/1/17)

#### Water and Waste Disposal Systems for Rural Communities - (CFA 10.760)

To provide basic human amenities, alleviate health hazards and promote the orderly growth of the rural areas of the nation by meeting the need for new and improved rural water and waste disposal facilities.

Funds may be used for the installation, repair, improvement, or expansion of a rural water facility including distribution lines, well pumping facilities and costs related thereto, and the installation, repair, improvement, or expansion of a rural waste disposal facility including the collection, and treatment of sanitary, storm, and solid wastes. Grant funds may not be used to pay: interest on loans, operation and maintenance costs, or acqusition or refinancing of an existing system. No maximum loan amount is established by statute. The maximum term on all loans is 40 years. However, no repayment period will exceed any statutory limitation or the organization's borrowing authority or the useful life of the improvement or facility to be financed. There are currently three interest rates for direct loans: (1) a poverty rate that is 60 percent of the market rate, (2) an intermediate rate that is 80 percent of the market rate, and (3) a market rate. The poverty interest rate will not exceed 5 percent per year. The poverty rate may apply when the loan is required to meet health or sanitary standards and the median household income (MHI) of the service area is below the poverty line or 80 percent of the statewide nonmetropolitan MHI, whichever is greater. The intermediate rate applies when the MHI of the service area is not more than 100 percent of the statewide nonmetropolitan MHI, and the poverty rate does not apply. The market rate applies when neither the poverty rate nor intermediate rate is applicable. The interest rate on guaranteed loans is negotiable between the applicant and the lender.

Applicant Eligibility: Municipalities, counties, other political subdivisions of a State such as districts and authorities, associations, cooperatives, corporations operated on a not-for-profit basis, Indian tribes on Federal and State reservations and other Federally recognized Indian tribes. The applicant must: (1) be unable to finance the proposed project from its own resources or through commercial credit at reasonable rates and terms; and (2) have the legal authority necessary for constructing, operating, and maintaining the proposed facility or service, and for obtaining, giving security for, and repaying the proposed loan. Assistance is authorized for eligible applicants in rural areas of the United States

**Deadline:** Not Applicable. (3/1/17)

#### Water & Waste Disposal Loan & Grant (Section 306C) - (CFA 10.770)

This grant provides water and waste disposal facilities and services to low income rural communities whose residents face significant health risks.

Funds may be used for 100 percent of costs to: Construct, enlarge, extend, or otherwise improve a community water or waste system; extend service lines and connect individual residences to a system. Allow applicant to make grants directly to individuals to: Extend service lines, connect resident's plumbing to system, pay reasonable charges and fees for connecting to system, installation of plumbing and related fixtures, and construction in dwelling of a bathroom.

**Applicant Eligibility:** This program assists qualified applicants that are not otherwise able to obtain commercial credit on reasonable terms. Eligible applicants include:

- Most State and local governmental entities
- Private non-profits
- Federally-recognized Tribes

The projects funded under this program must primarily provide water and/or waste disposal services to residents of rural areas and towns with fewer than 10,000 people, Tribal lands in rural areas and Colonias. Also the residents must face significant health risks due to not having access to an affordable community water and/or waste disposal system. (12/01/16)

#### Solid Waste Management Grants - (CFA 10.762)

Reduces or eliminates pollution of water resources and improve planning and management of solid waste disposal facilities in rural areas.

Funds may be used to: Evaluate current landfill conditions to determine threats to water resources in rural areas; provide technical assistance and/or training to enhance operator skills in the maintenance and operation of active landfills in rural areas; provide technical assistance and/or training to help associations reduce the solid waste stream; and provide technical assistance and/or training for operators of landfills in rural areas which are closed or will be closed in the near future with the development/implementation of closure plans, future land use plans, safety and maintenance planning, and closure scheduling within permit requirements. Grant funds may not be used to: Recruit applications/applications for any loan and/or grant program including RUS Water and Waste Disposal Loan and/or Grant Program; duplication of current services, replacement or substitution of support previously provided such as those performed by an association's consultant in developing a project; fund political activities; pay for capital assets, the purchase of real estate or vehicles, improve and renovate office space, or repair and maintain privately-owned property; pay for construction or operation and maintenance costs of water and waste facilities; and pay costs incurred prior to the effective date of grants made under this subpart.

**Applicant Eligibility:** Entities eligible for grants are nonprofit organizations, including: Private nonprofit organizations that have been granted tax exempt status by the Internal Revenue Service (IRS); and public bodies

including local governmental-based multijurisdictional organizations. Applicants must have the proven ability, background, experience, legal authority, and actual capacity to provide technical assistance and/or training on a regional basis to eligible beneficiaries (3/1/17)

#### <u>Grant Program to Establish a Fund for Financing Water and Wastewater</u> Projects – RFP Program - (CFA 10.864)

To make grants to private, nonprofit organizations to establish a revolving loan fund to make small, short term loans for pre-development or small capital water or waste disposal projects.

Grant funds will be used to establish and maintain a revolving loan fund to finance pre-development costs associated with proposed water and wastewater projects or with existing water and wastewater systems, and short-term costs incurred for replacement equipment, small-scale extension of services, or other small capital projects that are not part of the regular operations and maintenance activities of existing water and wastewater systems.

**Applicant Eligibility:** An applicant must be a private organization, organized as a non-profit corporation. Facilities shall primarily serve rural residents and rural businesses. The service area shall not include any area in any city or town having a population in excess of 10,000 inhabitants according to the latest decennial census of the United States. The loan recipient must be unable to finance the proposed project from their own resources or through commercial credit at reasonable rates and terms. The loan recipient must have or will obtain the legal authority necessary for owning, constructing, operating and maintaining the proposed service or facility, and for obtaining, giving security for, and repaying the proposed loan. (3/1/17)

#### Community Facilities Loans and Grants - (CFA 10.766)

This program provides affordable funding to develop essential community facilities in rural areas. An essential community facility is defined as a facility that provides an essential service to the local community for the orderly development of the community in a primarily rural area, and does not include private, commercial or business undertakings.

Examples of essential community facilities include:

- Health care facilities such as hospitals, medical clinics, dental clinics, nursing homes or assisted living facilities
- Public facilities such as town halls, courthouses, airport hangars or street improvements

- Community support services such as child care centers, community centers, fairgrounds or transitional housing
- Public safety services such as fire departments, police stations, prisons, police vehicles, fire trucks, public works vehicles or equipment
- Educational services such as museums, libraries or private schools

- Local food systems such as community gardens, food pantries, community kitchens, food banks, food hubs or greenhouses

Rural areas including cities, villages, townships and towns including Federally Recognized Tribal Lands with no more than 20,000 residents according to the latest U.S. Census Data are eligible for this program. #### Rural Business Enterprise Grants - CFDA 10.769

**Objectives (050):** To facilitate the development of small and emerging private business, industry, and related employment for improving the economy in rural communities.

Eligibility Requirements (080)

**Applicant Eligibility (081):** Applicants eligible for RBE grants are public bodies and nonprofit corporations serving rural areas such as States, counties, cities, townships, and incorporated towns and villages, boroughs, authorities, districts and Indian tribes on Federal and State reservations which will serve rural areas. Applicants eligible for TD grants are statewide, private, nonprofit, public television systems whose coverage is predominantly rural. Rural area for this program is defined as a city, town, or unincorporated area that has a population of 50,000 inhabitants or less, other than an urbanized area immediately adjacent to a city, town, or unincorporated area that has a population in excess of 50,000 inhabitants.

**Beneficiary Eligibility (082):** A small and emerging private business enterprise which will employ 50 or less new employees and has less than \$1.0 million in projected gross revenue. Public bodies, private non-profit corporations, and Federally recognized Indian tribes receive the grant to assist a business. Grants are not made directly to the business.

#### Rural Child Poverty Nutrition Center - (CFA 10.549)

University of Kentucky lead by Dr. Ann Vail was selected through a competitive process as the grantee that would establish the USDA Rural Child Poverty Nutrition Center. The roles of this Center include:

- developing and administering a series of sub-grants pertinent to the purposes of this grant
- coordinating relevant grant-related activities among sub-grantees and researchers
- conducting an evaluation of subgrantees' programs, and

widely disseminating information on communities' implementation strategies and evaluation findings.

#### **Rural Business Development Grant (RBDG)**

#### <u>Farm Operating Loans (Direct & Guaranteed / Insured Loans) - (CFDA 10.406)</u>

#### Regional Innovation Strategies Program - (CFDA 11.020)

EDA is committed to fostering connected, innovation-centric economic sectors which support the conversion of research into products and services, businesses, and ultimately jobs through entrepreneurship. Funding is available for capacity-building programs that provide proof-of-concept and commercialization assistance to innovators and entrepreneurs and for operational support for organizations that provide essential early-stage funding to startups. #### <u>Minority Business Resource Development – (CFDA 11.802)</u>

# <u>Partnerships for Opportunity and Workforce and Economic Revitalization</u> (POWER) Initiative

#### **U.S. Department of Education**

#### Adult Education - Basic Grants to States - (CFDA 84.002)

To fund local programs of adult education and literacy services, including workplace literacy services, family literacy services, and English literacy and integrated English literacy-civics education programs. Participation in these programs is limited to adults and out-of-school youths aged 16 and older who do not have a high school diploma or equivalent and who are not enrolled or required to be enrolled in a secondary school under State law. See 20 USC 9202(1).

Applicant Eligibility (081): Formula grants are made to designated eligible State agencies that under State law are responsible for administering or supervising statewide policy for adult education and literacy, including such entities as State educational agencies (SEAs), postsecondary agencies, or workforce agencies. State agencies must provide direct and equitable access to: local educational agencies; public or private nonprofit agencies; community-based organizations of demonstrated effectiveness; institutions of higher education; volunteer literacy organizations of demonstrated effectiveness; libraries; public housing authorities; nonprofit institutions not described above that have the ability to provide literacy services to adults and families; and consortia of the entities described above.

**Beneficiary Eligibility (082):** Adults and out-of-school youths who are 16 years of age and older, who are not enrolled or required to be enrolled in secondary school under State law, and who lack sufficient mastery of basic educational skills to enable them to function effectively in society or do not have a secondary school diploma or its recognized equivalent, and have not achieved an equivalent level of education, or are unable to speak, read, or write the English language. (3/15/17)

#### <u>Title I Grants to Local Educational Agencies - (CFDA 84.010)</u>

To help local educational agencies (LEAs) improve teaching and learning in high-poverty schools in particular for children failing, or most at-risk of failing, to meet challenging State academic achievement standards.

Use of funds varies, depending on whether a school is operating a schoolwide program under Section 1114 of the ESEA or a targeted assistance program under Section 1115 of the ESEA. A school with at least a 40 percent poverty rate may choose to operate a schoolwide program under Section 1114, which allows Title I funds to be combined with other Federal, State, and local funds to upgrade the school's overall instructional program in order to raise the achievement of the lowest-achieving students; a school that does not meet the 40 percent poverty threshold may also operate a schoolwide program if it receives a waiver to do so from the State educational agency (SEA). All other participating schools must operate a targeted assistance program, which provides extra instruction to those children failing, or most at risk of failing, to meet challenging State academic standards. Title I funds must be used only to supplement the State and local funds that would, in the absence of Title I funds, be made available for the education of participating students, and not to supplant such funds. This program is subject to non-supplanting requirements and must use a restricted indirect cost rate which is referenced under 34 CFR 76.564-76.569. **Applicant Eligibility (081):** SEAs including for the Outlying Areas and the Secretary of the Interior. Local educational agencies (LEAs) and Indian tribal schools are subgrantees.

**Beneficiary Eligibility (082):** In a targeted assistance program, children who are failing, or most at risk of failing, to meet challenging State academic standards. In a schoolwide program, all children in the school. (3/15/17)

#### Striving Readers - (CFDA 84.371)

**Beneficiary Eligibility (082):** The Striving Readers Comprehensive Literacy program benefits children and youth from birth through 12th grade (3/15/17)

# **Special Education Technical Assistance and Dissemination to Improve Services** and Results for Children with Disabilities - (CFDA 84.325)

# <u>Behavioral Health Workforce Education and Training (BHWET) Program – (CFDA 93.243)</u>

This program is structured to help older homeless youth achieve self-sufficiency and avoid long-term dependency on social services. Transitional living projects provide shelter,

skills training, and support services to homeless youth, including pregnant and parenting youth, ages 16 to less than 22. This extends the residential stay for homeless youth to 635 days or 21 months. MGHs provide the same services as the TLP in addition to providing parenting instructions and child care. Other services that are offered include, but are not limited to, transportation, family planning, and pregnancy prevention services.

- (4) made significant recruitment efforts to increase the number of under represented minority individuals serving in faculty or administrative positions at the school.

## Rent Supplements-Rental Housing for Lower Income Families - (CFDA 14.149)

Assistance covers the difference between the tenant's payment and the basic market rental, but may not exceed 70 percent of the market rental. # **Emergency Solutions Grant Program - (CFDA 14.231)**

# Youth Gang Prevention - (CFDA 16.544)

Objectives: To prevent, intervene, and reduce the participation of juveniles in the activities of gangs that commit crimes. Such programs and activities may include: 1) individual, peer, family, and group counseling, including provision of life skills training and preparation for living independently, which shall include cooperation with social services, welfare, and health care programs; 2) education and social services designed to address the social and developmental needs of juveniles; 3) crisis intervention and counseling to juveniles, who are particularly at risk of gang involvement, and their families; 4) the organization of the neighborhood and community groups to work closely with parents, schools, law enforcement, and other public and private agencies in the community; 5) supporting the coordination of existing comprehensive community-based antigang initiatives; and 6) training and assistance to adults who have significant relationships with juveniles who

are or may become members of gangs, to assist such adults in providing constructive alternatives to participating in the activities of gangs. To develop within the juvenile adjudicatory and correctional systems new and innovative means to address the problems of juveniles convicted of serious drug-related and gangrelated offenses. To provide treatment to juveniles who are members of such gangs, including members who are accused of committing a serious crime and members who have been adjudicated as being delinquent. To promote the involvement of juveniles in lawful activities in geographical areas in which gangs commit crimes. To promote and support, with the cooperation of community-based organizations experienced in providing services to juveniles engaged in gang-related activities and cooperation of local law enforcement agencies, the development of policies and activities in public elementary and secondary schools which will assist such schools in maintaining a safe environment conducive to learning. To assist juveniles who are or may become members of gangs to obtain appropriate educational instruction, in or outside a regular school program, including the provision of counseling and other services to promote and support the continued participation of such juveniles in such instructional programs. To expand the availability of prevention and treatment services relating to the illegal use of controlled substances and controlled substances analogues (as defined in paragraphs (6) and (32) of section 102 of the Controlled Substances Act (21 U.S.C. 802) by juveniles, provided through State and local health and social services agencies. To provide services to prevent juveniles from coming into contact with the juvenile justice system again as a result of gang-related activity. To provide services at a special location in a school or housing project. To facilitate coordination and cooperation among: 1) local education, juvenile justice, employment, law enforcement, and social service agencies; and 2) community-based programs with a proven record of effectively providing intervention services to juvenile gang members for the purpose of reducing the participation of juveniles in illegal gang activities.

# <u>National Transit Research Technical Assistance and Workforce Development – (CFDA 20.531)</u>

Funds from this program may be used for: (1) Maintenance and restoration of existing Human Resources and Training Innovative Public Transportation Frontline Workforce Development Program. As funding is available, FTA will award competitive grants to assist the development of innovative activities to support:

- (1) Employment training programs;
- (2) Outreach to specific under-represented populations in the workforce;
- (3) Research on public transportation personnel and training needs;
- (4) Training and assistance for veteran and minority business opportunities; and
- (5) Consensus-based national training standards and certifications in partnership with industry stakeholders.

#### Eligible frontline workforce program activities include:

- i. developing apprenticeships, on-the job training, and instructional training for public transportation maintenance and operations occupations;
- building local, regional, and statewide public transportation training partnerships with local public transportation operators, labor union organizations, workforce development boards, and State workforce agencies to identify and address workforce skill gaps;
- iii. improving safety, security, and emergency preparedness in local public transportation systems through improved safety culture and workforce communication with first responders and the riding public; and
- iv. addressing current or projected workforce shortages by developing partnerships with high schools, community colleges, and other community organizations.

Funds from this program may be used for: (1) Maintenance and restoration of existing trails; (2) development and rehabilitation of trailside and trailhead facilities and trail linkages; (3) purchase and lease of trail construction and maintenance equipment; (4) construction of new trails (with restrictions for new trails on Federal lands); (5) acquisition of easements or property for trails or trail corridors; (6) assessment of trail conditions for accessibility and maintenance; (7) development and dissemination of publications and operation of educational programs to promote safety and environmental protection and well as many others. # **U.S. Department of Treasury**

## **Minority CDE Training and Technical Assistance Initiative**

The Community Development Financial Institutions Fund (CDFI Fund) has contracted with National Community Investment Fund (NCIF) to provide group training and individual technical assistance to Minority Community Development Entities[1] (Minority CDEs). The purpose of the training and subsequent technical assistance is to ensure full understanding of how Minority CDEs can participate in the New Markets Tax Credit Program (NMTC Program) and to address identified challenges and needs Minority CDEs may face with such participation.

Under the terms of this contract, Minority CDEs who applied in any of the 2012-2016 NMTC Application rounds were invited to participate in this training and technical assistance in October 2016. The CDFI Fund has opened a waitlist for other Minority CDEs that would like to participate in this training initiative. Under this contract, the CDFI Fund is offering the following:

- Up to four workshops for group training
- Up to 25 one-on-one technical assistance trainings

Minority CDEs on the waitlist need to complete an eligibility survey. If eligible, Minority CDEs are to complete the CDE Information Form with detailed information about past applications, awards and CDE structure. In order to be eligible to participate in a group-training workshop in early 2017, Minority CDEs selected to participate must complete a Training and Technical Assistance Curriculum Intake Form at a later time. It is highly recommended that individuals completing the CDE Information Form are the Authorized Representatives of the Minority CDE. Participation in a training workshop (dates to be determined) is a prerequisite for the CDFI Fund to consider Minority CDEs for one-on-one technical assistance.

# **U.S. Department of Veterans Affairs**

# <u>VA Homeless Providers Grant and Per Diem Program – (CFDA 64.024)</u>

The Program allows VA to assist public or non-profit private entities with partial funding for "bricks and mortar" to create supportive housing or services centers or to purchase vans for outreach and transportation. In addition VA is also authorized fund operating expenses minus other sources of income for these facilities through per diem payments.

Applicants eligible for grants include public and nonprofit private entities with the capacity to effectively administer a grant; which demonstrate that adequate financial support will be available to carry out the project; and which agree to and demonstrate capacity to meet the applicable criteria and requirements of the grant program. Applicants eligible for per diem payments include public or nonprofit private entities who are either grant recipients, or who are eligible to receive a grant.

## **Veterans Cemetery Grants**

The program assists states, territories and federally recognized tribal governments in providing gravesites for Veterans in those areas where VA's national cemeteries cannot fully satisfy their burial needs. Grants may be used only for the purpose of establishing, expanding or improving Veterans cemeteries that are owned and operated by a state, federally recognized tribal government, or U.S. territory.

Deadline is July 1, 2017.

# **Appalachian Regional Commission**

## Appalachian Area Development - CFDA 23.002

To help the regional economy become more competitive by putting in place the building blocks for self-sustaining economic development, while continuing to provide special assistance to the Region's most distressed counties and areas. This program focuses on activities which support ARC's mission to be a strategic partner and advocate for sustainable community and economic development. Activities funded must advance ARC's strategic plan. Specific program goals are: (1) Increase job opportunities and per capita income in Appalachia to reach parity with the nation; (2) Strengthen the capacity of the people of Appalachia to compete in the global economy; (3) Develop and improve Appalachia's infrastructure to make the Region economically competitive; and (4) Build the Appalachian Development Highway System to reduce Appalachia's isolation. Specific objectives were developed for each goal.

# **Delta Area Economic Development**

**Objectives:** Delta Regional Authority's mission is to be an advocate for and partner with the people of the Delta to create opportunities for self-sustaining economic development and improved quality of life. This program focuses on activities which support DRA,s mission. Specific program goal are: (1) to develop the transportation infrastructure of the region for the purpose of facilitating economic development in the region (except that grants for this purpose may only be made to state and local government); (2) to assist the region in obtaining the job training, employment related education, and business development (with an emphasis of entrepreneurship) that are needed to build and maintain strong local economies; (3) to provide assistance to severely distressed and underdeveloped areas that lack financial resources for improving basic public services; (4) to provide assistance to severely distressed and underdeveloped areas that lack financial resources for equipping industrial parks and related facilities; and (5) to otherwise achieve the purpose of the Act. Grants are made either directly by the Authority or grants may supplement other Federal grants.

# BoatUS Foundation Accepting Grant Applications for Safe and Clean Boating Projects

The BoatUS Foundation for Boating Safety and Clean Water is accepting applications for its Grassroots Grants Program, which awards funds on an annual basis to nonprofit organizations, boating clubs, and student groups in the United States for projects that utilize innovative approaches to education about safe and clean boating.

The foundation is looking for creative projects that promote safe and clean boating on local waterways. Past topics have ranged from PSAs on the effects of boating under the influence to hands-on education about the effects of marine debris.

Projects the foundation is most interested in funding will be unique (topic, methods, or delivery mechanism); include extensive outreach to boaters; use technology to educate boaters, including social media and the Web; have a widespread reach (not just a handful of boaters); include hands-on work with the boating community; and have a way to measure the success of the program.

Applicants can include boating groups, clubs and associations, student groups, and local nonprofit organizations, including local chapters of national organizations. Grants will not be awarded to government agencies, international organizations, for-profit businesses, or individuals.

Applicants may request up to \$10,000. Funded projects must be completed within a year.

#### **Baseball Tomorrow Fund**

The Baseball Tomorrow Fund (BTF) awards grants to non-profit and tax-exempt organizations involved in the operation of youth baseball and/or softball programs and facilities. Organizations operating in the U.S. and international locations are eligible to apply. To date, an average of 400 requests are received annually; approximately 10 percent are awarded grants. Grants are awarded on a quarterly basis.

#### **Surdna Foundation Sustainable Environment Grants**

We believe in the potential of what we call "next generation infrastructure" to improve transit systems, make buildings more energy efficient, better manage our water systems and rebuild regional food systems. Focusing on urban areas and their surrounding suburbs, we seek solutions that connect and improve these infrastructure systems in ways that maximize positive impacts and minimize negative environmental, economic and social consequences.

#### JFNY Grant for Arts and Culture

The Japan Foundation New York office (JFNY) accepts applications for projects that take place within the 37 states east of Rocky Mountains listed below for the JFNY Grant throughout the year. This grant aims to support projects that will further understanding of Japanese arts and culture. Successful projects may be granted up to \$5,000. Priority will be given to those projects that have secured additional funding from sources other than the Japan Foundation.

# **Zayed Future Energy Global High Schools Prize**

The primary aim of the Global High Schools category is to inspire future generations across the globe by instilling an ethos of sustainability from an early age, including an appreciation of issues in energy, and broader sustainability. Each school will submit a detailed proposal for a project, and the Prize will become a grant that enables the project's completion. While the main objective is to promote sustainability in schools, special emphasis of the proposed project should be on specific measurable initiatives to promote renewable energy and sustainability, which may include improvements in energy or water efficiency, or a reduction in waste.

#### **Waste Management Charitable Giving**

Healthy thriving communities depend on involved citizens, organizations and corporate partners for momentum. We lend our support and services to causes that promote civic pride, economic development and revitalization. Every community has its own challenges, and we strive always to be part of problem-solving initiatives. Programs that Waste Management is most motivated to support include: environment, environmental education, and causes important to the areas where we operate. Applications are accepted year round and are reviewed on a continuous basis. Given the large amount of requests received, please anticipate an estimated two-month review period for each request.

#### **Clif Bar Foundation Small Grants**

These grants are awarded for general organizational support as well as funding for specific projects. Small grants average approximately \$7,000 each. Priority is given to applicants that: Address our funding priorities from a holistic perspective; Protect Earth's beauty and bounty; Create a robust, healthy food system; Increase opportunities for outdoor activity; Reduce environmental health hazards; Build stronger communities; Operate with clearly defined objectives and viable plans to achieve them; Demonstrate strong community ties and operate at the community level; Promote positive change through both the projects and their implementation process.

# Foundation for Contemporary Art Accepting Applications for Emergency Grants

Since its inception in 1963, the mission of the Foundation for Contemporary Arts has been to encourage, sponsor, and promote innovative work in the arts created and presented by individuals, groups, and organizations.

Created in 1993, the foundation's Emergency Grants program provides grants of up to \$2,000 to innovative visual and performing artists who have unanticipated, sudden opportunities to present their work to the public when there is insufficient time to seek other sources of funding; or who incur unexpected or unbudgeted expenses for projects close to completion with committed exhibition or performance dates.

To be eligible, applicants must be living, working, and paying taxes in the United States; have committed to a performance or exhibition opportunity and be able to provide specific dates at the time of application; and be an

individual artist or an individual representing an artist collective, ensemble, or group. Curators, producers, workshop organizers, organizations, or arts presenters are not eligible to apply.

**Deadline:** OPEN

## **IDA Seeks Applications to Support Independent Documentary Films**

The International Documentary Association is accepting applications for the creation of original, independent documentary films that illuminate pressing issues in the US.

Through the Pare Lorentz Documentary Fund, IDA will award production grants of up to \$25,000 to up to a dozen projects that tell a compelling story and focus on one of Pare Lorentz's central concerns -- the appropriate use of the natural environment, justice for all, and/or the illumination of pressing social problems. The fund supports full-length documentary films that reflect the spirit and nature of Pare Lorentz's work and exhibit objective research, artful storytelling, a strong visual style, high production values, excellent writing, and outstanding music composition, as well as skillful direction, camerawork, and editing. A program of the International Documentary Association, the Pare Lorentz Documentary Fund is made possible by the New York Community Trust.

Projects must be in production at the time of application, with the bulk of research and development completed but still having substantial production or post-production related work and expenses remaining. Grant funds may be used for production and post-production related expenses incurred during the period of support.

**To be eligible**, the applicant must be 18 years of age or older and be a producer and/or director of the submitted work. In addition, the applicant must be an independent filmmaker working on an original project. The applicant also should be an experienced filmmaker with at least one key above-the-line (producer, director, codirector, co-producer) or other principal creative (director of photography, editor) credit on a previously completed documentary.

**Deadline:** IDA will be accepting applications on a rolling basis until July 31, 2017. Applications will be reviewed throughout the period, with grants being awarded quarterly.

## **Weyerhaeuser Giving Fund**

Good Sports helps lay the foundation for healthy, active lifestyles by providing athletic equipment, footwear, and apparel to disadvantaged young people nationwide. By working closely with teams, coaches, and community leaders across the United States, the organization is able to focus on the respective needs of each individual program and help offset the main factors causing the greatest challenges.

Good Sports is accepting applications from organizations and schools for equipment, apparel, and footwear for a wide range of sports. Organizations that are approved will have access to equipment, apparel, and footwear inventory for a two-year period. During that time, organizations can make up to six separate donation requests — as long as need is well documented, donations will be granted. There is no need to resubmit a full application again during the two-year period.

To be eligible, applicants must directly serve youth between the ages of 3 and 18; serve youth in an economically disadvantaged area; be located in North America (the U.S. and Canada); and operate an organized sport, recreational activity, or fitness program that offers consistent and structured opportunity for play to large groups of children. Schools must apply as a whole; applications for individual programs within a school will not be considered. Donation requests for short-term events such as sports camps and tournaments or to individual athletes will not be considered.

While the equipment, apparel, and footwear received through the program are free, recipients are expected to pay shipping and handling costs, which amount to roughly 10 percent of the donation value, with a maximum fee of \$1,500.

**Deadline:** Applications are reviewed on a rolling basis. It is recommended, however, that organizations apply at least eight weeks prior to the start of their particular season or program to ensure the desired equipment can be accessed and shipped on time.

## **Karma for Cara Foundation Invites Applications for Youth Microgrants**

The Karma for Cara Foundation is a nonprofit founded by 21-year-old Cara Becker and her family while she was undergoing treatment for leukemia at the Johns Hopkins Kimmel Cancer Center. Cara and her two brothers began volunteering at a young age as part of their family's commitment to community service. She and her family saw a tremendous need to help support other patients and their families who were also challenged by cancer. Tragically, Cara passed four months after her diagnosis, yet her wish to help others through K4C lives on with the support of an ever-growing circle of family and friends.

As part of an effort to promote and support youth voluntarism, k4C started a microgrant program in fall 2014 to encourage kids 18 and under to apply for a grant of between \$250 and \$1,000 to complete service projects in their communities. Examples of fundable projects include but are not limited to turning a vacant lot into a community garden, rebuilding a school playground, and helping senior citizens get their homes ready for winter. Grants will be distributed as gift cards to home goods stores, office supply stores, grocery food chains, and toy stores.

# VFW Accepting Applications From Veterans for Emergency Financial Assistance

Veterans of Foreign Wars is accepting applications from active and discharged military service members who have been deployed in the last six years and have run into unexpected financial difficulties as a result of deployment or other military-related activity. Since the program's inception, Unmet Needs has distributed more than \$5 million in assistance to qualified military families, with nearly half of those funds going directly toward basic housing needs.

The Unmet Needs Program provides financial assistance of up to \$5,000 to assist with basic life needs in the form of a grant — not a loan — so no repayment is required. Eligible expenses include housing and vehicle payments; utility and phone bills; food and incidentals; children's clothing, food, diapers, school, and childcare; and medical bills, prescriptions, and eyeglasses. Each expense will be considered on a case-by-case basis, and payments will be made directly to the recipient's creditors.

The hardship must be the result of deployment, a military pay issue, or military-related illness or injury. It cannot be due to civil legal or domestic issues, misconduct, or any issues that are a result of spousal separation or divorce, financial mismanagement, or bankruptcy.

# Start a Snowball Invites Applications for Youth Philanthropy Projects

Start a Snowball, Inc. encourages kids of all ages to engage in philanthropic and community service activities. The organization believes that even one child with the right intentions and support can start a project that seems small in the beginning and eventually grows ("snowballs") into something that inspires and benefits an entire community.

In order to help kids kick off their philanthropy efforts, Start a Snowball awards \$100 in seed funding for projects taken on by individuals or organizations.

To be eligible, projects must be led by youth between the ages of 5 and 18 and have the intention of doing good.

Start a Snowball does not give directly to collection funds. The organization also does not provide support for fundraisers for sports teams, unless they serve an underserved or disadvantaged group, or support projects that are discriminatory or political in nature.

**Deadline:** Rolling

## **Craft Emergency Relief Fund Accepting Applications From Craftspeople in Need**

The Craft Emergency Relief Fund is a national nonprofit organization that awards small grants and loans to professional craftspeople experiencing career-threatening illness, accident, fire, theft, or natural disaster.

Financial assistance ranges from \$500 to \$8,000. Other services include referrals to craft suppliers who have agreed to offer discounts on materials and equipment to craftspeople eligible for CERF funds and booth fee waivers from specific craft show producers.

CERF loan recipients are expected to repay the loan in full within five years, enabling CERF to have funds readily available for future craftspeople in need.

Applicants must be a professional artist working in a craft discipline (e.g., a potter, metalsmith, glass artist, woodworker, fiber artist, or furniture maker) who has had a recent career-threatening emergency and a legal resident of the U.S.

# Pollock-Krasner Foundation Accepting Applications From Artists With Financial Need

The mission of the Pollock-Krasner Foundation is to aid those individuals who have worked as artists over a significant period of time. The foundation's dual criteria for grants are recognizable artistic merit and financial need, whether professional, personal, or both.

The foundation welcomes, throughout the year, applications from visual artists (painters, sculptors, and artists who work on paper, including printmakers) with genuine financial needs. Grants are intended for a one-year period of time, with the size of the grant to be determined by the artist's individual circumstances and professional exhibition history. Only applications for seed funding, as opposed to ongoing operational or program costs of a nonprofit organization, will be accepted.

To be eligible, applicants must be a passionate, committed individual with a social change vision that fits within one or more of the categories above. Established nonprofit organizations with paid staff will not be considered.

# Hope for The Warriors Accepting Applications for Critical Care Support for Wounded Veterans

Hope For The Warriors believes those touched by military service can succeed at home by restoring their sense of self, family, and hope. Nationally, the organization provides service members, veterans, and military families with comprehensive support programs focused on transition, health and wellness, peer engagement, and community resources.

Originally designed to meet short-term needs in the days following an injury, the Hope for The Warriors' Critical Care Coordination program has expanded to assist post-9/11 combat-wounded veterans and their families as they navigate through long-term recovery.

Program case coordinators work daily with post-9/11 combat-wounded service members and veterans, their families, and families of the fallen to meet immediate financial needs related to daily living including utilities, groceries, rent, mortgage, and rental deposits. The program provides casework assistance and resource referrals that will help clients immediately and in the future. Payment is always made to a third party.

To be eligible, applicants must be seeking support for needs that are a direct result of a service member's post-9/11 combat-related injury.

# <u>Singing for Change Accepting LOIs for Projects to Address Social and</u> <u>Environmental Problems</u>

Created by Jimmy Buffett in 1995, Singing for Change initially was funded with contributions from the singer's summer concert tour. Since then, SFC has offered competitive grants to progressive nonprofit organizations working to address the root causes of social or environmental problems.

Priority will be given to organizations that keep their overhead low, include community members in planning, and collaborate with other groups to find innovative ways of solving common problems. SFC aims to advance the common good by empowering people to thrive and strengthen and sustain vibrant, diverse communities.

Grants will range in size from \$1,000 to \$10,000. Grants are made only to nonprofit organizations with tax-exempt status under section 501(c)(3) of the Internal Revenue Code, or to organizations that have a sponsoring agency with exempt status.

# A Little Hope Announces Youth Bereavement Support Services Grants

A Little HOPE supports organizations that provide bereavement support services and grief counseling to children and teens who have experienced the death of a parent, sibling, or loved one.



# **Alabama Additional Funding Sources**

## **Community Foundations in Alabama**

There are 13 community foundations in Alabama, covering 78 percent of the counties in the state and holding assets that total more than \$190 million.

## **Daniel Foundation**

The Daniel Foundation offers grants in four program areas: Civic and Community Improvement, Education, Health, and Arts and Culture. Applications are limited to 501 (c)(3) organization that are located in Alabama.

## **Alabama Power Foundation**

The Alabama Power Foundation allocates funding in four categories: Improving Education, Strengthening Communities, Promoting Arts and Culture, and Restoring and Enhancing the Environment.

## **Alabama Humanities Foundation**

The AHF awards grants solely to support public humanities projects. Active public participation, involvement of humanities scholars, and strong humanities content are the three essential components of AHF-funded projects.

## **Gwyn Turner Endowed Fund**

The fund is administered by the National Trust for Historic Preservation, in partnership with Alabama Trust for Historic Preservation. Nonprofits and governmental agencies can obtain funding for preservation planning, heritage education, workshops, conferences and special interventions. Grants range from \$1,000 to \$5,000 and require a 1:1 cash match.
