I am requesting funding for Tuscaloosa National Airport (TCL) in fiscal year 2025. The entity to receive funding for this project is the City of Tuscaloosa located at 2201 University Blvd, Tuscaloosa, Alabama, 35401. The funding would be used to repurpose the airport's current terminal facility. The design and condition of the 53-year-old terminal infrastructure has reached the end of its useful life and is unable to meet the current and forecasted operational needs. This project emphasizes a new vision for the current facility in order to serve the community over the next 30 to 40 years.

The project has a Federal nexus because the funding provided is for purposes authorized by 49 U.S.C. 47100 et seq.
