I am requesting funding for Aliceville Volunteer Fire Department and Police Department Facility in fiscal year 2025. The entity to receive funding is the City of Aliceville, located at 419 Memorial Pkway, Aliceville, AL, 35442. The funding would be used to construct a joint police and volunteer fire station, both of which exist in disparate locations and in older structures, creating a new community facility. This project is a priority because Pickens County does not have a hospital, meaning that first responders are often the ones saving a life. The Aliceville Police Department and Volunteer Fire Department are essential tools, and a joint building would help first responders act more immediately, cohesively, and efficiently to the community.
