

## MILITARY SERVICE ACADEMY NOMINATION CHECKLIST

In order to qualify for a nomination, you will need to submit a completed profile and return it to my Birmingham office no later than Friday, November 6, 2020. The following materials are required as part of a completed profile:

- 1. Questionnaire (Attached)
- 2. SAT and/or ACT scores (applicants must follow up with their applied to academies in order to submit their SAT and ACT scores directly)
- 3. (3) Letters of Recommendation
  - a. Letters of recommendation are written on your behalf by anyone who knows you personally. For example: a teacher, your school principal, church leader, employer, etc.
- 4. High School Transcript
- 5. Official College Transcript (if applicable)

After your application is submitted, a selection committee comprised of military leaders will review your completed profile, conduct candidate interviews, and make nominee recommendations. **Interviews will be held on Saturday, November 21, 2020**.

Our office will keep you informed as the selection process moves forward. Our **Military Preview Day** will be Thursday, October 29 via Zoom, sign up here.

It is important to keep in mind that this process is highly competitive. Please include all awards and honors earned through the first semester of your senior year in your completed profile. Please visit the website for each military service academy for testing requirements information regarding the submission of your ACT and/or SAT scores after applying. It will be your responsibility to follow up with the military service academies to update them on your most recent scores.

### **Nominations for Military Service Academies**

Thank you for your interest in the U.S. Military Service Academies. As your 7th Congressional District Representative in the U.S. House of Representatives, each year I have the privilege of nominating a limited number of people to four of the five service academies. The honor of attending a service academy comes with an obligation and commitment to serve in the military for a minimum of five years upon graduation. Best wishes to you as you pursue your goal of attending one of the U.S. Military Service Academies and serving our country.

#### **The Nomination Process**

To be considered for an appointment to a military service academy, an applicant must meet the eligibility requirements established by law and be nominated from an authorized person including a Member of the United States Senate or the House of Representatives. I can nominate applicants who are legally domiciled within the boundaries of Alabama's 7th Congressional District.

### Who Is Eligible?

An applicant for a nomination must meet the following eligibility requirements as of July 1 of the year of admission to a service academy. He or she must be at least 17 years old, but not have passed the 23rd birthday, must be a United States citizen, and must be unmarried, not pregnant, and have no legal obligation to support children or other dependents.

# **Military Service Academies**

There are five Service Academies: The United States Air Force (USAFA), Naval (USNA), Army at West Point (USMA), Merchant Marine (USMMA), and Coast Guard (USCGA) Academies. Four out of the five military service academies require Congressional nominations. The U.S. Coast Guard Academy makes appointments based on their own application and admission process. Please note that you must start an application process for all the academies you apply to as well as the nomination process through my office.
