#### Congresswoman Sewell Joins EPA Officials to Tour Testing Sites in North Birmingham



On November 19, we joined Environmental Protection Agency (EPA) Region 4 Administrator Gwen Fleming and local officials for a briefing on the North Birmingham contamination issue along with a tour of the Collegeville testing areas. On November 1, the EPA commenced a plan to test 1200+ properties in the Collegeville, Fairmont, and Harriman neighborhoods for contamination and will begin cleanup efforts if necessary. It is my sincere hope that the testing conducted by the EPA will help address the serious concerns of hazardous air and water contamination in North Birmingham. On October 31, we met with local union president Wilhemina Richardson and other union representatives from American Apparel to discuss the issues surrounding the company's impending layoffs. My office led a delegation letter to Government Accountability Office (GAO) in support of American Apparel's protest petition and we are anxiously awaiting a final decision based on their review. In order to preserve America's manufacturing and industrial sector and to ensure middle and working class jobs remain in Alabama and throughout the country, we have also requested a meeting with the White House to discuss in greater detail the impact of our economic policies on these critically important jobs. # **Social Security Disability Benefits:** *A Success Story*

In July 2011, a constituent contacted our Selma district office regarding denial of her Social Security disability benefits. She had been denied benefits twice before contacting our district office. We opened a case for her, worked closely with the Social Security Administration on her behalf and began the process for review and evaluation of benefits. In September of 2012, she received a favorable decision that she was entitled to benefits. We were able to help her receive over \$25,000 in retroactive benefits and she now receives her regular monthly benefits.
