Rep. Sewell Votes to Approve President Obama's Trade Agenda

Congresswoman Terri Sewell voted to give President Obama the authority he needs to negotiate an agreement that expands opportunities for fair trade, but says that Congress should have done more to reauthorize a key federal assistance program for displaced workers.

"I cast my vote today in support of President Obama and American workers. I believe that this President should be given the same authorities that every other President has been given to negotiate trade agreements that benefit American workers, businesses, and our economy. While I share many of the concerns of my friends in labor regarding trade, I am convinced that President Obama is committed to safeguarding our shared values and protecting American jobs. Ultimately, I believe that President Obama will protect the best interests of the American people, and the folks I represent in Alabama's 7th Congressional District. The bottom line is that President Obama has our back, and we should have his too.

"I want to thank House leadership and the Obama administration for working with me to include critically important trade enforcement provisions in the trade package which will directly benefit the steel industry and the steel workers in my district. These measures will help protect American industries, particularly steel, from unfair trade practices and provide them with the necessary tools to seek timely and effective remedies. While not a cure all, these stronger enforcement provisions are now an essential part of the framework for negotiating any trade agreement going forward.

"My vote for the Trade Promotional Authority (TPA) ensures that President Obama has the necessary tools and Congressional oversight to negotiate and present Congress with comprehensive trade agreements that increase American exports and benefit American workers. In addition, my vote to reauthorize Trade Adjustment Assistance (TAA) is a vital lifeline for displaced workers that provides access to training, employment services, and relocation allowances. However, I am deeply disappointed that Congress failed to reauthorize TAA for American workers since globalization -- irrespective of trade agreements -- has led to the need for assistance for workers who lost their jobs through no fault of their own. It is my hope that my colleagues will reconsider the TAA vote because I strongly believe that TPA and TAA go hand in hand.

"To be clear, my votes today in no way undermine Congress' role or oversight in these ongoing trade negotiations. Congress still retains the right to advise President Obama throughout the negotiations and reject any trade agreement that falls short of the criteria we have outlined. I will continue to rigorously review all trade proposals and I will oppose any trade agreement that is a bad deal for Alabama workers and businesses."

Rep. Sewell Urges House Leaders to Adopt Stronger Trade Enforcement Provisions

Congresswoman Terri Sewell urged House Leadership to adopt stronger trade enforcement laws to protect the American steel industry as a part of the trade legislation lawmakers are expected to vote on this week.

"My vote on trade legislation hinges on stronger trade enforcement provisions on antidumping and currency manipulation, which directly affect the steel industry in my district. Any trade legislation that comes before the House must contain provisions that protect American workers and industries against unfair competition and deceptive trading practices. At the very least, the House should adopt measures to timely consider anti-dumping and countervailing claims before the International Trade Commission (ITC), and provide the Department of Commerce with the flexibility to use prices that are not distorted when calculating dumping," said Rep. Sewell.

"The steel industry supports an estimated 63,000 jobs across Alabama, and is one of the largest employers in the 7th Congressional District of Alabama. We cannot afford to lose even one job because other countries are not playing by the rules.

"One-sided trade practices like dumping and currency manipulation are hurting American businesses, particularly our steel industry, and the U.S. trade remedy laws only correct the problem after the fact. By the time that the process has been completed, American workers have already been laid off and our businesses have already lost their market share.

"American industries should not be forced to compete on an uneven playing field. Unfair trade practices hurt our domestic economy and our competitiveness abroad."

USDA Seeks Applications for Grants to Help Socially-Disadvantaged Producers

WASHINGTON, May 26, 2015 - Agriculture Secretary Tom Vilsack today announced that the U.S. Department of Agriculture (USDA) is now accepting applications to provide technical assistance to socially-disadvantaged groups in rural areas.

"These grants will help socially-disadvantaged business owners develop the tools and skills they need to grow their enterprises and succeed at creating jobs and expanding economic opportunities in rural areas," Vilsack said. "American agriculture is becoming increasingly diverse in many ways, with more minorities and women seeking to enter the field, as well as greater diversity in the age of farmers, the size of operations, in production methods, and in the types of crops being grown. All of these forms of diversity help strengthen U.S. agriculture for the future."

Funding will be made available through USDA's <u>Socially-Disadvantaged Groups Grant Program</u> (formerly the Small, Socially-Disadvantaged Producer Grant Program), which assists organizations that provide technical assistance to socially-disadvantaged groups in rural areas. Examples of technical assistance are conducting feasibility studies, developing business and strategic plans, and providing leadership training.

USDA plans to make up to \$3 million in grants available. The maximum award under this notice is \$175,000. More information on how to apply can be found on page 28937 of the May 20 <u>Federal Register</u>. Applications submitted by mail must be postmarked by July 20, 2015. Electronic applications must be submitted at <u>www.grants.gov</u> no later than midnight Eastern Time July 14, 2015.

Eligible applicants include groups of cooperatives, cooperative development centers and individual cooperatives that serve socially-disadvantaged groups. The cooperatives or centers can be located in any area, but the groups assisted must be located in an <u>eligible rural area</u>. Also, the majority of the governing body of the organization must be compromised of individuals who are members of socially-disadvantaged groups.

USDA Rural Development is encouraging applications for projects in census tracts with poverty rates of 20 percent or higher. All grants are awarded through a national competition.

The program is making a difference in many rural areas. For example, in 2013, the Southern California Focus on Cooperation (SCFC) received a \$200,000 Small, Socially-Disadvantaged Producer Grant to provide technical assistance to help 95 refugee immigrant and minority farmers improve their productive capacity, increase revenue, and strengthen their ability to govern and manage their cooperative businesses.

Many of the farmers benefiting from the project had little or no access to formal schooling and had been persecuted and oppressed for years in their native land. The International Rescue Committee (IRC), in concert with SCFC, developed marketing channels including various farmers markets and restaurants where the refugee farmers could sell their produce. Farmers have learned how to manage these marketing channels themselves, without assistance from IRC, and have gained new clients. They have also increased the level of cooperation among Hispanic, Korean and African farmer groups. These groups are working toward merging their efforts to form a single cooperative. The technical assistance provided by SCFC has enabled these farmers to build skills that have truly been life changing.

USDA Announces Funding Opportunity for Distance Learning and Telemedicine Projects

WASHINGTON, May 22, 2015 - Agriculture Secretary Tom Vilsack today announced that the U.S. Department of Agriculture (USDA) is accepting applications for its <u>Distance Learning and Telemedicine</u> (DLT) grant program, which provides increased access to education, training and health care resources in rural areas.

"This program provides people who live and work in rural areas with better access to a variety of educational and health care services," Vilsack said. "For example, because of the DLT program, students in rural areas can take advanced placement classes, residents can have access to specialized medical services not typically available, and many other benefits for rural communities."

USDA's Rural Utilities Service, a Rural Development agency is making \$19 million available for fiscal year 2015. The Distance Learning and Telemedicine Program finances telecommunications equipment, computer networks and advanced technologies for use by students, teachers, medical professionals and rural residents. Minimum grant amounts are \$50,000; maximum amounts are \$500,000 for fiscal year 2015.

Since 2009, USDA has provided more than \$182 million to expand access to learning at nearly 4,700 rural educational facilities and to improve delivery of medical care at more than 2,500 rural health facilities.

Details of the DLT funding are on Page 29602 of the May 22 <u>Federal Register</u>. The application deadline is July 6, 2015.

Department of Justice's Office of Community Oriented Policing Services releases final task force report, opens 2015 grant solicitations

Grants to focus on task force objectives

WASHINGTON, DC - The Office of Community Oriented Policing Services today announced the release of the final report from the President's Task Force on 21st Century Policing. On Dec. 18, 2014, President Barack Obama signed an executive order establishing the task force and charged it with identifying best practices and recommendations on how policing practices can promote effective crime reduction while building public trust. The task force sought expertise from stakeholders and input from the public to make recommendations, which are included in the final report.

"This report includes tenable solutions for every community across this nation, whether large or small," said COPS Office Director Ronald Davis. "The remarkable 11 individuals that made up this task force were able to build consensus around some of the most challenging topics in policing."

The COPS Office today also announced five separate Fiscal Year 2015 grant funding opportunities now open to the field for submission of applications. Agencies applying for funding are strongly encouraged to incorporate the recommendations of the President's Task Force on 21st Century Policing into the community policing strategies proposed in their applications. Grants will provide a total of up to \$163 million to state, local, territory and tribal law enforcement agencies to meet a variety of resource needs, including sworn officer positions, training and technical assistance, and expansion of problem-focused task forces.

The 2015 COPS Hiring Program is a competitive grant program that funds the hiring or rehiring of law enforcement officers. CHP provides 75 percent of the approved entry-level salaries and fringe benefits of each newly hired and/or rehired full-time officer, up to \$125,000 per officer position, over the three-year (36 month) grant period.

The 2015 Community Policing Development Program advances the practice of community policing in law enforcement agencies through training and technical assistance, the development of innovative community policing strategies, applied research, guidebooks and best practices that are national in scope. The CPD solicitation is designed to address critical topics in the law enforcement field by building on the principles of community policing.

The 2015 COPS Anti-Gang Initiative funds regional, multijurisdictional anti-gang task forces comprised of federal, state and local law enforcement agencies to address gang activity, focusing on enforcement, prevention and education and intervention.

The 2015 Anti-Heroin Task Force Program assists state law enforcement agencies in states with high per capita levels of primary treatment admissions for both heroin and other opioids. AHTF funds shall be used for investigative purposes to locate or investigate illicit activities related to the distribution of heroin or unlawful distribution of prescription opioids.

The 2015 COPS Anti-Methamphetamine Program advances public safety by providing funds directly to state law enforcement agencies to investigate illicit activities related to the manufacture and distribution of methamphetamine.

Applications for all programs are due by 7:59 p.m. EDT on June 19, 2015 and are available through the COPS Office website.

USDA Seeks Applications to Expand Economic Development in Rural Communities

Washington, District of Columbia, May 15, 2015 —

Agriculture Under Secretary Lisa Mensah today announced that USDA is seeking applications for grants to support rural community economic development.

"This funding from USDA will ensure that technical and financial assistance is available for those who wish to improve the quality of life in rural communities," Mensah said. "Very often, great visions for better rural communities exist, but the next steps toward positive change are unclear. These grants will help rural communities build a path to community economic development so rural America can share in the nation's economic recovery."

Approximately \$10.4 million is being made available under the <u>Rural Community Development Initiative (RCDI) program</u>. Eligible applicants include public, private, and non-profit intermediaries, and federally recognized tribes.

RCDI grants can be used to provide training or technical assistance. Training may be focus on homeownership education, minority business entrepreneurship, strategic community planning or accessing alternative funding sources. Intermediary organizations must provide matching funds at least equal to the RCDI grant. Grants range from \$50,000 to \$250,000.

USDA has invested more than \$33 million through the RCDI program since 2009. In 2013, the Choctaw Nation of Oklahoma received a \$150,000 grant to provide home buying and home maintenance education to 50 Native American women in the community of Broken Bow.





The online Veterans Employment Center is the single federal source for Veterans looking for new career opportunities in the private and public sectors, as well as Service Members transitioning to the civilian workforce, military and Veteran spouses and dependents looking for employment opportunities, GI Bill beneficiaries transitioning from training to the job market and employers looking to connect with high quality applicants. It is the first interagency tool that brings together public and private job opportunities with resume building and other career tools currently offered on a variety of websites together in one place. Through the online Veterans Employment Center, Veterans, transitioning Service Members and spouses are connected to high quality career choices by matching their identified skills with available public and private job opportunities. The site is built using an open application programming interface (API) to attract private sector innovation.

- Target job search based on specific, high-demand career paths
- Single search for both public and private sector positions

In connection with the First Lady and Dr. Biden's Joining Forces initiative, the Department of Veterans Affairs worked with the Departments of Defense, Labor, and Education, and the Office of Personnel Management to design and develop the site and incorporate features of existing online employment tools at each agency. The result is an upgrade to the existing Veterans Job Bank and an integrated solution connecting Veterans, transitioning Service Members and employers.
