## **Voting Rights Activist Sheyann Webb-Christburg Joins Rep. Sewell at the State of the Union**

In recognition of the need to restore the full protections of the Voting Rights Act of 1965, Congresswoman Terri Sewell has invited Sheyann Webb-Christburg of Montgomery – who at 8 years old was the youngest Foot Soldier to march from Selma to Montgomery in the name of voter equality – as her special guest for President Obama’s final State of the Union address.

“The State of Union falls on ‘Restoration Tuesday’ and I believe Sheyann Webb-Christburg is the embodiment of the struggle for voter equality in America. My hope is that her presence at the President’s address will remind us of the modern day fight for ensuring that every American citizen has access to the ballot box. The closure of DMV offices in Alabama last year proves that barriers to voting still exist and that Congress should pass the Voting Rights Advancement Act now!

“At an early age, Sheyann recognized that America failed to live up to its own promise by depriving African-Americans of their right to vote. Sheyann’s bravery reminded those around her that they were fighting for the next generation – her generation – as fervently as they were fighting for their own. Her courage also made it possible for me to represent our hometown of Selma in Congress. And as my childhood babysitter, I have literally grown up in her shadow. I am thankful to call Sheyann my friend, and honored to have her as my special guest for President Obama’s last State of the Union. Her presence should once again serve as a reminder of the importance of the vote,” said Rep. Sewell.

This will be Sheyann Webb-Christburg’s first time attending the State of the Union.

“I am very grateful, honored, and blessed to be given the opportunity by Congresswoman Terri Sewell to share in such an historical moment. It is my hope that President Obama will reflect on the progress that has been made since he took office, and outline his vision for our nation,” said Sheyann Webb-Christburg.

“Our nation has come a long way, but we still have a long way to go to. Federal voting protection is critical, and urgently needed. Recent experiences have shown us that disenfranchisement still poses a threat to our democracy. It saddens me to know that this is still an issue 50 years later. The struggles, blood, sweat, and tears of the 1960’s were too horrific and unjust for us to take any steps backwards. We must continue to educate and fight to protect this privilege and this right,” she continued.

### ***Background on Restoration Tuesday:***

*On Restoration Tuesday, Members of Congress are encouraged to speak on the floor in support of restoring the landmark Voting Rights Act of 1965. RestorationTuesday is the opportunity for Members to bring attention to modern day barriers to voting and urge passage of the Voting Rights Advancement Act of 2015 (H.R. 2867) which provides a modern day formula for federal preclearance protection.*

## **Rep. Sewell Opposes the House GOP's 62nd Attempt to Repeal or Undermine the ACA**

Today, Congresswoman Terri Sewell issued the following statement after voting against the so-called "Restoring Americans' Healthcare Freedom Reconciliation Act":

"The Restoring Americans' Healthcare Freedom Reconciliation Act is House Republicans' 62nd attempt to undermine or repeal the Affordable Care Act (ACA). We cannot afford to waste time on a bill that is destined for a veto, particularly when there are much more pressing issues facing our great nation.

"This bill is designed to take health insurance from 22 million uninsured Americans. It would cut the subsidies provided to low and middle income Americans living with diabetes and other diseases. Among its most dangerous provisions is a measure to repeal the Medicaid expansion. Alabama has yet to expand its Medicaid program, and my constituents are among those who have been hardest hit by state lawmakers' inactions.

"To add insult to injury, the bill would restrict access to family planning, wellness exams, and life-saving cancer screenings from millions of American women. This issue is very personal to my constituents, particularly those who have to drive through two counties to deliver a baby. For women in Sumter County, that's as far as Tuscaloosa, which is an hour away.

"Before passage of the ACA, we were spending more money per patient than any country in the world. Under the law, health care prices have grown at the slowest rate in 50 years. While the Affordable Care Act is not perfect, there are millions of Americans who now have access to quality healthcare and are leading healthier lives because of it. In this New Year, Congress should resolve to find solutions that benefit all Americans, not just the privileged few."

## **Reps. Terri Sewell and Jeff Duncan Place Friendly Bi-partisan Wager on the Top Collegiate Football Game of the Season**

As the University of Alabama and Clemson University vie for the NCAA College Football National Championship, Congresswoman Terri Sewell (AL-07) and Congressman Jeff Duncan (SC-03) made a friendly wager on which team would win this year's title. At stake – barbecue and bragging rights.

"My colleague Congressman Jeff Duncan is a brave soul for accepting this friendly wager. Given Alabama's unparalleled record of 15 National Championships, the Crimson Tide is destined to bring home another title in 2016. The Clemson Tigers simply will not be able to hold back Heisman Trophy winner Derrick Henry and the Tide's superior defense," said Congresswoman Sewell. "Football and barbecue go hand-in-hand, and Alabama has the best of both. It is too bad that Congressman Duncan and his staff won't be able to savor Alabama's delicious ribs. Roll Tide!"

"I commend my good friend Congresswoman Sewell for the tremendous risk she has undertaken by betting against the topped ranked team in the country, the Clemson Tigers. Unfortunately for the Congresswoman, Heisman Trophy winner Derrick Henry does not play defense because they will need an extra defender as Deshaun Watson puts the Tide defense on ice skates. The Tide has turned in college football. I look forward to having Congresswoman Sewell join me and my office for some delicious Dreamland Bar-B-Que ribs! Go Tigers!" said Congressman Duncan. If the University of Alabama's Crimson Tide secures a victory, Congressman Duncan has agreed to wear the trademark Bear Bryant houndstooth hat and an Alabama necktie for a photo on the steps of the U.S. Capitol, and will provide South Carolina barbecue for the Congresswoman and her office.

Should Clemson University's Tigers win, Congresswoman Sewell has agreed to treat Congressman Duncan's office to ribs from the famous Dreamland Bar-B-Que in Tuscaloosa, and will pose for a picture on the U.S. Capitol steps dressed in Clemson apparel.

## **Rep. Sewell Responds to President Obama's Executive Actions to Promote Gun Safety**

Congresswoman Terri Sewell issued the following statement after President Obama unveiled a series of common sense measures to curb gun violence.

"Our nation must take common sense actions to stem the rising tide of gun violence that has claimed far too many lives. Effective policies should make it harder for criminals and those with a history of serious mental illness to obtain a gun, but such policies cannot restrict a law-abiding citizen's right to bear arms. Unfortunately, Congress has repeatedly failed to pass gun safety measures that would protect our communities while defending responsible gun ownership.

"I am a strong defender of the Second Amendment, however, the status quo is not working and we cannot stand by and do nothing while mass killings continue to occur in America. In the face of Congressional inaction, President Obama has announced a series of common sense measures such as closing the gun show loophole, increasing mental health treatment, and mandatory dealer reporting on stolen firearms—all measures that will make our communities safer.

"While I understand the concerns that some of my constituents have regarding President Obama's executive orders, I also recognize that we must strike a balance between gun ownership and gun safety. To be clear, I do not support any legislation or executive orders that threaten our constitutionally protected rights. I believe that President Obama's executive orders meet this criteria and are in line with the majority of American's views on this issue. My hope is that we can set aside party politics and work together in the best interests of our nation to reduce gun violence and protect all Americans."

## **Rep. Sewell Issues Statement on Tornado Damage in Southwest Birmingham**

Today, Congresswoman Terri A. Sewell released the following statement on the heavy storms and tornadoes that affected the Southwest Birmingham area on Christmas Day.

"My heart is with those impacted by the tornado that swept across parts of Southwest Birmingham on Christmas Day. We have been through similar tragedies together, and we know what is possible when communities come together in times of need.

"I have been in touch with local officials throughout the affected area, and my staff is working with local and state officials to help assess the extent of the damage and to assist with any recovery efforts. I am especially thankful for the work that Hopewell Baptist Church, Pastor E. E. Rodgers, Commissioner Sandra Little Brown and countless others have done to provide immediate assistance to those in need.

"My office and I are in contact with the Governor's office and the State EMA to monitor the situation. We are working with local, state, and federal officials to bring assistance to those affected."

## HUD OFFERS NEXT ROUND OF PLANNING GRANTS TO HELP TRANSFORM COMMUNITIES

*Choice Neighborhoods Planning Grants to help communities revitalize distressed areas*

WASHINGTON – Today, the U.S. Department of Housing and Urban Development (HUD) announced the availability of new funding to help local communities across the country to redevelop severely distressed public and HUD-assisted housing and transform surrounding neighborhoods. The funding announcement introduces an additional, innovative component to the [Choice Neighborhoods Planning Grant](#), called Planning and Action Grants.

Grants of up to \$2 million will enable communities to create a locally driven plan to transform struggling neighborhoods, as well as implement early improvements, such as reclaiming vacant property and attracting new businesses. [Read HUD's funding notice.](#)

“HUD’s mission of expanding opportunity extends beyond a family’s front door to the neighborhoods where they live,” said HUD Secretary Julián Castro. “These grants will let local leaders create homegrown plans to strengthen their neighborhoods and to take those first vital steps to turn their plans into reality.”

Choice Neighborhoods is HUD’s signature place-based initiative in support of the President’s goal to build Ladders of Opportunity to the middle class. Choice Neighborhoods is focused on three core goals:

- **Housing:** Replace distressed public and assisted housing with high-quality mixed-income housing that is well-managed and responsive to the needs of the surrounding neighborhood.
- **People:** Improve educational outcomes and intergenerational mobility for youth with services and supports delivered directly to youth and their families.
- **Neighborhood:** Create the conditions necessary for public and private reinvestment in distressed neighborhoods to offer the kinds of amenities and assets, including safety, good schools, and commercial activity, that are important to families’ choices about their community.

Up to now, Choice Neighborhoods Planning Grant funds could only be used to create a neighborhood Transformation Plan. However, experience with the 63 previously awarded Choice Neighborhoods Planning Grantees has shown that tangible, early actions help sustain community energy, attract new resources, and build momentum to turn that plan into reality.

HUD’s FY15/16 Choice Neighborhoods Planning Grant funds build upon these lessons by introducing Planning and Action Grants. Under these grants, communities with severely distressed public or HUD-assisted housing will continue to develop a successful neighborhood transformation plan and build the support necessary for that plan to be successfully implemented. In addition, Planning and Action Grant funds will also enable activities including:

- Reclaiming and recycling vacant property into community gardens, pocket parks, farmers markets, or land banking;
- Beautification, place making, and community arts projects;
- Homeowner and business façade improvement programs;
- Neighborhood broadband/Wi-Fi;
- Fresh food initiatives; and
- Gap financing for economic development projects.

Through the Choice Neighborhoods planning process local governments, housing authorities, residents, nonprofits, tribal authorities, private developers, school districts, police departments, and other civic organizations create a common vision and develop effective strategies to revitalize their neighborhood. The resulting Transformation Plan and locally driven Action Activities lay the foundation for revitalizing the distressed public and/or assisted housing units, transforming the surrounding neighborhood, and promoting opportunities for families.

Today, Choice Neighborhoods Planning Grantees can be found across the country in cities and towns, such as Kansas City, Missouri, Norwalk, Connecticut, and Sacramento, California. Several Planning Grantees have already launched neighborhood improvements that provided the inspiration for Planning and Action Grants. For example, in Salisbury, North Carolina, partners expanded a Mobile Fresh Farm to residents, spurring a nearby college to open a new culinary school that will provide mentoring to local students and sell surplus produce at discount prices. In Columbus, Ohio, partners created a gateway to the community by redeveloping a highway bridge and creating a mural wall with a history of the neighborhood.

Choice Neighborhoods Planning Grant funds are available for public housing authorities, local governments, nonprofit organizations, and tribal entities. Applicants must submit a completed electronic application through [www.grants.gov](http://www.grants.gov) by February 9, 2016. [Read HUD's funding notice.](#)

The Citizens' Institute on Rural Design™ (CIRD) has issued a request for proposals to rural communities interested in applying for funding to host a community design workshop in either 2016 or 2017.

The Citizens' Institute on Rural Design™ is a National Endowment for the Arts leadership initiative in partnership with the U.S. Department of Agriculture and Project for Public Spaces, Inc., along with the Orton Family Foundation. CIRD provides communities access to the resources they need to convert their own good ideas into reality.

CIRD offers annual competitive funding to six small towns or rural communities to host a two-and-a-half day community development and design workshop. With assistance from a wide range of design, planning, and creative placemaking professionals, the workshops are intended to bring together local leaders from non-profits, community organizations, and government agencies to develop actionable solutions to the communities' pressing development challenges. The communities will receive additional support through webinars, conference calls, and web-based resources on [www.rural-design.org](http://www.rural-design.org).

Design and development challenges include but are not limited to the following: Main Street revitalization, managing and shaping community growth, the design of community-supportive transportation systems, preservation of natural and historic landscapes and buildings, protecting working agricultural lands, and maximizing the role of arts and culture as an economic driver for local and regional economies. Since 1991 CIRD has convened more than 70 workshops in all regions of the country, empowering residents to leverage local assets today in order to build better places to live, work, and play in the future.

**The deadline for submitting a proposal is Tuesday January 12, 2016 at 11:00 pm EST.** Successful applicants will receive a \$10,000 stipend (that must be matched one-to-one) in addition to in-kind professional design expertise and technical assistance **valued at \$35,000.** The Request for Proposals is posted on the CIRD website: [www.rural-design.org/request-for-proposals](http://www.rural-design.org/request-for-proposals). Selected communities will be announced in March of 2016 and workshops will be held during the fall of 2016 through spring of 2017.

Each year, approximately ten ensembles of three to five musicians working in traditional American genres are selected to conduct regional cultural exchange tours in Africa, Asia, Eastern Europe, Central and South America, and the Middle East for approximately a month. For the purpose of this program, traditional American genres are defined as including, but not limited to, Contemporary Urban, Hip Hop, Rock & Roll, Indie Rock, R&B, Jazz, Blues, Broadway Musical Theater, and American roots music genres like Country, Gospel, Soul, Bluegrass, Zydeco, Cajun, Afro-Caribbean, Tejano, Southwestern American Conjunto, Native-American, and Folk.

AMA tours operate under the official auspices of the U.S. government. The State Department funds international travel, hotels, and an allowance for meals and incidental expenses. In addition, a tour honorarium of \$200 per day for expenses incurred while on the road will be awarded to each musician in an ensemble. American Voices organizes the tours with the input of ECA/State Department and participating U.S. embassies and consulates.

Musicians must be at least 18 years of age, a citizen of the U.S., and either hold or be able to obtain a valid U.S. passport.

Applications must be submitted by **January 24, 2016**. Finalists will be announced in late January/early February, and live auditions will be held March 14–19 in New York City and March 18 in San Francisco. Final ensembles will be selected by April 4.

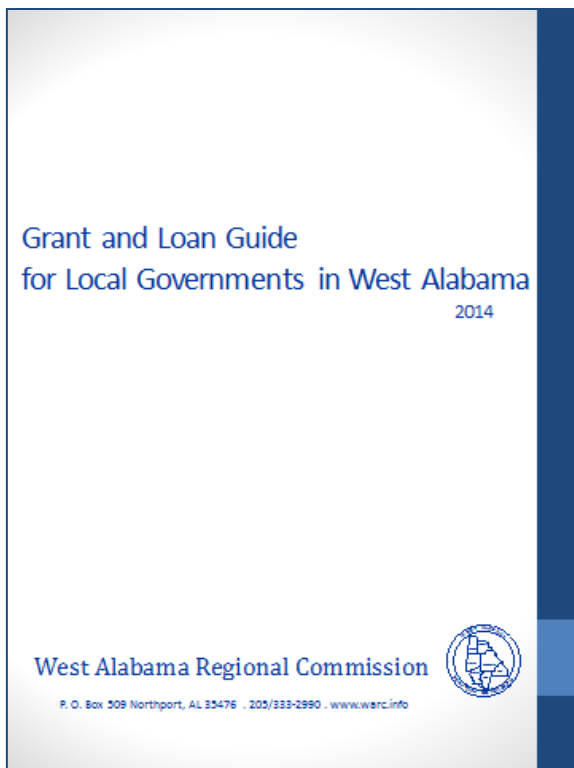

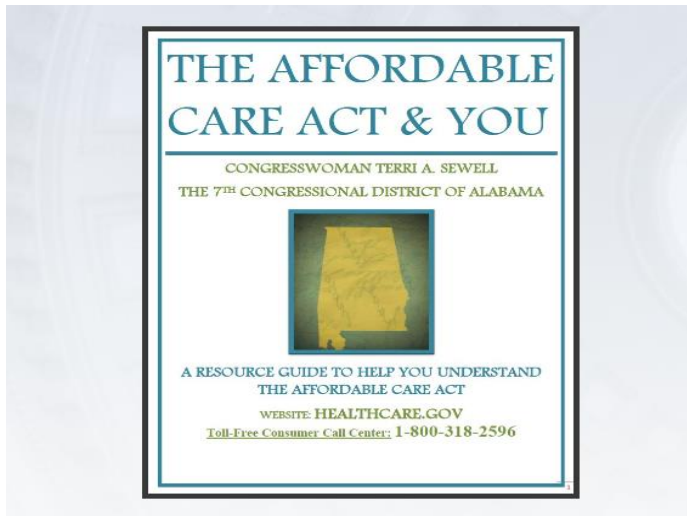

Through the online Veterans Employment Center, Veterans, transitioning Service Members and spouses are connected to high quality career choices by matching their identified skills with available public and private job opportunities. The site is built using an open application programming interface (API) to attract private sector innovation.
