*Rep. Sewell congratulates the military service applicants she nominated*

**WASHINGTON, D.C.** – U.S. Rep. Terri Sewell (AL-07) congratulated the three outstanding young people she nominated to and accepted appointments to the United States service academies in 2019. Each year, Rep. Sewell nominates a group of young Alabamians who embody the core principles of the armed forces to compete for highly selective spots in the nation’s five service academies. A nomination signifies superior academic, physical and leadership abilities and a demonstrable commitment to service.

“I am truly honored to be able to support our young leaders of tomorrow in their aspirations toward higher service,” **said Rep. Sewell.** “There is no path more admirable than that of protecting our country. ## [Rep. Sewell Named to Key Trade Task Force](#)

*Sewell one of Nine Democratic Members of Congress to negotiate improvements of U.S.-Mexico-Canada trade agreement*

**WASHINGTON, D.C.** – U.S. Rep. Terri Sewell (AL-07) released the following statement today after Speaker of the House Nancy Pelosi appointed her to the House Democrats’ trade Working Group, a task force charged with negotiating improvements to the new U.S.-Mexico-Canada trade agreement:

“I am honored that Speaker Pelosi and Chairman Neal have selected me to join the task force charged with making tangible improvements to the new trade agreement with Mexico and Canada.

“The task force has a lot of work ahead of it, however, I am optimistic we can work with United States Trade Representative Robert Lighthizer to ensure the new trade agreement grows the American economy, protects workers and strengthens our relationships with our neighbors.”

Sewell, a member of the House Ways & Means Subcommittee on Trade, will work with Rep. Rosa DeLauro to improve the trade agreement’s enforcement capabilities. Reps. Earl Blumenauer and Jan Schakowski will head the drug pricing team; Reps. Jimmy Gomez and Mike Thompson will lead the labor group; Reps. Susan Bonamici and John Larson will work on environmental issues; and Chairman Richard Neal will oversee the task force in its entirety.

## House Intelligence Committee Unanimously Approves Intelligence Authorization Act

*Bill includes Sewell provision to improve federal campaign security*

**WASHINGTON, DC** – Today, the House Permanent Select Committee on Intelligence approved the Damon Paul Nelson and Matthew Young Pollard Intelligence Authorization Act (IAA) for Fiscal Years 2018, 2019, and 2020, by unanimous voice vote. The bill authorizes funding and enables comprehensive congressional oversight of elements of the U.S. Intelligence Community (IC), and includes a provision authored by U.S. Rep. Terri Sewell (AL-07), chair of the Subcommittee on Defense and Warfighter Support, aimed at improving federal campaign election security.

“When it comes to securing our elections, nothing less than our democracy is at stake. The Intelligence Community agrees that unless the United States acts, Russia and others will continue to attack our elections,” **Sewell said**. “Arming our federal campaigns and the public with the knowledge and resources to best protect themselves from cyber-attacks is a commonsense step to protect the integrity of our elections.”

Sewell’s provision would require the Director of National Intelligence (DNI) to work with the Under Secretary of Homeland Security for Intelligence and Analysis and the Director of the Federal Bureau of Investigation (FBI) to make available an advisory report on foreign counter-intelligence and cybersecurity threats to election campaigns for federal offices. Additionally, it would require the DNI work jointly to publish a summary of best practices that federal campaigns can employ to counter such threats.

In the event that Director of the Federal Bureau of Investigation and the Under Secretary of Homeland Security for Intelligence and Analysis jointly determine that a federal election campaign is subject to a heightened foreign counterintelligence or cybersecurity threat, the provision would allow them to make available additional information to those campaigns to help thwart outside interference.

## Rep. Sewell Praises House-Passage of Election Security Measures

**WASHINGTON, D.C.** – U.S. Rep. Terri Sewell (AL-07) announced today the House passage the SAFE Act, an election security bill that provides \$600 million for election security grants to states to improve the security of elections for federal office and increases funding for the Election Assistance Commission operating expenses by more than 75 percent.

“The integrity of our democracy – and national security – depend on our ability to protect our elections from foreign interference. In 2016, Russia waged an unprecedented attack on our election and there is no question that they and other bad actors will continue to work tirelessly to influence future American elections,” **Sewell said.** “The SAFE Act makes critical investments to ensure our election systems are resilient against future attacks. We as a Congress have a duty to ensure that every vote is counted and restore the American public’s faith in our election systems.”

The SAFE Act provides funding for states to replace outdated and vulnerable voting equipment, mandates paper ballot voting systems and risk-limiting post-election audits and contains strict cybersecurity requirements for election technology vendors and voting systems.

The legislation now heads to the Senate for consideration.

## [Reps. Sewell, Smith Introduce Bipartisan, Bicameral Rural Jobs Act](#)

*Legislation provides \$500 million to boost investment in rural and distressed communities*

**WASHINGTON, D.C.** – U.S. Reps. Terri Sewell (AL-07) and Jason Smith (MO-08) and Sens. Mark Warner (D-VA), Roger Wicker (R-MS), Shelley Moore Capito (R-WV) and Ben Cardin (D-MD) today introduced the Rural Jobs Act, legislation that would increase New Markets Tax Credit (NMTC) allocations to spur economic revitalization in rural economies, creating jobs and opportunities, and improving services and facilities.

Specifically, the legislation would authorize an additional \$500 million in NMTC allocation per year for 2019 and 2020 for certain rural areas. The new allocation would target Rural Jobs Zones, which are NMTC-eligible census tracts in rural communities that are eligible for the United States Department of Agriculture (USDA) Business & Industry program. At least 25 percent of the new allocation would be prioritized for persistent poverty counties and high-migration rural counties.

“Alabama’s 7th District knows from experience that the New Market Tax Credit is a proven, cost-effective incentive that spurs investment in areas like Aliceville, where the credit helped transform the Huyck Felt brick plant into a new wood pellet manufacturing facility, creating 275 jobs, and Selma, where the program helped create 55 jobs at a biomass processing facility,” **Rep. Sewell said**. “Too many small towns are struggling to survive, which is why it is critically important that we expand the NMTC to incentivize investment in rural areas and, especially, persistent-poverty rural areas like many of those in the Black Belt to help ensure these communities are not left behind.”

“The Rural Jobs Act will allow for new economic opportunities in the areas of our country that need it the most,” **Rep. Smith said**. “By building on the success of the New Markets program, the Rural Jobs Act will bring investment to rural communities with persistent poverty and high migration. It is too often that rural communities are overlooked by Washington. This legislation is a targeted approach that will encourage investment in rural America.”

“During my time as Governor and in the Senate, I’ve supported initiatives to help create jobs and boost economic opportunity for all Virginians,” **Sen. Warner said**. “There’s a lot happening in parts of Southwest and Southside Virginia, but we still have more work to do to ensure that no part of Virginia is left behind. That’s why I’m proud to introduce this legislation to set aside additional tax credits for rural and underserved regions.”

“In Maryland, the New Markets Tax Credit has been deployed throughout our state on a diverse range of infrastructure and community development efforts. I am pleased to support this bipartisan legislation, which will further the reach of the program to low-income rural communities, creating jobs and stimulating our economy across Maryland and across America,” **said Sen. Cardin**.

“The Rural Jobs Act would be an important addition to the successful New Market Tax Credit program, which has spurred tens of billions in private investment in many distressed communities across America,” **Sen. Wicker said**. “The legislation we have introduced today would help boost these

investments in rural areas and ensure that every community is receiving a proportionate share of the benefits of the NMTC.”

“The New Markets Tax Credits program has played a vital role in helping economically distressed communities in West Virginia attract the private capital needed for economic development investments,” **Sen. Capito said.** “The Rural Jobs Act expands upon this already powerful tool by ensuring these investments occur in the communities that need them the most. I’m proud to support this legislation that I know will go a long way in providing the boost these areas of West Virginia need.”

NMTCs provide private investors with a 39 percent credit against federal income taxes for investments made in some of the most distressed communities in the nation. To be eligible for NMTC financing, businesses being financed must, at a minimum, be located in designated low-income communities, defined by U.S. Census data as census tracts with a poverty rate of at least 20 percent, or with median family incomes that do not exceed 80 percent of area median income.

## [Reps. Sewell, Fitzpatrick, Crow and Calvert launch ALS Caucus](#)

### *Newly Formed ALS Caucus Seeks To Find A Cure For ALS, Which Could Unlock The Key To Many Neurological Diseases*

**WASHINGTON, D.C.** – Today, Reps. Terri Sewell (D-AL-07), Brian Fitzpatrick (R-PA-01), Jason Crow (D-CO-06) and Ken Calvert (R-CA-42) launched the ALS Caucus to bring together members of Congress from both sides of the aisle to share experiences, exchange ideas, and work collaboratively to find a cure for amyotrophic lateral sclerosis (ALS). The caucus was formed with the help of I AM ALS and many ALS advocacy groups, including The ALS Association and others.

“The launch of the ALS Caucus is welcome news in the fight against such a debilitating disease,” said **Rep. Fitzpatrick**. “There are approximately 5,000 new ALS diagnoses per year in the United States, each one bringing a new set of challenges and difficulties to American families. They need our support on the federal level to support enhanced research and treatment options, and I am proud to lead the ALS Caucus with Representatives Calvert, Crow, and Sewell to be their voice in Congress.”

“ALS is a disease that brings immense challenges and heartbreak to many families,” said **Rep. Calvert**. “The new ALS Caucus is being launched to find policy solutions to help afflicted families and bring more resources to the table to find a cure. I am eager to work with my House colleagues and all ALS-stakeholders as we embark on this important mission.”

“ALS is a disease that knows no stranger. In my own family, we lost our dear cousin Jeff to the disease and studies show veterans of the Gulf War are twice as likely to develop ALS. It is clear that more research needs to be done to fully understand this vicious disease and find a cure,” said **Rep. Crow**. “With 15 Americans diagnosed with ALS every day, my colleagues and I are ready to find a path forward and provide a renewed focus to funding scientific research. We owe this to every member of our community who should not have to face any disease without hope for a cure.”

“Every 90 minutes, someone in the United States is diagnosed with ALS and another person passes away from it,” said **Rep. Sewell**. “As co-chair of the new ALS Caucus, I am committed to ensuring patients and families have the resources they need to access adequate care and, eventually, a cure for this debilitating disease.”

ALS is a progressive neurodegenerative disease that affects the body’s motor neurons causing decreased mobility and eventually leads to death. The ALS Caucus will raise awareness about the challenges faced by ALS patients and their families, think creatively about policy solutions to reduce the negative impacts of ALS, and invest in groundbreaking research to end ALS.



## [Rep. Sewell Secures Additional \\$718 Million to Upgrade Rural Wastewater Systems](#)

**WASHINGTON, D.C.** – U.S. Rep. Terri Sewell (AL-07) announced today the House passage of over \$718 million in federal funding she helped secure for rural water and wastewater loan and grant programs for Fiscal Year 2020. Specifically, this funding bill includes \$15 million for the grant program created by Sewell’s Rural Septic Tank Access Act that passed in last year’s Farm Bill to help rural families afford decentralized wastewater systems and septic tanks.

“Every single American deserves access to basic water and sewer sanitation systems and, yet, families living in rural areas – from California, to Alabama, to West Virginia – struggle to afford necessary upgrades to their septic systems,” **Sewell said.** “I have been working for years to provide additional funding to replace failing septic systems and I am proud the funding the House passed today will go to work to improve the lives of Americans and Alabamians living in rural communities.”

Included in the \$718 million the House approved today is \$15 million specifically allocated to expand funding for the Rural Septic Tank Access Act, legislation introduced by Sewell and included in the 2018 Farm Bill to provide grants of up to \$15,000 for rural low- and moderate-income households for the construction and repair of decentralized wastewater systems, including septic tanks. By expanding this program, Congress will strengthen existing federal resources to assist in the financing of wastewater systems for rural Americans not serviced by municipal wastewater treatment systems.

In addition to the \$718 million in federal funding she secured today, Sewell was also successful in passing an amendment to add and remove funding from the Rural Water and Waste Disposal Program Account within USDA’s Rural Utilities Service to prioritize USDA’s ongoing efforts to address inadequate wastewater infrastructure in rural and unincorporated communities, specifically those where families or individuals have straight-pipe septic systems or failing decentralized sewage treatment systems.

Sewell has shown a years-long commitment to improving failing septic systems. Last March, she worked with House appropriators to secure \$1.8 billion in additional funding for water and wastewater infrastructure. In November, USDA announced Uniontown would receive \$23.4 million of that funding to repair the city’s existing wastewater treatment plant and install new infrastructure.

## House Passes Sewell-Walorski Amendment on Auto Tariffs

**WASHINGTON, D.C.** – U.S. Reps. Terri Sewell (D-AL) and Jackie Walorski (R-IN) announced today the House passage of a bipartisan amendment to the Commerce, Justice and Science funding bill calling on the Trump administration to release the Commerce Department’s Section 232 report on imported automobiles and auto parts.

“It has been over four months since the Department of Commerce submitted their Auto 232 Report to the White House, and neither Congress nor the public has seen the report,” **Sewell said.** “Unfortunately, I think I know why this Administration will not share this report. It’s because the products hard-working Americans in the auto sector design, build, sell and service are not a threat to our national security. The auto workers in my district are terrified that any day President Trump could announce tariffs that would threaten their jobs.”

Sewell has been an outspoken opponent of the Trump Administration’s proposal to dramatically raise tariffs on auto imports. She led a bipartisan group of 159 lawmakers in a [letter](#) urging Director of the National Economic Council Larry Kudlow and President Trump against imposing costly new tariffs that could harm the auto industry. Sewell and others have filed bipartisan [legislation](#) to delay auto tariffs by requiring the International Trade Commission (ITC) to conduct a comprehensive study on the economic importance of automotive manufacturing in America before tariffs on automobiles and auto parts could be applied. She is also the lead sponsor of the bipartisan, bicameral [Trade Security Act](#), which would reform Section 232 to increase Congressional oversight in the Section 232 process and reassign national security threat assessments to the Department of Defense.

The tariffs would deal a devastating blow to Alabama, where auto manufacturers are a powerful driver of the local economy. Mercedes, Honda and Hyundai assembly plants have made the state a hub for car and light truck production. According to the [Peterson Institute](#), if auto 232 tariffs were implemented and foreign countries retaliated, 624,000 jobs could be lost in the auto sector.

# Rep. Sewell Secures Federal Funding for Health Care, Education, Defense

*H.R. 3055 passes House by a vote of 225-203*

WASHINGTON, D.C. – Rep. Terri Sewell (AL-07) announced today the House passage of the Fiscal Year 2020 Labor, Health and Human Services and Education funding bill. The legislation, which now heads to the Senate for approval, includes several wins for Alabama that Sewell secured for programs critical to health care, education and defense.

“The funding bill the House passed today is a win for Alabamians living in the 7th District,” **Sewell said**. “The overall bill passed today includes \$190 billion for the U.S. Departments of Health and Human Services, Labor and Education to help expand Alabamians’ access to a competitive education, a good job and quality, affordable health care. I am proud that I was able to secure funding for several provisions critical to Alabamians, including increased capital for programs that strengthen health care delivery and access, and prepare Americans to be competitive in the workforce.”

In addition to the numerous provisions Sewell secured, the funding bill provides a total of \$41.1 billion for the National Institutes of Health (NIH), including \$3.2 billion for HIV/AIDS research; \$1.9 billion for Job Corps; and \$11.9 billion for Head Start, an increase of \$1.5 billion.

Following is a list of the provisions Sewell requested that were included in the bill the House approved today:

## Health Care

- **Federally Qualified Health Centers** – Secured more than \$1.6 billion for the Health Center program to provide primary care services in underserved areas. Federally Qualified Health Centers may be Community Health Centers, Migrant Health Centers, Health Care for the Homeless and Health Centers for Residents of Public Housing.
- **NIH National Institute on Minority Health and Health Disparities** – Secured \$341 million to advance the mission of NIH’s National Institute on Minority Health and Health Disparities (NIMHD). NIMHD leads scientific research to improve minority health and reduce health status and health care delivery, including racial groups, rural populations, low-income populations and others.
- **Interdisciplinary Rural African American Aging Research at NIH** – Secured language urging NIMHD to work with external partners to develop the infrastructure needed to conduct studies on the patterns and determinants of health and disease conditions in aging populations, with an emphasis on those living in rural America.
- **Racial and Ethnic Approaches to Community Health (REACH) Program** – Secured \$71.95 million for the Centers for Disease Control and Prevention to reduce racial and ethnic health disparities.
- **Sickle Cell Service Demonstration Program** – Secured \$7 million to increase the number of providers treating those with sickle cell disease or sickle cell related issues and increase the

number of patients receiving regular care from providers with experience treating sickle cell disease.

- **Maternal and Child Health (MCH) SPRANS Sickle Cell Program** – Secured \$3 million for the research and training of health care providers for mothers and children with sickle cell disease. According to the Children’s Hospital of Alabama, the UAB Division of Pediatric Hematology Oncology team at Children’s of Alabama cares for about 1,000 children with sickle cell disease in Alabama.
- **Rural Health Care Access** – Secured language supporting the Centers for Medicare & Medicaid Services in order to address regional disparities in health care access and quality, taking into account factors that could negatively impact the ability of hospitals to provide care for rural communities.

### Education

- **Gaining Early Awareness and Readiness for Undergraduate Programs (GEAR UP)** – Secured \$395 million for the GEAR UP program to increase the number of low-income students who are prepared to enter and succeed in postsecondary education. The program provides states with six-year grants and partnerships which in turn provide services at high-poverty middle and high schools and offers college scholarships to participating students.
- **Health Careers Opportunity Program (HCOP)** – Secured \$20 million for the HCOP, which provides grants to projects designed to increase and support opportunities for individuals from low-income backgrounds to enter health professions.
- **Minority Centers of Excellence** – Secured \$25 million for the Health Resources and Services Administration to improve the recruitment and training of minority students preparing for health profession careers.

### Defense

- **F-35A Aircraft Procurement** – Secured over \$5.1 billion for the procurement of 12 F-35 aircraft to be stationed at the Alabama Air National Guard’s 187th Fighter Wing in Montgomery.

These projects advance local economic, physical, and/or social outcomes by placing the arts at the table with other sectors, such as agriculture and food, economic development, education and youth, environment and energy, health, housing, public safety, transportation, and workforce development. The focus of the NRI-2.0 program is on ubiquity, which in this context means seamless integration of co-robots to assist humans in every aspect of life. The program supports four main research thrusts that are envisioned to advance the goal of ubiquitous co-robots: scalability, customizability, lowering barriers to entry, and societal impact. Topics addressing scalability include how robots can collaborate effectively with multiple humans or other robots; how robots can perceive, plan, act, and learn in uncertain, real-world environments, especially in a distributed fashion; and how to facilitate large-scale, safe, robust and reliable operation of robots in complex environments. Customizability includes how to enable co-robots to adapt to specific tasks, environments, or people, with minimal modification to hardware and software; how robots can personalize their interactions with people; and how robots can communicate naturally with humans, both verbally and non-verbally. Topics in lowering barriers to entry should focus on lowering the barriers for conducting fundamental robotics research and research on integrated robotics application. This may include development of open-source co-robot hardware and software, as well as widely-accessible testbeds. Outreach or using robots in educational programs do not, by themselves, lower the barriers to entry for robotics research. Topics in societal

impact include fundamental research to establish and infuse robotics into educational curricula, advance the robotics workforce through education pathways, and explore the social, economic, ethical, and legal implications of our future with ubiquitous collaborative robots. Collaboration between academic, industry, non-profit, and other organizations is encouraged to establish better linkages between fundamental science and engineering and technology development, deployment, and use. CESER employs existing NSF funding mechanisms to accomplish the program's goals such as Early-concept Grants for Exploratory Research (EAGER) and Conference proposals. GUIDANCE TO POTENTIAL PROPOSERS Science/engineering-driven collaboration. A central feature of successful CESER projects is a strong, mutually-dependent collaborative team comprising expertise in the target science/engineering discipline(s) as well as expertise in CI development and implementation. Such a collaborative approach is critical to informing and guiding the development of requirements towards the eventual development and deployment of user-centric innovative CI that fosters new pathways to discovery. Proposals pursuant to CESER should clearly identify and describe the science and engineering goals and rationale, and explain and support the potential for transformative impacts on science/engineering research and broader impacts. Proposals for technical efforts that are not well-tied to identified science and engineering research challenges as well as utilization scenarios are unlikely to be supported. Exploratory and pilot activities. CESER supports early-stage exploratory efforts that may comprise analysis, community planning, and pilot-level activities that are preparatory or informative for eventual future development and deployment of science/engineering-driven CI. Proposals for full-scale technical efforts leading to development/deployment should be directed to other appropriate NSF programs. Integrative and accelerative approaches. Proposals are particularly welcomed that address identified common needs across multiple research disciplines; leverage and accelerate the impact of existing CI investments in resources and services in one or more application domains; aim to reduce barriers to broader adoption of CI-enabled science/engineering approaches; and integrate different aspects and elements of CI to achieve holistic solutions with transformative science/engineering impact. Requirement to contact NSF Cognizant Program Officers. CESER is an inherently collaborative science/engineering-CI program. Successful CESER projects typically involve co-funding from the relevant disciplinary research programs within NSF. Consequently, before submitting a proposal to CESER, proposers must first (1) discuss their ideas with a cognizant CESER Program Officer to ensure that CESER is the appropriate venue for the proposal and (2) discuss their ideas with the relevant NSF disciplinary science and engineering research program(s) to ensure there is adequate disciplinary interest in the proposed effort. **High-Risk Research in Biological Anthropology and Archaeology – (CFDA 47.075)**

Anthropological research may be conducted under unusual circumstances, often in distant locations. As a result, the ability to conduct potentially important research may hinge on factors that are impossible to assess from a distance and some projects with potentially great payoffs may face difficulties in securing funding. This program gives small awards that provide investigators with the opportunity to assess the feasibility of an anthropological research project. It is required that the proposed activity be clearly high risk in nature. The information gathered may then be used as the basis for preparing a more fully developed research program. Investigators must contact the cognizant NSF Program Director before submitting an HRRBAA proposal. This will facilitate determining whether the proposed work is appropriate for HRRBAA support.

**Broadening Participation in Engineering – (CFDA 47.041)**

NSF seeks to strengthen the future U.S. Engineering workforce by enabling the participation of all citizens through the support of research in the science of Broadening Participation in Engineering (BPE). The BPE program is a dedicated to supporting the development of a diverse and well-prepared engineering workforce. BPE focuses on enhancing the diversity and inclusion of all underrepresented populations in engineering, including gender identity and expression, race and ethnicity (African Americans/Blacks, Hispanic Americans, American Indians, Alaska Natives, Native Hawaiians, and Native Pacific Islanders), disability, LGBTQ+, first generation college and socio-economic status. Activities must be supported by relevant data and have the capability to produce a model that can be replicated in other contexts. Develop innovative methods and projects to aggressively recruit and retain tenure track faculty from underrepresented groups. Design and transform culture to make diversity, equity, and inclusion a priority in the engineering enterprise. BPE research activities will provide scientific evidence that engineering educators, employers, and policy makers need to make informed decisions to design effective programs that broaden the participation of persons from historically underrepresented groups in the engineering workforce. BPE is interested in funding research that spans K-12 to workforce and offers the greatest return on investment. BPE funded research should produce outcomes that are scalable, sustainable, and applicable to various contexts, settings, and demographics within the engineering enterprise. BPE is particularly interested in research that employs intersectional approaches in recognition that gender, race and ethnicity do not exist in isolation from each other and from other categories of social identity. BPE is equally interested in research activities that align with and provide meaningful connections to the NSF INCLUDES National Network. The overarching goal of NSF INCLUDES is to achieve significant impact at scale in transforming STEM education and workforce development by educating a diverse, STEM-capable workforce that includes talented individuals from all sectors of the Nation's population. Collaborations are encouraged between BPE proposals and existing NSF INCLUDES projects, for example, the NSF INCLUDES Alliances and Coordination Hub, provided these collaborations strengthen both the BPE and

NSF INCLUDES projects. Before submitting a proposal to the BPE program, prospective Principal Investigators are strongly encouraged to speak to the program director to obtain guidance as to whether the proposed ideas are aligned with the strategic goals of the BPE program. Provide appropriate justification to support selection of the targeted group(s), with specific and applicable objectives, and demonstrate applicable knowledge of the relevant literature on underrepresentation. Integrate a mechanism to assess and evaluate how well the project has achieved the stated objectives as part of the project management plan. Provide evidence of clear, measurable outcomes and consideration of how the strategy will advance knowledge beyond localized contexts. Incorporate a dissemination plan that goes beyond publishing research papers and presenting at conferences. PIs should think creatively about who needs to hear about the research for it to have an impact, and develop a strategy to reach that audience. Describe how the outcomes have the potential to enhance diversity and inclusion of underrepresented populations in engineering. The Project Summary must contain a list of 3-5 keywords. Place the keywords on a separate line at the end of the Overview section of the Project Summary.

### **Promoting the Holistic Approach on Nutrition Policy – (CFDA 10.960)**

Program Overview, Objectives, and Priorities The USDA's Foreign Agricultural Service Office of Agreements and Scientific Affairs announces an open competition for multi-year cooperative agreement proposals to design, plan, and implement nutrition workshops and seminars for foreign regulatory officials on the margins of international meetings and in key trade countries or regions, pending the availability of funds. The workshops and seminars will inform foreign regulators and policy-makers on options to promote an evidence-based approach to nutrition policy as they tackle diet related non-communicable diseases (NCDs) such as obesity. The seminars should focus on science- and evidence-based approaches to improve healthy eating in their countries by broadening the bucket of options beyond the trade-restrictive regulations (see background section, below, for more information) that are being increasingly adopted around the world. Objectives: These seminars and workshops should feature speakers from research institutions that specialize in nutrition and behavior change,

U.S. government subject matter experts, and private sector representatives. Participants of these workshops and seminars will gain: (1) a better understanding on the role of voluntary versus regulatory approaches in promoting healthy eating and reducing diet related non-communicable diseases (NCDs); (2) learn from existing research, best practices and lessons learned from existing U.S. programs and policies; and (3) formulate 1-2 alternative strategies to their current approach. For any regulatory approaches, an emphasis on good regulatory practices will be included. · The academic research presentations should focus on evaluating the efficacy of policy that results in behavioral change of eating habits. The emphasis could be on the methodology required to analyze the efficacy and cost-benefit of a regulatory approach vs. voluntary approach. They could also discuss means to measure the efficacy of various consumer education approaches. Presenters should be selected based on their research to broaden the bucket of options from prescriptive measures to education and behavior change approaches. This session may also feature speakers discussing various examples of models for behavior change, or those who can discuss measuring results of various Nutrition Education for Behavior Change programs such as the Supplemental Nutrition Assistance Program Education (SNAP-Ed), the Expanded Food and Nutrition Education Program (EFNEP), and the WIC Works Resource System. · These U.S. government sessions would showcase USDA and Department of Health and Human Services programs and research in this space and discuss a comprehensive approach, a combination of regulatory and non-regulatory approaches to nutrition and food security in the United States. Moreover, these sessions will share the U.S. Government's experiences in producing the U.S. Dietary Guidelines, which reflect the current body of nutrition science and provide advice on what to eat and drink to promote health and reduce the risk of chronic diseases, recognizing that individuals will need to make changes in their food and beverage choices to achieve a healthy dietary pattern. The Dietary Guidelines serve as the foundation for U.S. Government nutrition programs and policies. USDA's Foreign Agricultural Service Office of Agreements and Scientific Affairs may also identify appropriate U.S. government speakers, which may include experts from USDA's Food and Nutrition Service, USDA's National Institute of Food and Agriculture, the Health and Human Services Office of Disease Prevention and Health Promotion, and the U.S. Food and Drug Administration. · The industry presentations could provide an opportunity for U.S. companies to speak about their role in engaging on regulatory efforts and their own initiatives to promote healthier diets, such as those focused on reducing portion size and limiting food advertising in schools and to young children. Dietitians from industry could be invited to share their research on how voluntary efforts are showing impacts on healthy eating. Industry representatives who work on providing comments and feedback to regulators could also discuss the value of engaging all stakeholders in developing regulations and provide insight on good regulatory practice. USDA's Foreign Agricultural Service Office of Agreements and Scientific Affairs can work with the applicant to make connections with leads for voluntary industry efforts, including dietitians.

Award Information The FY19 TBDRP Idea Award intends to support conceptually innovative, high-risk/potentially high-reward research in the early stages of development that could lead to critical discoveries or major advancements that will accelerate progress in improving outcomes for individuals affected by Lyme disease and/or other tick-borne illnesses. This award mechanism promotes new ideas that represent innovative approaches to Lyme disease and other tick-borne diseases research and have the potential to make an important contribution toward the TBDRP mission. Applications should include a well-formulated, testable hypothesis based on strong scientific rationale that is established through inferential reasoning and/or critical review and analysis of the literature. The following are key aspects of the FY19 TBDRP Idea Award:

- **Innovation:** Innovative research may introduce a new paradigm, challenge existing paradigms, look at existing problems from new perspectives, or exhibit other uniquely creative qualities that may include high-risk/potentially high-gain approaches to Lyme disease and other tick-borne diseases research. Research that is merely an incremental advance (the next logical step) is not considered innovative.
- **Relevance:** Applications should articulate how the proposed research is relevant to at least one of the FY19 TBDRP Focus Areas. Highly relevant research will address the current



evidence-based burden of disease on public health, while also considering the healthcare needs and welfare of military Service members and their families. • Preliminary Data: Due to this award's emphasis on innovation, inclusion of preliminary data, such as unpublished data from the laboratory of the Principal Investigator (PI) or collaborators named on the application, and/or data from published literature that are relevant to Lyme disease and other tick-borne diseases and support the proposed research project, is encouraged, but not required. To leverage existing resources and maximize statistical power, Lyme and other tick-borne disease biorepositories and databases are important resources to consider if retrospectively collected human anatomical substances or correlated data are critical to the proposed studies. Investigators are strongly encouraged to incorporate the following components into their study design where appropriate: authentication of proposed cell lines; statistical rigor of in vitro cellular studies and preclinical animal experiments; and validation in well-pedigreed cohorts of uniformly documented patients. Studies utilizing data derived from large patient studies that include long-term health records, biospecimen repositories, and pre-existing research, and/or studies that apply state-of-the-art genomic and/or proteomic analysis, bioinformatics, and/or mathematical models to such data are also encouraged. The proposed research must be relevant to active duty Service members, Veterans, military beneficiaries, and/or the American public. The anticipated direct costs budgeted for the entire period of performance for an FY19 TBDRP Idea Award will not exceed \$300,000. Refer to Section II.D.5, Funding Restrictions, for detailed funding information. The CDMRP expects to allot approximately \$0.48M to fund approximately one Idea Award application. Funding of applications received is contingent upon the availability of Federal funds for this program as well as the number of applications received, the quality and merit of the applications as evaluated by scientific and programmatic review, and the requirements of the Government. Funds to be obligated on any award resulting from this funding opportunity will be available for use for a limited time period based on the fiscal year of the funds. It is anticipated that awards made from this FY19 funding opportunity will be funded with FY19 funds, which will expire for use on September 30, 2025. The types of awards made under the Program Announcement will be assistance agreements (grants or cooperative agreements). Making this a priority for all State and local emergency agencies helps to support the safety of individuals with intellectual and developmental disabilities during a disaster or emergency as well as ensure that adequate supports are provided during each phase of the emergency process. To accomplish this, the Administration on Intellectual and Developmental Disabilities (AIDD) within the Administration on Disabilities, Administration for Community Living, U.S. Department of Health and Human Services (HHS), plans to fund one cooperative agreement to establish a national technical assistance and resource center. The aim of the center will be to provide direct assistance and guidance to States and Territories and build improve their capacity to better addressing the safety needs as well as access to adequate support of individuals with disabilities during an emergency or disaster during the response and recovery phase.. In addition, the center will aim to provide technical assistance, resources, and information at the State, Federal, and local level as a part of the response and recovery efforts.

Medical professionals are expected to serve in various roles and capacities in the project. Partners should demonstrate support of civil rights across the lifespan for people with disabilities. Conceptual Framework for the Design of the Project. The project should be guided by a conceptual framework that incorporates a civil rights framework, the core values in the Developmental Disabilities Assistance and Bill of Rights (DD Act) and other relevant evidence or theories related to discrimination and equal access to health care. The application should describe how the conceptual framework will be used to guide all aspects of the project. Evaluation to assess progress and determine outcomes from the project. It is expected that the project will use process evaluation techniques to analyze how the project activities are delivered to determine, among other things, the extent to which the project is being implemented as planned, how the project activities are being received by the target group, the barriers to implementation, and areas for project improvements/refinements. It is also expected that the project will use summative evaluation techniques to determine project success in meeting the intended outcome of enhancing the health and safety of individuals by increasing their independence, social capital, self-determination, community integration, productivity and participation. Applications are being accepted for partners to carry out activities as part of these pilot projects in States of Alabama, Arkansas, California, Florida, Georgia, Louisiana, Mississippi, North Carolina, Oklahoma, South Carolina, and Texas. APHIS has determined that these states have the highest feral swine population densities and corresponding associated damages. A total of up to \$33,750,000 is available for these activities in FYs 2019 - 2023. Non-federal, not-for-profit entities (NFE) are invited to submit applications. Projects may be between one and three years in duration. The maximum amount for a single award in FY 2020 is \$1,500,000 and applicants must match at least 25% of federal funding. APPLICATIONS DUE DATE: Applications must be received by 5 p.m. Eastern Time on August 19, 2019. The purpose of the FSCP is to respond to the threat feral swine pose to agriculture, native ecosystems, and human and animal health. Feral swine are a destructive, non-native, invasive species and their populations have been increasing across the United States. An estimated \$2 billion in damage, including agricultural, is caused by feral swine each year. The species can have significant negative impacts on plant and animal habitats, soils, water quality, as well as other natural and cultural resources. Livestock and humans are also susceptible to diseases carried by feral swine. The Agriculture Improvement Act of 2018 directs USDA to carry out the pilot program where the Secretary has determined that feral swine have been identified as such a threat. NRCS State Conservationists and APHIS State Directors, in coordination with State technical committees, have identified pilot projects which can be carried out within states with high feral swine densities. Pilot projects will consist broadly of three coordinated components: 1) feral swine removal by APHIS, 2) restoration efforts supported by NRCS, and 3) assistance to producers for feral swine control provided through grant agreements with non-federal partners. This opportunity for proposals is intended to address objective 3 described above for non-federal partners to provide landowner assistance for on-farm trapping and provide related services as part of the pilot projects described above. Funding for these services will be provided through grant agreements between partners and NRCS. The Disaster Recovery DWGs are authorized under Section 170 of the Workforce Innovation and Opportunity Act (WIOA). The purpose of these grants is to enable eligible applicants to create disaster-relief employment to alleviate the effects of the opioid crisis in affected communities, as well as to provide employment and training activities, including supportive services, to address economic and workforce impacts related to widespread opioid use, addiction, and overdose. While the opioid crisis affects communities in unique ways that necessitate customized approaches to best address its impacts, the Department expects that successful opioid Disaster Recovery DWG projects will accomplish the following: facilitate community partnerships that are central to dealing with this complex public health crisis; provide training that builds the skilled workforce in professions that could impact the causes and treatment of the opioid crisis, such as: addiction treatment, mental health, and pain management; ensure the timely delivery of the appropriate career, training, and supportive services to dislocated workers (including displaced homemakers), individuals temporarily or permanently laid off due to the opioid crisis, long-term unemployed individuals, and self-employed individuals unemployed or significantly underemployed as a result of the opioid public health emergency—including individuals in these populations who have been impacted by opioid use; and create temporary disaster-relief employment that addresses the unique impacts of the opioid crisis in affected communities.

### [Announcement of Stand Down Grants – \(CFDA 17.805\)](#)

DOL VETS supports local Stand Down (SD) events that assist homeless veterans by providing a wide variety of employment, social, and health services. A homeless veteran is a veteran, as defined in 38 U.S.C. 101(2), who is “homeless” as that term is defined at 42 U.S.C. 11302(a)-(b), as amended by the Homeless Emergency Assistance and Rapid Transition to Housing Act of 2009 (Public Law 111-22). Stand Down grant funds must be used to enhance employment and training opportunities or to promote the self-sufficiency of homeless veterans through paid work. Veterans experiencing homelessness do not always have access to basic hygiene supplies necessary to maintain their health and appearance. Lack of shelter limits their ability to prepare for and present themselves at job interviews or be contacted for follow-up. Basic services such as showers, haircuts, attention to health concerns, and other collaborative services provided at SD events can give participants a greater sense of self and an opportunity to improve their chances of securing and maintaining employment. Each year, VETS sets funds aside from the Homeless Veterans’ Reintegration Program (HVRP) budget activity to award SD grants. Stand Down funding is a non-competitive grant awarded on a first-come, first-served basis until available annual funding is exhausted. VETS will continue to accept applications and process when additional funds become available. The maximum amount that can be awarded, per applicant for a geographic area, in a fiscal year (October 1 – September 30) is \$7,000 for a one-day event and \$10,000 for a multi-day event. VETS recognizes the following as circumstances that may justify awarding SD grants in higher amounts: emergencies or major disasters, as defined in the Stafford Act, which have been declared eligible for public assistance by the Federal Emergency Management Agency (FEMA). In addition, emergencies or disaster situations of national significance, natural or man-made, that could result in a potentially large loss of employment, as declared or otherwise recognized in writing by the chief official of the Federal Agency with jurisdiction over the Federal response to the emergency or disaster. If the VETS Assistant Secretary determines it is appropriate to award increased grants for SD events due to a disaster, the VETS Assistant Secretary will announce such a determination in writing, including the maximum amount that can be awarded on account of such an identified disaster, in order to provide notice to

entities proposing to conduct SD events in those geographic areas where a disaster has been declared or to which a substantial number of veterans have relocated or been relocated. Acceptable uses of Stand Down grant funds do not change in such circumstances. All applications should be emailed to the appropriate DVET of the state in which the SD event is planned.

### **U.S. Department of Transportation**

#### **[Assistance for Local Emergency Response Training Grants – \(CFDA 20.703\)](#)**

The Pipeline and Hazardous Materials Safety Administration (PHMSA), through this competitive grant opportunity, is requesting applications from national nonprofit fire service organizations for Assistance for Local Emergency Response Training (ALERT) grant funds. The foundation of the ALERT Grants focuses on incident response activities related to the transportation of crude oil, ethanol, and other flammable liquids by rail. ALERT grant funding will be awarded to nonprofit organizations to train individuals with statutory responsibility to respond to accidents and incidents involving hazardous materials.

**Deadline:** July 12, 2019

#### **[FY 2019 National Infrastructure Investments – \(CFDA 20.933\)](#)**

The FY 2019 Appropriations Act provided \$900 million for National Infrastructure Investments. As with previous rounds, funds for the FY 2019 BUILD Transportation program are to be awarded on a competitive basis for projects that will have a significant local or regional impact. The Act also allows DOT to use a small portion of the \$900 million for oversight and administration of grants. If this solicitation does not result in the award and obligation of all available funds, DOT may publish additional solicitations. The Consolidated Appropriations Act, 2019 specifies that BUILD Transportation Discretionary Grants may not be less than \$5 million and not greater than \$25 million, except that for projects located in rural areas the minimum BUILD Transportation Discretionary Grant size is \$1 million. The FY 2019 Appropriations Act specifies that not more than 50 percent of funds can be spent on projects located in a rural area with a population equal to or less than 200,000 and not more than 50 percent of funds can be spent on projects located in an urbanized area with a population of more than 200,000. The Department revised the definition for rural and urban projects from previous BUILD/TIGER rounds to two categories, consistent with the urban and rural funding maximums. Pursuant to the FY Consolidated Appropriations Act, 2019, no more than 10 percent of the funds made available for TIGER BUILD Transportation Discretionary Grants (or \$90 million) may be awarded to projects in a single State. Further, pursuant to the Consolidated Appropriations Act, 2019, DOT must take measures to ensure an equitable geographic distribution of grant funds, an appropriate balance in addressing the needs of urban and rural areas, and investment in a variety of transportation modes. The Consolidated Appropriations Act, 2019 requires that FY 2019 BUILD funds are only available for obligation through September 30, 2021. No FY 2019 BUILD funds may be expended after September 30, 2026. As part of the review and selection process described in the Notice of Funding Opportunity, DOT will consider whether a project is ready to proceed with an obligation of grant funds from DOT within the statutory time provided. Under the FY 2019 Appropriations Act, no waiver is possible for these deadlines. The



FY 2019 Appropriations Act allows for up to 20 percent of available funds (or \$180 million) to be used by the Department to pay the subsidy and administrative costs for a project receiving credit assistance under the Transportation Infrastructure Finance and Innovation Act of 1998 (“TIFIA”) program, if it would further the purposes of the BUILD Transportation Discretionary Grant program. Recipients of prior TIGER Discretionary Grants may apply for funding to support additional phases of a project awarded funds in earlier rounds of this program. However, to be competitive, the applicant should demonstrate the extent to which the previously funded project phase has been able to meet estimated project schedules and budget, as well as the ability to realize the benefits expected for the project. DOT expects that each BUILD Transportation Discretionary Grant will be administered by one of the relevant modal administrations, pursuant to a grant agreement between the BUILD Transportation Discretionary Grant recipient and the relevant modal administration.

**[Integrated Mobility Innovation Demonstration Program – \(CFDA 20.530\)](#)**

The Federal Transit Administration (FTA) announces the availability of \$15 million of Fiscal Year 2017 and Fiscal Year 2018 research funds for eligible projects. ### **BoatUS Foundation Accepting Grant Applications for Safe and Clean Boating Projects**

The BoatUS Foundation for Boating Safety and Clean Water is accepting applications for its Grassroots Grants Program, which awards funds on an annual basis to nonprofit organizations, boating clubs, and student groups in the United States for projects that utilize innovative approaches to education about safe and clean boating.

While the main objective is to promote sustainability in schools, special emphasis of the proposed project should be on specific measurable initiatives to promote renewable energy and sustainability, which may include improvements in energy or water efficiency, or a reduction in waste.

### [Waste Management Charitable Giving](#)

Healthy thriving communities depend on involved citizens, organizations and corporate partners for momentum. We lend our support and services to causes that promote civic pride, economic development and revitalization. Every community has its own challenges, and we strive always to be part of problem-solving initiatives. Programs that Waste Management is most motivated to support include: environment, environmental education, and causes

important to the areas where we operate. Applications are accepted year round and are reviewed on a continuous basis. Given the large amount of requests received, please anticipate an estimated two-month review period for each request.

### Clif Bar Foundation Small Grants

These grants are awarded for general organizational support as well as funding for specific projects. Small grants average approximately \$7,000 each. Priority is given to applicants that: Address our funding priorities from a holistic perspective; Protect Earth's beauty and bounty; Create a robust, healthy food system; Increase opportunities for outdoor activity; Reduce environmental health hazards; Build stronger communities; Operate with clearly defined objectives and viable plans to achieve them; Demonstrate strong community ties and operate at the community level; Promote positive change through both the projects and their implementation process.

**Deadline:** Applications are reviewed three times a year; the deadlines are the 1st of February, June, and October. Grants awarded during a particular cycle will be announced at the beginning of the following cycle.

### Foundation for Contemporary Art Accepting Applications for Emergency Grants

Since its inception in 1963, the mission of the Foundation for Contemporary Arts has been to encourage, sponsor, and promote innovative work in the arts created and presented by individuals, groups, and organizations.

Created in 1993, the foundation's Emergency Grants program provides grants of up to \$2,000 to innovative visual and performing artists who have unanticipated, sudden opportunities to present their work to the public when there is insufficient time to seek other sources of funding; or who incur unexpected or unbudgeted expenses for projects close to completion with committed exhibition or performance dates.

To be eligible, applicants must be living, working, and paying taxes in the United States; have committed to a performance or exhibition opportunity and be able to provide specific dates at the time of application; and be an individual artist or an individual representing an artist collective, ensemble, or group. Curators, producers, workshop organizers, organizations, or arts presenters are not eligible to apply.

**Deadline:** OPEN

### Weyerhaeuser Giving Fund

We support U.S. and Canadian communities where we have a significant presence or business interest. These communities range from rural to metropolitan, each with unique priorities and needs. Our employees serve on local advisory committees for our Giving Fund and develop funding priorities within four focus areas to support their particular communities. This provides a strong companywide framework for giving while allowing flexibility to meet unique needs in our different communities.

Through the Weyerhaeuser Giving Fund we concentrate the majority of our funding in four focus areas:

- Affordable Housing and Shelter

- Be a tax-exempt, nonprofit public charity classified under Section 501(c)(3) of the U.S. Internal Revenue Code OR a registered charity in Canada with a Canada Revenue Agency Number, or registered as a provincial nonprofit society OR a public education institution or government entity qualified under Section 170(c)(1) of the U.S. Internal Revenue Code or qualified as a Canadian municipality.

### Wells Fargo Corporate Giving Programs

Wells Fargo supports nonprofit organizations that work on a community level in the areas of human services, arts and culture, community development, civic responsibility, education, environmental consciousness, and volunteerism.

**Deadline:** Applications accepted on an ongoing basis.

### Good Sports Accepting Applications for Sports Equipment Grant

Good Sports helps lay the foundation for healthy, active lifestyles by providing athletic equipment, footwear, and apparel to disadvantaged young people nationwide. By working closely with teams, coaches, and community leaders across the United States, the organization is able to focus on the respective needs of each individual program and help offset the main factors causing the greatest challenges.

Good Sports is accepting applications from organizations and schools for equipment, apparel, and footwear for a wide range of sports. Organizations that are approved will have access to equipment, apparel, and footwear inventory for a two-year period. During that time, organizations can make up to six separate donation requests — as long as need is well documented, donations will be granted. There is no need to resubmit a full application again during the two-year period.

To be eligible, applicants must directly serve youth between the ages of 3 and 18; serve youth in an economically disadvantaged area; be located in North America (the U.S. and Canada); and operate an organized sport, recreational activity, or fitness program that offers consistent and structured opportunity for play to large groups of children. Schools must apply as a whole; applications for individual programs within a school will not be considered. Donation requests for short-term events such as sports camps and tournaments or to individual athletes will not be considered.

While the equipment, apparel, and footwear received through the program are free, recipients are expected to pay shipping and handling costs, which amount to roughly 10 percent of the donation value, with a maximum fee of \$1,500.

**Deadline:** Applications are reviewed on a rolling basis. It is recommended, however, that organizations apply at least eight weeks prior to the start of their particular season or program to ensure the desired equipment can be accessed and shipped on time.

### [Karma for Cara Foundation Invites Applications for Youth Microgrants](#)

The Karma for Cara Foundation is a nonprofit founded by 21-year-old Cara Becker and her family while she was undergoing treatment for leukemia at the Johns Hopkins Kimmel Cancer Center. Cara and her two brothers began volunteering at a young age as part of their family's commitment to community service. She and her family saw a tremendous need to help support other patients and their families who were also challenged by cancer. Tragically, Cara passed four months after her diagnosis, yet her wish to help others through K4C lives on with the support of an ever-growing circle of family and friends.

As part of an effort to promote and support youth voluntarism, k4C started a microgrant program in fall 2014 to encourage kids 18 and under to apply for a grant of between \$250 and \$1,000 to complete service projects in their communities. Examples of fundable projects include but are not limited to turning a vacant lot into a community garden, rebuilding a school playground, and helping senior citizens get their homes ready for winter. Grants will be distributed as gift cards to home goods stores, office supply stores, grocery food chains, and toy stores.

### [VFW Accepting Applications From Veterans for Emergency Financial Assistance](#)

Veterans of Foreign Wars is accepting applications from active and discharged military service members who have been deployed in the last six years and have run into unexpected financial difficulties as a result of deployment or other military-related activity. Since the program's inception, Unmet Needs has distributed more than \$5 million in assistance to qualified military families, with nearly half of those funds going directly toward basic housing needs.

The hardship must be the result of deployment, a military pay issue, or military-related illness or injury. It cannot be due to civil legal or domestic issues, misconduct, or any issues that are a result of spousal separation or divorce, financial mismanagement, or bankruptcy.

### [Start a Snowball Invites Applications for Youth Philanthropy Projects](#)

Start a Snowball, Inc. encourages kids of all ages to engage in philanthropic and community service activities. The organization believes that even one child with the right intentions and support can start a project that seems small in the beginning and eventually grows ("snowballs") into something that inspires and benefits an entire community.

In order to help kids kick off their philanthropy efforts, Start a Snowball awards \$100 in seed funding for projects taken on by individuals or organizations.

To be eligible, projects must be led by youth between the ages of 5 and 18 and have the intention of doing good.

Start a Snowball does not give directly to collection funds. The organization also does not provide support for fundraisers for sports teams, unless they serve an underserved or disadvantaged group, or support projects that are discriminatory or political in nature.

### [Craft Emergency Relief Fund Accepting Applications From Craftspeople in Need](#)

The Craft Emergency Relief Fund is a national nonprofit organization that awards small grants and loans to professional craftspeople experiencing career-threatening illness, accident, fire, theft, or natural disaster.

Financial assistance ranges from \$500 to \$8,000. Other services include referrals to craft suppliers who have agreed to offer discounts on materials and equipment to craftspeople eligible for CERF funds and booth fee waivers from specific craft show producers.

CERF loan recipients are expected to repay the loan in full within five years, enabling CERF to have funds readily available for future craftspeople in need.

Applicants must be a professional artist working in a craft discipline (e.g., a potter, metalsmith, glass artist, woodworker, fiber artist, or furniture maker) who has had a recent career-threatening emergency and a legal resident of the U.S.

### [Pollock-Krasner Foundation Accepting Applications From Artists With Financial Need](#)

The mission of the Pollock-Krasner Foundation is to aid those individuals who have worked as artists over a significant period of time. The foundation's dual criteria for grants are recognizable artistic merit and financial need, whether professional, personal, or both.

Grants are intended for a one-year period of time, with the size of the grant to be determined by the artist's individual circumstances and professional exhibition history. Artists applying for a grant must be actively exhibiting their current work in a professional artistic venue such as a gallery or museum space.

The foundation does not accept applications from commercial artists, video artists, performance artists, filmmakers, crafts-makers, computer artists, or any artist whose work primarily falls into these categories.

### [Pollination Project Invites Applications From Social Entrepreneurs for Seed Grants](#)

The Pollination Project is accepting applications from social entrepreneurs looking to make their communities and world a better place. Seed grants of up to \$1,000 will be awarded to projects in the early stages of development, including those that promote compassion toward all life (people, planet, animals), environmental sustainability, justice in all its forms, community health and wellness, and social change-oriented arts and culture. Only applications for seed funding, as opposed to ongoing operational or program costs of a nonprofit organization, will be accepted. To be eligible, applicants must be a passionate, committed individual with a social change vision that fits within one or more of the categories above. Established nonprofit organizations with paid staff will not be considered.

### [Hope for The Warriors Accepting Applications for Critical Care Support for Wounded Veterans](#)

Hope For The Warriors believes those touched by military service can succeed at home by restoring their sense of self, family, and hope. Nationally, the organization provides service members, veterans, and military families with comprehensive support programs focused on transition, health and wellness, peer engagement, and community resources.

Originally designed to meet short-term needs in the days following an injury, the Hope for The Warriors' Critical Care Coordination program has expanded to assist post-9/11 combat-wounded veterans and their families as they navigate through long-term recovery.

Program case coordinators work daily with post-9/11 combat-wounded service members and veterans, their families, and families of the fallen to meet immediate financial needs related to daily living including utilities, groceries, rent, mortgage, and rental deposits. The program provides casework assistance and resource referrals that will help clients immediately and in the future. Payment is always made to a third party.

To be eligible, applicants must be seeking support for needs that are a direct result of a service member's post-9/11 combat-related injury.

#### [Singing for Change Accepting LOIs for Projects to Address Social and Environmental Problems](#)

Created by Jimmy Buffett in 1995, Singing for Change initially was funded with contributions from the singer's summer concert tour. Since then, SFC has offered competitive grants to progressive nonprofit organizations working to address the root causes of social or environmental problems.

Priority will be given to organizations that keep their overhead low, include community members in planning, and collaborate with other groups to find innovative ways of solving common problems. SFC aims to advance the common good by empowering people to thrive and strengthen and sustain vibrant, diverse communities.

Grants will range in size from \$1,000 to \$10,000. Grants are made only to nonprofit organizations with tax-exempt status under section 501(c)(3) of the Internal Revenue Code, or to organizations that have a sponsoring agency with exempt status.

#### [A Little Hope Announces Youth Bereavement Support Services Grants](#)

A Little HOPE supports organizations that provide bereavement support services and grief counseling to children and teens who have experienced the death of a parent, sibling, or loved one.

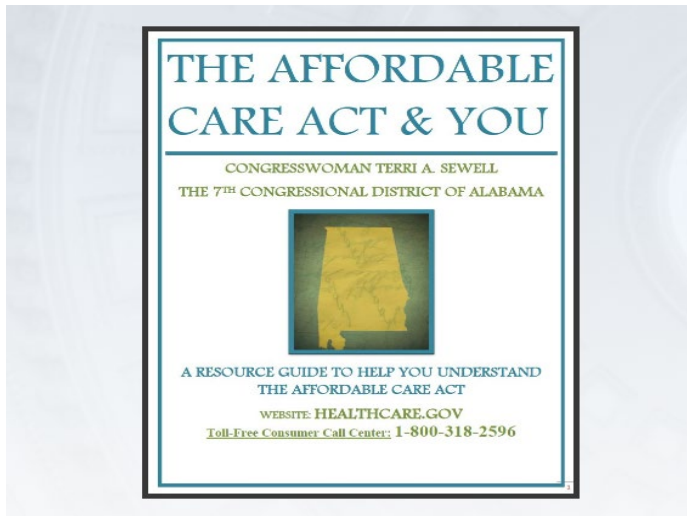

## **Alabama Additional Funding Sources**

### **Community Foundations in Alabama**

There are 13 community foundations in Alabama, covering 78 percent of the counties in the state and holding assets that total more than \$190 million.

#### **Daniel Foundation**

The Daniel Foundation offers grants in four program areas: Civic and Community Improvement, Education, Health, and Arts and Culture. Applications are limited to 501 (c)(3) organization that are located in Alabama.

#### **Alabama Power Foundation**

The Alabama Power Foundation allocates funding in four categories: Improving Education, Strengthening Communities, Promoting Arts and Culture, and Restoring and Enhancing the Environment.

#### **Alabama Humanities Foundation**

The AHF awards grants solely to support public humanities projects. Active public participation, involvement of humanities scholars, and strong humanities content are the three essential components of AHF-funded projects.

#### **Gwyn Turner Endowed Fund**

The fund is administered by the National Trust for Historic Preservation, in partnership with Alabama Trust for Historic Preservation. Nonprofits and governmental agencies can obtain funding for preservation planning, heritage education, workshops, conferences and special interventions. Grants range from \$1,000 to \$5,000 and require a 1:1 cash match.

#### **Sybil H. Smith Trust**

### **FACT SHEET: Veterans Employment Center**

The online Veterans Employment Center is the single federal source for Veterans looking for new career opportunities in the private and public sectors, as well as Service Members transitioning to the civilian workforce, military and Veteran spouses and dependents looking for employment opportunities, GI Bill beneficiaries transitioning from training to the job market and employers looking to connect with high quality applicants. It is the first interagency tool that brings together public and private job opportunities with resume building and other career tools currently offered on a variety of websites together in one place.

Through the online Veterans Employment Center, Veterans, transitioning Service Members and spouses are connected to high quality career choices by matching their identified skills with available public and private job opportunities. The site is built using an open application programming interface (API) to attract private sector innovation.

### **Veteran Applicant Resources:**

- Quick public resume posting with an instant connection to thousands of public and private employers
- Target job search based on specific, high-demand career paths
- Single search for both public and private sector positions
- Military skills translator and resume generator
- Social media integration with popular bookmarking sites for saving job postings

### **Employer Resources:**

- Access targeted feed of qualified resumes from Veteran applicants
- View reverse skills translation (military to civilian skills) for applicants
- Set Veterans hiring goals and track progress
- Connect to resources designed to help recruit and retain talented, Veteran employees

In connection with the First Lady and Dr. Biden's Joining Forces initiative, the Department of Veterans Affairs worked with the Departments of Defense, Labor, and Education, and the Office of Personnel Management to design and develop the site and incorporate features of existing online employment tools at each agency. The result is an upgrade to the existing Veterans Job Bank and an integrated solution connecting Veterans, transitioning Service Members and employers.

Employers, Veterans and transitioning Service Members deserve a single, authoritative source for connecting to each other. Now that the core tools and an integrated search function exist in one single location, each agency is engaged in minimizing duplication and redundancy of current sites and services.
